### Waiting on the Election and the November SCPP Meeting

At the time of this writing, shortly before the 2024 General Election, we are in a tense bubble eager to see what will happen on November 5th since so much depends on the outcome of that election at the state level.

Obtaining a permanent Cost of Living Adjustment (COLA) for Plan 1 retirees remains the WSSRA's top legislative priority. Plan 1 members are our oldest retirees and have endured 14 years of watching their purchasing power eroded by inflation. Since 2010 the national cost of living has increased more than 40 percent. As a result, many have lost close to half of their purchasing power to inflation. To offset these losses we have won only four partial one-time COLAs of between 1.5 and 3%. That is just not enough. In addition to their growing economic insecurity, these aging retirees are entering the time in life of rapidly growing medical expenses. In fact, quite a few have died waiting for the COLA that never came. Only a permanent annual COLA will halt their gradual slide toward poverty. That COLA would not restore purchasing power already lost, but it would prevent additional future erosion. It is essential to solve this issue before we move on to other priorities.

The bill that created the 2023 one-time ad hoc COLA also directed the Select Committee on Pension Policy (SCPP) to study establishing a permanent Plan 1 COLA and to present its findings to the 2025 Legislature. As a result, for the first time in history, the SCPP members voted at their September 2024 meeting to direct staff to prepare a bill creating a permanent Plan 1 COLA. We had hoped that at their October meeting they would vote to endorse and send it on for consideration by the 2025 Legislature, but they chose to wait due to a couple technical issues. Their last real chance to vote it forward will be at their November 15 meeting.

Meanwhile, financial experts anticipate a 5 to 7 billion dollar shortfall in state funding during the coming 2025-27 biennium. Demands from around the state for what money they will have are growing rapidly. So, just as our COLA chances look brighter in one way, something else comes along to threaten them.

Even worse than that are two initiatives on the November 5 General Election ballot. Either of them would kill our chance to obtain a permanent COLA if passed because that would strip away so much money from state coffers. These are Initiative 2109, to repeal the Capital Gains Tax on profits from stock investments above \$250,000 (made law in 2021), and Initiative 2117, to repeal the Washington Climate Commitment Act known as the CCA, also a law since 2021. The CCA will gradually shrink Washington's greenhouse gas emissions by 95 percent by 2050 through annually shrinking caps on carbon emissions allowed from our largest polluters and annual auctions that require them to purchase increasingly expensive credits to keep polluting. That money goes into the state coffers.

Both the Capital Gains Tax and the Climate Commitment Act bring huge amounts of money into the state budget to support important educational and environmental programs. The passage of either initiative would kill a major source of state funding, making a potentially bad situation for us much, much worse since the Legislature will need to fund those programs somehow. We might not even see an ad hoc Plan 1 COLA and we might even have to fight to save our PEBB medical benefit.

Hopefully I have shown you why this is a tense time. So much is riding on the outcome of the November 5 election and on the actions of the SCPP on November 15.

The WSSRA Legislative Committee will meet via Zoom on November 8. I hope to have more information for you and a plan of action after that meeting. Until then, cross your fingers and hope for the best.


### **Christmas House**

Christmas House is a 100% volunteer, non-profit organization in Everett, Washington that provides an opportunity for qualifying, low-income, Snohomish County parents to select free holiday gifts for their children age infant-18.

Christmas House was founded in 1981 by Roy Fraser in his garage. Roy had heard of children in Snohomish County who had not received anything for the prior Christmas and was determined to change that. He established the first annual Christmas House and stocked it primarily with used toys and handmade items, which they refurbished and gave away to families in need. They served more than 100 children the first year. Unfortunately, Roy did not live to see the second Christmas House, but his memory lives on as the 43rd year of giving continues.

The general format of how Christmas House functions has not changed over the years, just the number of families and individual children who benefit from his dream over four decades ago.
