# LEGISLATIVE REPORT

#### Social Media Ad Proposal to Be Considered by WEA Board November 5th

The WSSRA Executive Board will consider a proposal at their November 5, 2019 meeting to purchase online social media advertisements to explain to the public the serious financial issues facing Washington State School Retirees with a particular focus on Plan 1 members. The proposal was first discussed at the Legislative break-out session during the WSSRA Convention in June. It was discussed again at a September 5<sup>th</sup> joint meeting of the WSSRA Legislative Committee and WSSR-PAC Board in Cle Elum, Washington. We finalized and agreed to submit the proposal for consideration during an October 3<sup>rd</sup> Legislative Committee/PAC Board state-wide conference call. The proposal was considered by Coordinating Councils around the state at their October Coordinating meetings. NW-1 Coordinating Council voted to support the plan and submit it to the WSSRA Board.

The plan involves purchasing social media ads to appear on all Facebook pages within the geographic area around the Washington State Capitol Campus. That would include the Facebook pages of all legislators' offices. Whenever anyone opened the legislators' pages, they would see our ads describing the dilemma faced by Plan 1 retirees who lack an ongoing Cost of Living Adjustment (COLA). If necessary, for greater emphasis, we could easily target individual legislators' home districts. In that case, all Facebook pages within his or her district would show our ads. The beauty of this project is that this can all be done at a reasonable price, with a very extensive program costing less than \$10,000.

Something quite similar is already being done by the Retired Educators of Minnesota, and they report great success with it.

This new approach comes out of our long-standing frustration at failing to achieve a permanent COLA solution for Plan 1 members in the years since 2011. Of the more than a dozen retirement programs sponsored by the state, only two lack an ongoing COLA. These are PERS 1 and TRS 1, the oldest of the three educator-specific plans and the two plans that contain not only our oldest members but also the largest concentration of female members. Since our past efforts using more traditional methods have not shown success, we hope to add this newest tool to our toolbox.

#### WSSRA Delegation Attends NRTA Conference and Lobbies Federal Legislators

Between October 20th and 24<sup>th</sup> WSSRA Legislative Committee Member Tim Knopf and WSSRA Legislative Director Peter Diedrick attended the National Retired Teachers' Association (NRTA) National Advocacy Conference in the Washington, D.C.

The NRTA is the national parent organization of the Washington State School Retirees' Association and a division of the even more powerful AARP. Ethel Percy Andrus founded the NRTA in 1947 because she realized that retired educators were living on very small pensions, often without any health insurance, and needed serious help. Eleven years later, in 1958, she also founded the American Association of Retired Persons (now AARP). Ms. Andrus (1884-1967) was a long-time California educator and the first woman high school principal in the state of California. She was inducted into the National Women's Hall of Fame in 1993, and at the University of Southern California, Leonard Davis School of Gerontology, the Ethel Percy Andrus Gerontology Center is named after her.

The conference opened with registration and a reception Monday evening, and Tuesday brought a full day of presentations by national experts, but on Wednesday we were able to get onto the capitol campus to lobby for the retention of defined benefit retirement plans (pensions not 401K's) and for bills such as Senate Bill 2543 and House Bill 3 that would lower retirees' medical costs by capping Medicare Part D out-of-pocket expenses and allow Medicare to finally negotiate lower prescription drug prices.

During our day "on the hill" we met with Alex Payne, the Legislative Director of Representative Kim Schrier (D), from Washington's 8<sup>th</sup> Congressional District and Anna Conroe, Legislative Correspondent for U.S. Senator Maria Cantwell.

We wrapped up our visits with a face-to-face meeting with Washington's 2<sup>nd</sup> Congressional District Representative, Rick Larsen, and his Legislative Assistant, Samuel Wilcoxson. At each office our appeals were received well, and we were told that they hoped that something similar to what we were asking would make it into some of kind of package by the end of the current session.

That Wednesday we walked over seven miles in dress shoes and passed through seven security check points, removing our belts and pocket items each time before passing through metal detectors. Thankfully, our travel, hotel and meal expenses were covered by the AARP!

# **HEALTH NEWS**

#### Food Can Boost Your Mood

Researchers have demonstrated that a healthy diet can help cut the risks of illness from diabetes to cancer. Current research shows what you eat does impact your mood. A study of 46,000 people over eleven years published in the "European Journal of Nutrition" notes that individuals are less likely to have symptoms of depression reoccur and were much less likely to get depression in the first place.

There is an observable brain-gut connection. Micro biomes are a mix of good and bad bacteria in your GI tract. We know that good bacteria in your gut produces a great deal of neurotransmitters implicated in mood (like GABA). The mood related to the hormone serotonin is thought of as a brain chemical, but more than 90% of it is produced in the GI tract.

Ultra-Processed Issues Studies have shown that diets high in "ultra-processed" foods like soda pop, instant soups and chicken nuggets in a study of 15,000 people who ate them the most, had a 33% higher rate of depression than those who ate a lesser amount. These foods tend to be lower in essential nutrients like omega3 fatty acids and B vitamins. "Highly processed foods" contain little fiber and it's fiber that keeps your microbiomes and mood in better balance. Also, highly processed foods are loaded with sugar and additives that feed the "bad bacteria" in your gut. Those people eating the most sugary soda drinks have a 25-35% better chance of being depressed on average.

Christmas House was founded in 1981 by Roy Fraser in his garage. Roy had heard of children in Snohomish County who had not received anything for the prior Christmas and was determined to change that. He established the first annual Christmas House and stocked it primarily with used toys and handmade items, which they refurbished and gave away to families in need. They served more than 100 children the first year. Unfortunately, Roy did not live to see the second Christmas House, but his memory lives on as the 39th year of giving continues.

The general format of how Christmas House functions has not changed over the years, just the number of families and individual children who benefit from his dream over three decades ago.
