- Discussion: received some suggestions; HOA would authorize all towing \$120 (85 + 35 + storage)

- DECISION: tabled to allow for further updates; HOA's to respond & vote at next mtg

# 8) PSA Community TV Update-George Hopstetter

- Circulated ad for cable technician. QC Communication may be interested.
- Tower area was cleared, logs were hauled in, then cut up & removed.
- Lighting damage is being repaired on the pointe community television system lightning storms back in November storms; continue to work on these problems to restore service. Most of the trunk lines will be restored over the next week.
- Residents continue to request connection to the PSA Community Television Service is averaging request for resident service of 2-5 per week
- Failed Amplifiers sent back for repair are due to return of a backup power supply for the cable system. Due to arrive next Tuesday 1/25
- Will finalizing equipment list for new antennas order and install on the PSA Television system headend tower soon, weather permitting, and may be April before installation commences.
- QC Communication will be donating Comcast head equipment that has been updated that will match

what the PSA Community Television system can use, .550 trunk cable, .625 trunk cable, connectors, headend amplifiers and modulators. This will allow us to update and improve our headend gear and remove the old and non-functioning equipment.

• Contacted BigTen, & they are working on an option for us.

# 9) Sign Repairs & replacements-George Hopstetter

- Signs will be installed by Mar/Apr for spring season.
- Working to install new LED flood lighting with photo cell on the new village pointer sign over the next few weeks...
- New signs requesting new quotes for (6)- Cart crossing area on through ways and (6)- carts yield to traffic at same areas on cart paths. Also new signs for gate areas, "No Soliciting" and "Gate Arm Closes after each Vehicle". Need by annual mtg.
- Guest entrance pointer signs to be re-done to be more visible at the gate # 1 and #5. Estimate end of Feb.
