Treasurer report- Brian Earley

- PSA budgeted planned expenditures to be \$85,000 more than income for 2018.
- All past due accounts have been sent to collections which would be accelerated for all of 2018 per our policy.
- Accounting is now on a monthly budget to work from for 2018.

PSA Cable System.

Glenn Adams made a motion to remove community TV from next year's budget. This motion was seconded by Mike Baugh.

All in favor. None Opposed. Passed by unanimous vote of the PSA BOD.

Discussion to combine efforts with HOA and PSA to collect from nonpaying owners.

Motion to limit serving terms to be removed from the members of the LLC Board.

Patrick Owen made a motion to limit serving terms. This motion was seconded by Mike Baugh. All in favor. None opposed. Passed by unanimous vote of the PSA BOD.

Review of the LLC operations agreement-

- Annual LLC Board meeting is held after the annual PSA meeting.
- LLC Board will schedule monthly meetings, this will be modified on the LLC Operating Agreement.
- LLC Board will introduce their candidates and PSA will make the formal recommendation based on finding the most qualified candidate, unless there is a conflict of interest. Services of a head hunting consultant may be utilized.
- President to be referred to as Vice Chairman only on the Operating Agreement.
