The Virginians Plan will be a total alternation of the present federal system and substituting a great National Council with full legislative Powers upon all the Objects of the Union. States' votes will prove the constitution. Congress had gathered as a meeting to draft the Articles—amendments.

In 1790, Gilbert du Motie, known as the Marquis de Lafayette, sent the key to George Washington on behalf of the people of France. 




