Thank you for contacting me regarding the nomination of Judge Ketanji Brown Jackson for Associate Justice of the Supreme Court. I appreciate hearing from you.

On February 25, 2022, President Biden nominated Judge Ketanji Brown Jackson, who currently serves on the United States Court of Appeals for the District of Columbia Circuit, to fill Justice Stephen Breyer's seat at the end of the court's current term. As you may know, Justice Breyer will retire after serving more than 27 years on the Supreme Court. He has authored thoughtful, measured opinions in support of a woman's right to choose, civil and voting rights, the Affordable Care Act, and the First Amendment. Justice Breyer leaves a powerful legacy as a defender of good government that works for the people it represents.

I strongly believe the Supreme Court needs a justice who understands how their decisions will impact the Nevadans I fight for every day. There is no position more important within our legal system than a seat on the Supreme Court, and the next justice will make decisions that will affect Americans for generations to come. While I voted to confirm Judge Jackson to the U.S. Court of Appeals, a nomination to the Supreme Court requires careful attention. I plan to meet with her in the coming weeks and again review her record thoroughly.
