Dear Mr. Shannon,

Hello, I'm Dina Titus, your Congresswoman from the First District. Throughout my six terms in Congress, I have prioritized developing and improving our country's infrastructure and advancing Nevada's economy.

As the Chair of the House Transportation & Infrastructure Economic Development Subcommittee, I was honored to contribute to and pass H.R. 3684, the bipartisan Infrastructure Investment and Jobs Act. This legislation, which was signed into law by President Biden on November 15, 2021, makes the largest investment in almost a century in our infrastructure. It creates good-paying union jobs and provides resources for clean water, lead pipe replacement, broadband internet, and electric vehicle infrastructure. This historic bill will help ease inflationary pressures and strengthen supply chains by making long overdue improvements in our nation's ports, airports, rail, roads, bridges, and transit systems.

Specifically, the Infrastructure Investment and Jobs Act allocates \$2.5 billion for federal-aid highway programs and \$225 million for bridge replacement and repairs in Nevada. The law also provides \$459 million over five years to improve public transportation options, and \$38 million to support the expansion of EV charging across the state. The Infrastructure Investment and Jobs Act will also provide hundreds of millions of dollars for Nevada in funding to support broadband coverage, wildlife protection, cybersecurity, water infrastructure, and wildfire suppression.

I am proud to have left my mark on this legislation which will repair our dilapidated infrastructure and provide opportunities for Nevadans. Be assured I will continue delivering concrete results for Las Vegans throughout my tenure.
