I'm Dina Titus, your Congresswoman from the First District, and I am writing to tell you about my exciting efforts to address the climate crisis and conserve the environment.

I am a proud cosponsor of H.R. 4220, the National Climate Service Corps and Careers Network Act of 2021, to establish a National Climate Service Corps to help communities withstand and respond to natural disasters. I believe a modern version of the CCC can be a major tool in the revitalization of rural communities, restoration of our environment, and most importantly, addressing the impacts of global climate change.

I am also a cosponsor of H.R. 4442, the Green New Deal for Public Schools Act of 2021. This legislation would administer grants to public schools to construct new or convert existing facilities into healthy, zero-carbon schools. The legislation would also establish a Climate Change Resiliency Program and the Office of Sustainable Schools within the Department of Education to coordinate grant efforts and increase the resiliency of public schools during natural disasters and health crises. The Green New Deal for Public Schools Act would be a necessary step in creating a safe environment for our children to learn in, while also fighting climate change.

These are the kinds of policies and investments we must make to address the climate crisis and safeguard our planet for future generations. Be assured that I will keep fighting for innovative initiatives like the Civilian Climate Corps and the Green New Deal for Public Schools.
