Cyber Safety Pledge

- 3. I will not open emails or messages from people I do not know
- 4. I will not talk to strangers online or meet face-to-face with anyone from the Internet.
- 5. I will always be polite and respectful of others online and will not be rude or mean online.
- 6. I will tell my parent, guardian or teacher if anything online makes me feel uncomfortable, scared, sad or confused.
- 7. I will only post pictures or videos with my parent's approval.
- 8. I will create a unique user ID to play online with my friends so that I do not reveal anything personal about myself.
