WHEREAS, a special meeting of the membership of the NORTHSHORE UNIT &A Property Owners' Association was held October 17, 1999, and, pursuant to Article XI, restrictions were amended by a majority vote of the Association.

IT IS, THEREFORE, the act of the majority vote of the Association that the Declaration described above is amended as follows, to-wit:
