# A MESSAGE FROM OUR PRESIDENT

## Dear Friends,

2017 was a record year for this organization, and one which, thanks to our generous donors and friends, further cemented our status as our region's most important animal organization.

Our shelter found homes for 602 animals, besting the previous year's record of 552. We continued our animal welfare work in the community, locally addressing some of the root causes of pet homelessness and overpopulation. Our feral cat initiatives humanely kept the local stray cat population in check—while improving lives for these vulnerable creatures. Finally, our humane education programs shared our caring mission and values with the next generation.

2017 was special in another way: in June, we celebrated our 25th anniversary, marking a quarter century of compassionate care for Massachusetts animals and the people who love them. By undertaking a Strategic Planning Process, we also started to set the groundwork for our next 25 years of helping Massachusetts animals.

We are so grateful for the generosity of this community. You have been with us for 25 years, and we pledge to be there for you for the next 25—and beyond.

## > 2017 ACCOMPLISHMENTS

### We achieved a record number of adoptions.

Adoptions at our shelter increased for the 5th consecutive year, translating to a record 602 animals homed, besting 2016's previous record of 552 animals adopted.

### We expanded our community service to include military veterans.

This November, we announced plans to offer services for the pets of military veterans facing financial hardship. The program helps target the root causes of pet homelessness, enabling pets to stay with the owners who might otherwise be forced to surrender them.



### We reinforced our position as the region's leading resource for animal welfare.

When Hurricane Harvey struck Houston, we were inundated with calls from concerned animal lovers wanting to help. We organized a 48-hour emergency drive for pet food and pet supplies. By coordinating with the city of Boston, we were able to deliver over 2,000 pounds of urgently needed items to first responders in Texas within the week.

# HIGHLIGHTS FROM A BUSY YEAR

**January & February** | Animal rescuers don't hibernate! We adopted out 89 animals in the dead of New England winter.



## April

Kara McInnis ran the world-famous Boston Marathon to raise money for our pets—and crucial awareness for the issue of animal homelessness.

**June** | We celebrated our 25th anniversary by throwing a party for the South Shore Community that has supported us since 1992. Underneath sunny skies, party attendees were treated to games, food, prizes, and a police K9 demonstration. Executive Director Maryann Regan announced the winner of the 2017 Vazza Award, a prize honoring a young community member who has demonstrated support to SAS and a deep love for animals.

**August** | We rescued four dogs from a 'pet hoarding' situation in Boston. The dogs were healthy but completely unsocialized, having been kept indoors for their entire lives. Our volunteers and staff worked tirelessly to socialize them, introducing them to treats, leash walks, grass and sunshine. All four were adopted by October.

## November

To honor Veterans Day, we announced the expansion of our HELP program to include military vets. The HELP program is our initiative that provides supplies, medical care and support to elderly pet owners in the community who are facing financial hardship. As part of the HELP program, we held a free wellness clinic for dogs and cats.



**December** | Our strong social media presence helped us with an amazing rescue of 5 orphaned kittens. A supporter brought us a cat who had been hit and killed by a car, in hopes that we could give the owner some closure. We realized that the cat had recently given birth and sent out an urgent call via social media to help in the search for the orphans. A tip from one of our 15,000 followers led us to discover the kittens days later, clinging to life in a chilly Norwell barn. All survived, and all have been adopted. The incredible story was featured on *CBS News*.

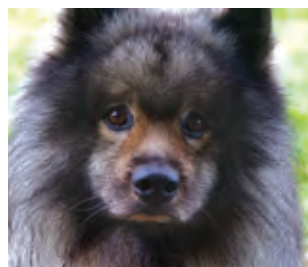

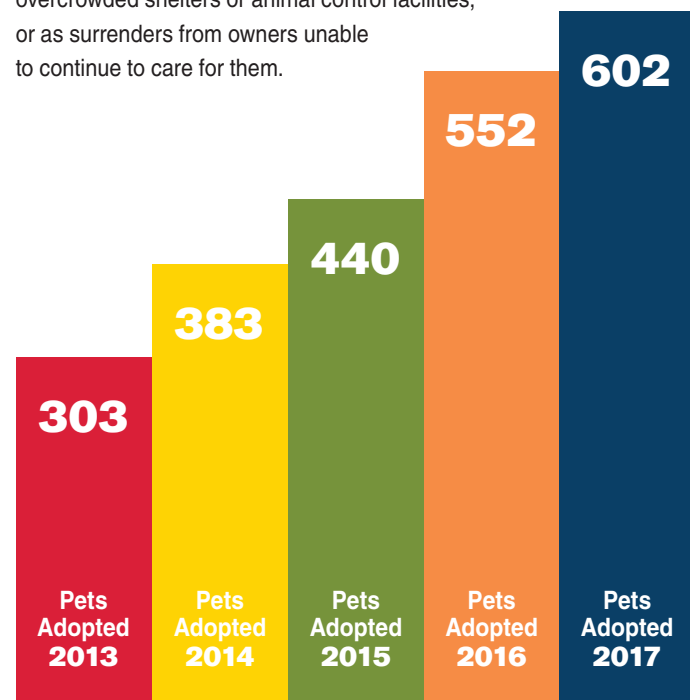

## ADOPTIONS

Our shelter found homes for 602 animals in 2017, continuing a 5-year trend of increased adoptions each year. Our animals come to SAS from all over Massachusetts, coming to us as strays, as transfers from overcrowded shelters or animal control facilities, or as surrenders from owners unable to continue to care for them.



**Our thoughtful and generous** friends and supporters made 2017 extraordinary. Because of you, SAS remains very financially healthy.

In 2017, we saw a large increase in revenue, due to a surge in new supporters and a generous bequest from the Susan Phippen Estate. Although in 2017 we cared for a record number of animals and adopted out 50 more dogs, we were able to keep 2017 expenses even with those of 2016.

We added to our team and made investments to our infrastructure as part of our ongoing mission to improve our level of care and increase the reach of our programs. Thank you to our supporters and our amazing volunteers and staff—you made it a truly successful year.

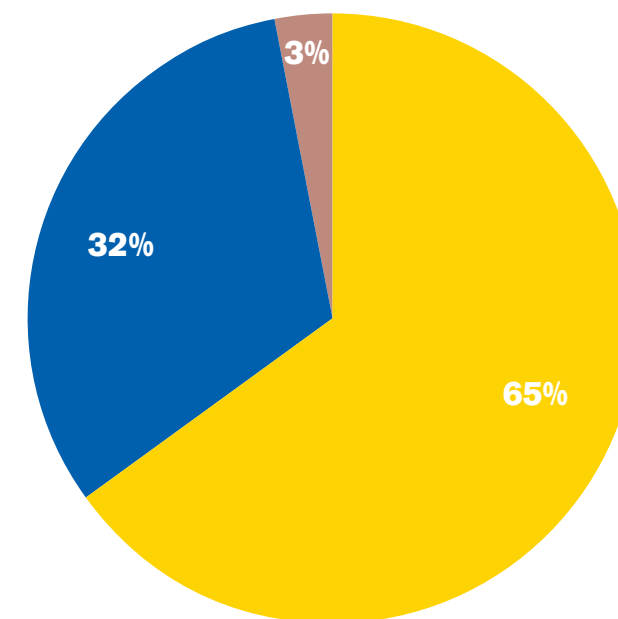

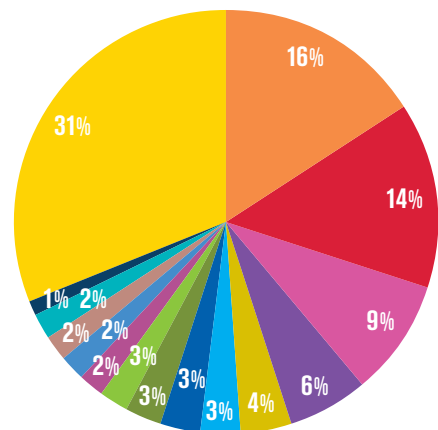

Many shelters don't have the resources necessary to care for elderly or special needs animals. **We are committed to finding homes for even the most vulnerable pets.**

**Roughly 20% of the animals we adopt out each year are older than seven years, or have a medical or behavioral condition which makes them more difficult to adopt. Our supporters don't want us to give up on them, and we believe they deserve happy lives. Here are some of their stories from 2017:**



**Chili** | Talk about bad luck. Chili was a three-legged cat who was rescued after being abandoned in an locked apartment when his owners moved. He tested positive for Feline Leukemia, a virus which is the leading non-trauma cause of death in cats. Feline Leukemia does not have to be a death

sentence, and we really wanted Chili to have a shot at life with a loving family. He was adopted in the fall of 2017.

**Dakota** | This 12-year-old, nearly blind miniature schnauzer was scheduled for euthanasia at another Massachusetts facility. We transferred him to our shelter and were charmed by his affectionate nature and love for soft toys and balls. After a short time with us, we were able to find him a home where he could comfortably live out the last portion of his life.



**Laz** | Ten-year-old Laz came to us friendly and loving, but in very rough shape. He had been struggling to live out-of-doors, and was terribly thin. A medical exam showed him to be hyperthyroid and FIV+, a condition for which there is no cure.



Cats with FIV can live long, healthy lives, but they are vulnerable to secondary infections due to a compromised immune system, and many shelters routinely euthanize them. After several months, we were able to find a great home and a second chance for Laz.

**Peaches** | Finding a great home for an 11-year-old Pit Bull is bit of a challenge, but given Peaches' sweet, shy demeanor and the difficult life she'd lived, we knew we had to try. She was



terribly malnourished and suffering from painful arthritis when she first arrived, but today Peaches has been adopted and receives regular laser treatments and aquatic therapy.

**SUSAN PHIPPEN: An angel for animals**  
It is with the deepest gratitude that we recognize a most generous 2017 bequest. Susan Phippen was beloved in Scituate for her tireless civic leadership and her dedication to many causes including historic preservation, helping families in need, and of course, animals. 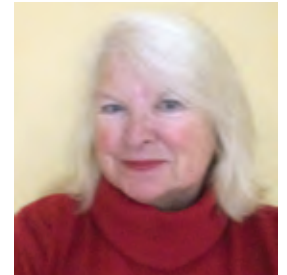
