SprayHub[™] Privacy Policy

Tomecek Agronomy Services Inc. (hereinafter "TAG", "we", "us" or "our") considers your personal information to be very important and it should be protected. This Privacy Policy describes how we treat the information we collect when you use SprayHub. Please take the time to read this Privacy Policy carefully. This Privacy Policy should be read in conjunction with the terms and conditions contained in the Spray Hub end user license agreement (the "Terms of Use") found on <u>www.tomecekag.ca</u>. All capitalized terms used herein not otherwise defined shall have the meanings ascribed to them in the Terms of Use.

By using SprayHub or otherwise providing us with your personal information, you are accepting the practices described in this Privacy Policy, as they may be amended by us from time to time, and agreeing to our collection and use of your personal information in accordance with this Privacy Policy. If you do not agree to the collection, use and disclosure of your personal information in this way, please do not use Spray Hub or otherwise provide TAG with your personal information.

1. PRIVACY STATEMENT

Our policies and practices have been designed to comply with the *Personal Information Protection and Electronic Documents Act* (the "Act") and any other relevant privacy legislation.

TAG respects the privacy of each individual with whom it comes into contact as a user of SprayHub. TAG will not rent or sell any of your personal information to any organization or individual unless you give us permission to do so.

2. PERSONAL INFORMATION

Personal information is information that refers to an individual specifically and that is recorded in any form. Personal information includes such things as age, income, date of birth, ethnic origin and credit records but does not include aggregated data from which the identity of an individual cannot be determined. Information about individuals contained in the following documents is not considered personal information:

- public telephone directories, where the subscriber can refuse to be listed;
- professional and business directories available to the public;
- public registries and court records; and
- other publicly available printed and electronic publications.

We are responsible for all personal information under our control, including any personal information that we transfer to third parties for processing, storage or other purposes. The activities of third parties that provide services to us or that you link to through your use of SprayHub, or that may collect information about you themselves or that we may share your information with in accordance with this Privacy Policy are governed by the respective privacy policies of those third parties.

In order for SprayHub to work for all parties, we need to communicate with you. To do this, we require your email address. In order to establish your user account, we also require certain registration data. We may also request additional information to better provide you with the SprayHub services.

TAG does not collect any other personal information that you do not expressly provide. If you do not want your personal information collected, do not provide it to us. If you have already submitted the information and would like us to remove it from our records, or you would like to know what information is held in our records or wish to have any of the information updated or modified, please contact us at the address set forth below. TAG will not disclose your personal information to any third party without your consent, except as detailed below.

3. USE OF PERSONAL INFORMATION

TAG may use and/or maintain records of your personal information such as your name, address and other registration data, current location, and/or other unique personal identifiers, as the case may be, to provide and facilitate use of Spray Hub.

TAG identifies the purpose for which your personal information is collected and will be used or disclosed. If that purpose is not listed below, we will do this before or at the time the information is actually being collected. You will be deemed to consent to our use of your personal information for the purpose of:

- communicating with you generally about SprayHub and the services provided through SprayHub;
- registering your user account with SprayHub;
- administering an managing the SprayHub services and our business operations;
- tracking and reporting on your use of SprayHub including, without limitation, providing information about your agricultural activities to the persons and organizations that you specify during registration for the purposes of enabling enhanced real-time communication between the parties involved in the agricultural process;
- protecting against fraud or error;
- understanding and responding to your needs and preferences, including, but not limited to, communicating with you and to provide you with support and other services;
- providing services requested by you including, without limitation, the SprayHub services;
- performing statistical analyses of user behaviour and characteristics, in order to measure interest in and use of the various sections of SprayHub so as to improve design and navigation of SprayHub;
- troubleshooting problems and technical or security issues;
- detecting and protecting against error, fraud or other criminal activity as required by any applicable laws, rules or regulations or governmental requirements;
- complying with legal and governmental requirements; and

• fulfilling any other purpose that would be reasonably apparent to the average person at the time we collect it from you.

Any personal information or content that you voluntarily disclose while using Spray Hub, which can be viewed by other users thereof, becomes publicly viewable and can be collected and used by others.

Due to the global nature of the Internet, you may be transferring your personal information to countries outside of your jurisdiction of residence, whose legal systems do not offer the same protection for your data as the laws of your jurisdiction of residence.

4. NON-PERSONAL INFORMATION

It is possible that we may also request non-personally identifiable information, like gender, city of residence and age. We may use this data to improve SprayHub and/or personalize your experience using SprayHub. This information will only be shared in an aggregate, anonymous form, which means that the information will not contain any personally identifiable information about you or any other person.

5. USAGE INFORMATION

In addition to collecting personal and non-personal information, TAG and our third party service providers may also use a variety of technologies that collect non-personal, aggregated information about the registered users' use of SprayHub. Usage Information may include the browser you are using, the URL that referred you to SprayHub, all of the areas within SprayHub that you visit, and the time of day, among other information.This information is not personally identifiable and will only be used to find out how its registered users use SprayHub. For example, this information may tell us how much time users spend on SprayHub. The collection of this information allows us, among other things, to create new features, prepare for traffic load demands and to efficiently distribute any email communications.

6. SHARING INFORMATION

Except with your consent and as set out herein, we will not sell, license, trade or disclose your personal information to or with others.

We may disclose or share non-personally identifiable information with partners, advertisers or prospective partners or advertisers to help explain our business and the effectiveness of our business or for promotional purposes. For example, we may disclose aggregated demographic information which does not include any personally identifiable information.

TAG may disclose personal information to third party providers of TAG, including third parties engaged to assist us in providing the SprayHub services (including but not limited to software development and hosting, data processing, transaction processing services, document management and office administration) to you or to carry out one or more of the uses described above. These service providers are prohibited from using your personal information for any purpose other than to provide this assistance and are required to protect personal information disclosed by TAG and to comply with the general privacy principles described in this Privacy Policy.

TAG reserves the right to disclose personal information to a third party if a law, regulation, search warrant, subpoena or court order legally requires or authorizes us to do so.

TAG also reserves the right to disclose and/or transfer personal information to a third party in the event of a proposed or actual purchase, sale (including a liquidation, realization, foreclosure or repossession), lease, merger, amalgamation or any other type of acquisition, disposal, transfer, conveyance or financing of all or any portion of TAG or of any of the business or assets or shares of TAG or a division thereof. TAG will secure an undertaking from any such third party to treat the disclosed and/or transferred personal information with the same degree of diligence as had been previously provided by TAG.

7. ACCURACY AND RETENTION OF PERSONAL INFORMATION

TAG endeavours to ensure that any personal information in its possession is as accurate, current and complete as necessary for the purposes for which we use that information. If we become aware that personal information is inaccurate, incomplete or out of date, we will revise the personal information.

We keep your personal information only as long as it is required for the reasons it was collected. The length of time we retain information varies, depending on the purpose for which it was collected and the nature of the information. This period may extend beyond the end of your relationship with us, but it will be only for so long as it is necessary for us to have sufficient information to respond to any issues that may arise at a later date.

8. SECURITY

We use physical, electronic, and administrative safeguards to assist us in preventing unauthorized access, maintaining data accuracy, and correctly using your personal information. Except as specified in this Privacy Policy, we use commercially reasonable efforts to limit access to your personal information to the employees, agents, and officers of TAG on a need-to-know basis.

9. CHANGES TO THIS PRIVACY POLICY

TAG reserves the right to make changes to this Privacy Policy from time to time by posting the updated version of this Policy on our website at <u>www.tomecekag.ca</u>, and by emailing a copy of the updated Privacy Policy to you. In such a case, we will update the effective date of the updated version of this Privacy Policy. You may find the current effective date at the bottom of this Privacy Policy. You are bound by any changes to this Privacy Policy when you use Spray Hub after such changes have been first posted.
