These programs are designed to meet and assist your loved one's ability to complete daily living tasks independently in the community setting.

Eligible services include but are not limited to:

- Social skills
- Budgeting
- Self-Advocacy
- Housekeeping
- Vocational Skills
- Safety Skills
- Recreational Activities
- Community Integration
- Medical Appointments
- Companion Services (Behavior or Day and/or Night Companions)

Early & Periodic Screening, Diagnosis, and Treatment (EPSDT)

• It is a service for individuals between **0-21 years of age**. Only in combination with Children's Choice. Children's Choice Waiver (CCW) is a Medicaid Home and Community Based Service Program that offers supplemental support to children with developmental disabilities who are currently living at home or who will be leaving a foster care/institution to return home.

New Opportunities Waiver (NOW)

Provides case management, family support, and training for individuals who are ages 3 and older
and who are MR/DD. This program is intended to provide specific activity-focused services rather
than continuous custodial care.

Community Choices Waiver (CCW)

Provides home and community-based services (HCBS) for seniors and adults with disabilities
who are at risk of nursing home admission. This program is intended to assist in remaining at home
or in the community.



Long-Term Personal Care Services (LT-PCS)

• Provide regular support for unspecified activities of daily living for individuals. This program provides services to individuals **aged 21 years or older**.

Children's Choice Waiver (CC)

• The Children's Choice Waiver (CC) program specifically offers services in the home and community to individuals **aged 0 to 20 years** who live at home with their families or are transitioning from an institution to return home. This program provides in-home care and support for children with developmental disabilities.

Residential Options Waiver (ROW)

Provides services to individuals from birth to the end of life that have a developmental disability
which manifested prior to the age of 22. (Must meet the Louisiana definition of DD).

Supervised Independent Living (SIL)

D' Nicole provides a Supervised Independent Living Program. SIL is designed to meet and assist
people in living independently with minimal assistance in the home of their choice. We believe
individuals of all abilities deserve to live their best life. Our goal is to support our clients' endeavors
through therapeutic guidance in their living situation by providing transportation to stores for
groceries and clothes, doctor appointments, movies, or outings into the community.
