Camp Rules and Etiquette for our Mock Hunting Guests During Your Stay With us

1. Never go out exploring alone. Make sure you have a GPS incase you go exploring without a guide. If you do not have a GPS, exploring without a guide is not recommended and is against camp rules. We Hunt Arizona will not be held accountable if you get lost or worse, hurt.

- 2. Fires are to be in approved fire rings. No fires are to be left unattended and must be properly extinguished.
- 3. Do not dig holes; do not cause harm or damage trees or other vegetation. Practice no trace camping and hiking.
- 4. Use of fireworks or other explosives within campsite and other recreation areas is prohibited.
- 5. Help prevent pollution by keeping garbage, litter, and foreign substances out of lakes, streams, and other waters. All garbage and litter must either be deposited in containers provided, or taken with you when you leave.

6. We allow alcohol in camp. However, we have a ZERO tolerance to the consumption of Alcohol at any time during active hunting. This means if you have a beer for lunch, it will be 2-3 hours after your beer before the afternoon outting begins. No alcoholic beverages will be allowed while in the field or directly before going in the field. After your in field guided excursion is finished for the day and you are back in the outfitters camp, feel free to enjoy beer or wine (no glass or hard liquor is allowed) in hunt camp either with your dinner or around the camp fire.

We request that guests remember excessive alcohol use will not be tolerated.

7. No weapons allowed.

Your guide will be armed in case of any animal encounter that may result in injury or harm to our guests.

8. If your excursion is with us during an actual hunting season, remember the following IS THE ARIZONA STATE LAW...

• <u>17-316. Interference with rights of hunters; classification; civil action; exceptions</u>

A. It is a class 2 misdemeanor for a person while in a hunting area to intentionally interfere with, prevent or disrupt the lawful taking of wildlife by:

- 1. Harassing, driving or disturbing any wildlife.
- 2. Blocking, obstructing or impeding, or attempting to block, obstruct or impede, a person lawfully taking wildlife.
- 3. Erecting a barrier without the consent of the landowner or lessee with the intent to deny ingress to or egress from areas where wildlife may be lawfully taken.
- 4. Making or attempting to make physical contact, without permission, with a person lawfully taking wildlife.
- 5. Engaging in, or attempting to engage in, theft, vandalism or destruction of real or personal property.
- 6. Disturbing or altering, or attempting to disturb or alter, the condition or authorized placement of real or personal property intended for use in the lawful taking of wildlife.
- 7. Making or attempting to make loud noises or gestures, set out or attempt to set out animal baits, scents or lures or human scent, use any other natural or artificial visual, aural, olfactory or physical stimuli, or engage in or attempt to engage in any other similar action or activity, in order to disturb, alarm, drive, attract or affect the behavior of wildlife or disturb, alarm, disrupt or annoy a person lawfully taking wildlife.
- 8. Interjecting oneself into the line of fire of a person lawfully taking wildlife.

Once your reservation is made, prior to your trip, you will get a copy of these rules and will be asked to sign them. So that there is no misunderstanding before, during or after your Mock Hunt Experience with us.
