



THE UGG SCHOLARSHIP FUND

Scholarship fund program guidelines

The Ugg scholarship fund is dedicated to helping individuals in targeted communities of Southwest, Atlanta who strongly desire employment and interested in becoming an apprentice. The belief of “Developing Tomorrow’s Future Leaders” means to ensure no one is left behind and CCME Training Service is committed to opening doors in underserved communities to unseen talent that offers opportunities to leaders of our future workforce.

The purpose of the Ugg scholarship is to provide scholarships to deserving individuals who desire entry into the workforce or a career upgrade utilizing a non-traditional education approach intending to pursue a career sector apprenticeship with CCME Training Service.

For 2022, the Ugg scholarship fund award ceiling is \$20,000, and the individual maximum award is \$10,000. The Ugg scholarship fund will be awarded to two (2) individuals that apply for the funding and meet the scholarship qualifications. **Note: Scholarship funds will be awarded to the apprentice once they have been accepted into the apprenticeship program by the USDOL.**

Criteria and eligibility: (Ugg Scholarship Fund applicants)

1. Applicant must live in the following Southwest Atlanta community (Campbelltown Rd, Delowe, Niskey lake, Barge Rd, Ben Hill, Cascade (Old Kimberly Court Community or Adamsville).
2. Applicant must have a barrier such as: (At risk youth adult, teen parent, probation, enrolled into an adult education program, homeless, foster care and/or graduating high school).
3. Applicant can’t be eligible for funding through our partnering agency (must show proof)
4. If awarded the scholarship, applicant must consent to a “give back” commitment by providing a good faith community service activity related to your occupation IN THE Southwest Atlanta Community.
5. Applicant must be willing to attend the required scholarship orientation held by CCME Training Service.
6. Applicants may not be related to any of CCME Training Service owners or staff members - for this permits a conflict of interest.
7. To be considered the applicant complete the following:
 - ❖ Applicant must apply during the permitted timeline
 - ❖ Complete the required application, questionnaire and meet all the requirements
 - ❖ Submit an Essay
