

TORAHFLIX ACTOR RELEASE FORM

This Actor Release Form (“Agreement”) is entered into by and between Torahflix (“Producer”), a company organized and existing under the laws of New York, USA, with its principal place of business at 137-18 75 Rd Flushing, NY 11367, and the undersigned actor/performer (“Actor”), individually and collectively referred to as the “Parties.”

1. Grant of Rights

The Actor hereby grants Producer the unrestricted right and permission to use, distribute, broadcast, and exploit the Actor’s performance(s), voice, image, likeness, name, and biographical information (collectively, the “Materials”) in connection with the production, marketing, and distribution of any audiovisual work, including but not limited to films, television shows, online media, promotional materials, and other media content created by Torahflix (the “Work”).

2. Scope of Usage

The Materials may be used in any and all media, whether now known or hereafter created, worldwide, and in perpetuity. This includes the right to edit, modify, and adapt the Materials for any purpose, including commercial or promotional purposes, and without limitation as to the form, manner, or medium of distribution.

3. Compensation

The Actor acknowledges and agrees that their performance and participation in the Work are voluntary, and the compensation for their services shall be set forth in a separate agreement or as otherwise agreed upon. This release does not entitle the Actor to any additional compensation or royalties beyond what is specified in the separate compensation agreement.

4. No Further Compensation

The Actor agrees that they will not receive any further compensation or royalties beyond the agreed-upon terms for the use of the Materials, regardless of how the Work is distributed, broadcast, or exhibited, unless otherwise agreed in writing.

5. Indemnification

The Actor agrees to indemnify and hold harmless Producer, its affiliates, employees, agents, and assigns from any and all claims, demands, damages, liabilities, and expenses arising out of or in connection with the Actor’s participation in the production and use of the Materials.

6. Release of Liability

The Actor waives any and all rights to inspect or approve the final form of the Work or the Materials as used in the Work. The Actor further waives any right to assert any claim against Producer, its affiliates, or partners for any reason related to the use of the Materials in the Work.

7. Confidentiality

The Actor agrees not to disclose any confidential information related to the Work, its content, or any other proprietary information belonging to Torahflix. This confidentiality obligation shall survive the termination of this Agreement.

8. Relationship of the Parties

The Actor acknowledges that this Agreement does not create an employer-employee, agency, or partnership relationship between the Actor and Producer, but merely serves to grant the rights outlined herein.

9. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of New York, USA, without regard to its conflicts of law principles.

10. Entire Agreement

This Agreement constitutes the entire understanding between the Parties with respect to the subject matter hereof and supersedes all prior or contemporaneous oral or written agreements, understandings, or representations.

11. Amendment

Any amendment or modification of this Agreement must be in writing and executed by both Parties.
