DOG TRAINING AGREEMENT (page 1)

This Agreement is between _____ (hereinafter referred to as "Owner") and Walks and Homes Dog Training Services (hereinafter known as "Trainer").

Both parties agree as follows:

The Owner agrees to pay the Trainer a non-refundable fee in the amount of £_____ per session (approximate length of one hour) payable at least 7 days prior to the agreed start date.

OR

The Owner agrees to pay the Trainer a non-refundable fee in the amount of £_____ for a package of _____ sessions (approximate length of one hour each) payable at least 7 days prior to the agreed start date.

All fees are non-refundable, and sessions are not confirmed until payment has been received.

The Trainer agrees to provide private and/or group lessons for the Owner and the Dog. Sessions will be approximately one hour in duration and will take place at the Owner's home or at a chosen location.

The Trainer will make reasonable efforts to assist the Owner in achieving training and behavioural goals. The Owner acknowledges that training success depends on their consistency and involvement.

The Owner understands and agrees that they and all members of the household will follow the Trainer's instructions without modification and will reinforce all training provided.

The Owner accepts full responsibility for the Dog's behaviour at all times.

The Owner confirms that the Dog is in good health, up to date with vaccinations, and free from contagious conditions.

DOG TRAINING AGREEMENT (page 2)

Cancellation Policy for Walks and Homes Dog Training Services

By paying the session fees, the Trainer assumes that the Owner has read and agreed to the Terms and Conditions of this contract.

No cancellation fees will be applied. If either party is unable to attend a scheduled session, the session will be rescheduled at a mutually agreed time, provided reasonable notice given.

Owner agrees to be solely responsible for any damage, injury, or loss caused by the Dog during the term of this Agreement and agrees to indemnify and hold harmless the Trainer from any related claims, expenses, including legal fees.

At the Trainer's decision, the Trainer's duties hereunder shall terminate if (a) in Trainer's sole judgment Dog is dangerous or vicious to the Trainer or any other person or animal, or interferes with the training of other dogs, or (b) the Owner breaches any term or condition of this Agreement.

Without limiting the generality of the foregoing, the Owner acknowledges that Trainer has not represented, promised, guaranteed, or warranted that Dog will never bite, that the Dog will not be dangerous or vicious in the future, that the Dog will not exhibit other behavioural problems, or that the results of the training will last for any amount of time.

This Agreement constitutes the entire agreement between the parties.

No verbal statements or prior agreements shall have any force or effect unless included in this document.

Any amendments must be made in writing and signed by both parties.
