This Agreement is between _____ (hereinafter referred to as "Owner") and Walks and Homes Pet Services (hereinafter known as "Trainer").

Both parties agree as follows:

Owner agrees to pay Trainer a nonrefundable fee in the amount of £_____ per session (approximate length of one hour) to be paid 7 days prior to the agreed start date.

OR

Owner agrees to pay Trainer a nonrefundable fee in the amount of £_____ for a package of _____ sessions (approximate length _____ each) to be paid 7 days prior to the agreed start date.

Trainer agrees to provide **private/group lessons** for the Owner and Dog on a lesson-by-lesson basis, the goal being to teach how to train and work with Dog. These lessons will take place at Owner's home or at a chosen location.

Trainer will make every reasonable effort to help the Owner achieve training and behaviour modification goals but gives no guarantee of Dog's performance or behaviour.

Owner understands that he/she and members of the household must follow Trainer's instructions without modification, work with dog daily as recommended, and constantly reinforce training that is given to the Dog.

Cancellation Policy for Dog Training Services

In case the Owner fails to give at least 24 hours cancellation notice, or is not present at time of scheduled appointment, session fees are still due. For a package deal, the session will still be counted as one session.

In case if the Dog causes property damage, or bites or injures any dog, animal or person (including but not limited to Trainer and Trainer's agents), during training sessions and during the term of this Agreement, the Owner agrees to pay all resulting losses and damages suffered or incurred, and to defend and indemnify Trainer and Trainer's agents from any resulting claims, demands, lawsuits, losses, costs or expenses, including attorney fees.

In case if the Dog is injured in a fight or in any other manner during training sessions and during the term of the Agreement, Owner assumes the risk and agrees that Trainer should not be held responsible for any resulting injuries, losses, damages, costs, or expenses.

At Trainer's decision, Trainer's duties hereunder shall terminate if (a) in Trainer's sole judgment Dog is dangerous or vicious to Trainer or any other person or animal, or interferes with the training of other dogs, or (b) Owner breaches any term or condition of this Agreement.

Both parties confirm that, except for what is specifically written in this Agreement, no promises, representations, or oral agreements have been made regarding Dog's training sessions or anything else.

Without limiting the generality of the foregoing, Owner acknowledges that Trainer has not represented, promised, guaranteed, or warranted that Dog will never bite, that Dog will not be dangerous or vicious in the future, that Dog will not exhibit other behavioural problems, or that the results of the training will last for any amount of time.

This Agreement may be amended only by a written instrument signed by both Client and Trainer.
