On 11/12/2020 Sergeant Thomas Thillet contacted me in reference to an incident between Deputy Travis McCabe and Code Enforcement Officer Buddy Burgess.

Sergeant Thillet provided a video of the encounter for review.

On this same date I spoke with McCabe regarding the incident. McCabe stated immediately after he arrived and made contact with Burgess he became confrontational and would not discuss the reason for law enforcement assistance. McCabe informed me he simply asked for clarification on the reason for the citation and Burgess immediately began lecturing him on his duties and became argumentative.

The video provided corroborates McCabe's account of the incident. Burgess' attitude and demeanor throughout the video was extremely unprofessional and did not display the type of working relationships and interactions Deputy Sheriffs usually have with Code Enforcement Officers. This incident and behavior from Burgess is not the first negative encounter between members of the Walton County Sheriff's Office and Burgess. Burgess' repeated unprofessional behavior is creating a strain on the working relationship with Walton County Code Enforcement.

November 17,2020

This report is in reference to Access # CV-2020-0040179, Beach Code Compliance Officer Buddy Burgess. According to the report on November 11, 2020, Officer Burgess was attempting to drive off the beach using the beach drive on road at Ed Walline Beach Access. He observed two white male subjects carrying surfboards starting to walk down the same access road. It should be noted that there are signage advising the public not to block the emergency access road and to use the boardwalk to access the beach. In his report, Officer Burgess stated that he had made several attempts to have the two white males to stop and turn around and explain the hazards of blocking the emergency access roadway. In his report Officer Burgess stated that only one of the subjects stopped and talk to Officer Burgess. The other white male did not stop and continued to walk to the beach. Officer Burgess contacted this subject later identified as Chandler Johnson who refused to speak to Officer Burgess and became argumentative and uncooperative.

In the report, Officer Burgess stated that the Johnson subject said he would provide his information, but when Officer Burgess asked his name, he stated his name was Christian, when asked to spell it, he refused to continue. Officer Burgess informed the Johnson subject if he refused to cooperate, Officer Burgess would be forced to contact the Walton County Sheriff's Office and his refusal to sign and accept a citation would be a misdemeanor. At that point the Johnson subject stated, "You say that like it's supposed to scare me". Officer Burgess then went back to his vehicle and contacted the Walton Co. Sheriff's Office and Chandler entered the water. Officer Burgess no longer had contact with the two white males. Before the Deputy arrived, Officer Burgess contacted the SWFD Lifeguard working at Ed Walline Access asking if she knew the white male, she advised that she did not know his last name, but his first name was Chandler. Officer Burgess stated that he was walking back to his vehicle when the deputy arrived, and spoke to Officer Burgess, asking what was going on. Officer Burgess stated that he advised the deputy that he was trying to issue a citation for breach of peace, but subject refused to provide any information, sign or accept the citation. In the report, Officer Burgess advised that the deputy immediately began to question why Officer Burgess was trying to issue a citation for the violation. Officer Burgess further stated in his report, that he retrieved his body camera so that he could document the encounter. In Officer Burgess' report, it was stated that the deputy continued questioning what the citation was for and how it was appropriate for the situation. Officer Burgess stated to the deputy that he did not mean any disrespect, but that was not why he was there for and it did not matter. Officer Burgess advised the deputy, that if he refused to enforce a misdemeanor FS. .162.21 (6) that occurred in his presence then that was on the deputy. At this point according the report, the deputy started to raise his voice, and Officer Burgess ended the encounter and asked the deputy who his supervisor was, he said it was Sgt. Thillet. Officer Burgess advised that he would contact the

supervisor. A portion of the incident was captured on Officer Burgess Body Camera, which I was able to obtain a copy of the footage. No Citation was issued by Officer Burgess.

On November 23,2020 I received a copy of an email from Major Donald Clark Director of Law Enforcement Walton County Sheriff's Office and a memorandum from Lieutenant Dustin Cosson to Captain Robert Gray in reference to the incident involving Code Compliance Officer Buddy Burgess and Deputy Sheriff Travis McCabe. The following are quotes from the email and the memorandum.

(Email)

Director Cornman,

Please see attached memorandum reference an interaction we had with Buddy Burgess on November 12, 2020. I routinely hear from my staff of negative interactions with Mr. Burgess in his official capacity as a Code Enforcement Officer. It has degraded to the point that staff members have lost confidence in his abilities to make common sense assessments of code violations. His behavior has also damaged the working relationship between Code Enforcement and the Sheriff's Office. We want, very much, to work alongside each other when serving our community however, I feel this is not possible with Mr. Burgess. At this point, I do not believe the working relationship with my staff and Mr. Burgess can be repaired. I wanted to bring this to your attention to mitigate any further degradation between our agencies.

(Memorandum)

After reviewing the reports and Officer Burgess Body Camera footage and the memorandum from the Walton County Sheriff's Office, it is my opinion that Beach Code Compliance Officer

Burgess should have given Deputy McCabe more information and explained the reason for the citation, especially after asking the Walton County Sheriff Office assistance on this case.

When I asked him to spell it for me he started spelling and I appeared he did not no how to spell it so he then just refused to continue. I informed him if he refused to cooperate I would be forced to contact the Walton County Sheriff's Office and his refusal to sign and accept a citation is a misdemeanor. He stated," You say that like it's supposed to scare me." I then returned to my vehicle and contacted the WCSO. Mr. Johnston entered the water to surf while I stood by for the WCSO. While I waited I placed my body cam inside my vehicl and went to speak with the life guard to see if she knew Mr. Johnston's name as at tha time I did not know his identity. The lifeguard said she did not know his last name but his first name was Chandler. As I was walking back t my vehice the deputy arrived and walked down the boardwalk. He asked what was going on and I told him I was trying t issue a citation for breach of peace but the subject refused to provide in formation and sign and accept. The deputy immediately began to question why I was issueing the citation. Due to his dimeanor and the way he was asking the questions. I stopped him momentarily so I could retrieve my body cam so there would be no question as to what was said between us. The deputy continued questioning what the citaiton was for and how I felt it was appropriate for the situation. I told him that I meant no disrespect but that was not what he was there for and it did not matter. He was adamant that he needed to know how the subject was in breach of peace. The deputy informed me that if he went over there and asked the subect for his information but he refused he was going to walk away. I told him that if he chose to refuse to enforce a misdemeanor that occurred in his presence then that was on him. He was adamant that he coud not do anything unless I explained to him how the subject was in breach of peace and refused to accept that he was only there to inforce F.S.S. 162. When the deputy started raising his voice I ended the discussion and asked him who his supervisor was. After asking multiple times he

While employed as a Beach Code Enforcement Officer (enforcing "Walton County Waterways and Beach Waterways Ordinance), on February 17, 2020 while attempting to enforce the Land Development Code involving a political sign you engaged in a verbal confrontation with Sgt. John Glenister of the Walton County Sheriff's Office. When Sgt Glenister arrived on scene as you had requested, he advised you that that the sign was not in violation due to it having an exception based on it being a political sign. You began yelling at Sgt. Glenister and demanding that he enforce F.S. 162.21, which deals with individuals refusing to sign a code citation. You also indicated to Sgt Glenister that the individual with the sign was blocking the crosswalk and Sgt Glenister determined that he was not blocking the crosswalk. Your behavior directed toward WCSO and Sgt Glenister was unacceptable and will not be tolerated. It should also be noted that this type of activity has previously been documented in a memo dated 12/04/2018 to employee (Buddy Burgess) file from Brian Kellenberger (supervisor). This memo documented an informal counseling session with you about a fire lane parking incident at Publix. During this incident you were attempting to enforce a parking violation which is not covered under your jurisdiction or authority and you acted with a short and abrasive attitude toward the complainant, quickly escalating to threatening to involve WCSO. During this meeting, Brian Kellenberger advised you about the need of a polite, professional and courteous service to our citizens/customers and reminded you that your area of responsibility is Chapter 22-Waterways and Beach Activities Ordinance which included the beach and TDC parks. CORRECTIVE ACTION TO BE TAKEN BY THE EMPLOYEE: Review of the Walton County Personal and Policy Manual in reference to conduct with other employees or general workers. In the future you are to act in a polite, professional and courteous manner toward all coworkers, other employees, superiors, elected officials, constitutional office employees and the general public. You are to work violations that are covered under your jurisdiction as a beach code enforcement officer unless asked or directed to assist in another situation. The County reserves the right to take any further disciplinary action it deems appropriate, up to and including termination. On 6/8/2020 I was informed by Danny Garner that I was being issued a written reprimand due to an incident that occurred on 2/17/2020. During this encounter I was contacted by 3 different deputies. The first Don Fernandez which did exactly as was requested of him. He stood by as I explained to the subject that he was in violation of Walton County Municipal Code with having the signage in the right of way and blocking the multi-use path. Deputy Fernandez explained to the subject that I was in a position to address such issues and required the subject to provide me with his information. Once I gathered the information I returned to my vehicle as did Deputy Fernandez. As we waited for the subject to comply Deputy Fernandez informed me Sgt Glennister wanted to speak with me on the phone. Sgt Glennister questioned the validity of the ordinance, but I provided him the section number for him to look. As I stood by Sgt Pullings arrived on scene and went to speak with the subject. A few minutes later he returned and informed me this was a civil matter due to the citation being a civil citation. I reminded him that failure to sign said citation is a misdemeanor to which he denied. Told him I just needed him to stand by while I attempt to issue a citation. He walked to his vehicle and left. Deputy Fernandez started to leave and I flagged him down to ask where they were going. He stated they were ordered by their LT to vacate the area immediately. I then contacted Lt. Brown and asked what the situation was as to them leaving. He said he told them to standby while I did what I needed to do and then leave. As we spoke Sgt Glennister pulled up. I ended my conversation with Lt. Brown and engaged Sgt Glennister. He immediately walked around to the passenger side of his truck and pulled out his computer and began telling me I was incorrect and could not issue the citation. I attempted multiple times to explain to Sgt Glennister the reason for his presence it to enforce Florida State Statute 162 if it arose and to standby to assure the peace. Throughout our entire contact I addressed him as Sgt Glennister and attempted to show him professional courtesy. He however continued to call me Buddy and stated he refused to standby. At that point I told him if he was not going to do his job he could go back to his truck. He stated he was leaving. I then contacted Lt. Brown again and explained that Sgt Glennister stated he would not stand by. Lt. requested I hand Sgt Glennister the phone. As they spoke on the phone Sgt Glennister lied to him and stated the subject had signage stating "Vote Trump" so they fell under political signage which he claimed was exempt. Lt. Brown ordered Sgt Glennister to stand by while ! conducted my business. As I walked up to the subject Sgt. Glennister interrupted my business to inform the subject that I was going to write him a citation for a specific ordinance but he was in fact not in violation. The subjects finally agreed to relocate so as to not interfere with the foot traffic attempting to utilize the beach. After I relayed the information to Danny Garner regarding the case he and Brian Kellenberger reviewed my case notes. Danny later informed me, he and Brian both agree I was in the right by enforcing the land development code due to their location in relation to the public beach access.

In my written reprimand there are several issues to note. The first would be the fact that information regarding the incident that is referenced is from the WCSO deputies' statements and not from mine or Officer Ratcliff's statements. On the day that Danny Garner issued me the written reprimand he stated there were statements from 3 deputies and I informed him if there was then someone was lying as there were not 3 deputies there. I then requested copies of the deputies statements. The evening of the next day I received a copy of Sgt Glennister's statement. When I reminded Danny Garner I requested all the deputies' statements he informed me he only had a statement from Sgt Glennister. This means Danny Garner based this reprimand and the statements contained within solely on Sgt Glennister's

statement and completely ignored Dan Ratcliff's statement and my report. It states that I just began yelling at Sgt Glennister, demanding he enforce Florida State Statute 162. At no point did I yell or demand anything from Sgt Glennister as is corroborated by Officer Ratcliff.

The second would be the fact that it claims I stated they were blocking the crosswalk which I did not. My report stated they were blocking the multi-use path which Is where half of their stuff was located on. As Beach Code Enforcement we ARE tasked with enforcement of multi-use path violations, Per Brian Kellenberger.

The reprimand letter cites a prior incident that was documented in a memo Brian Kellenberger placed in my personnel file. In this memo Brian Kellenberger states he received a complaint. Nowhere in this memo does it state these accusations were confirmed or if there was any supporting evidence to corroborate. During this informal session it was admitted by Brian Kellenberger that it was obvious the information the complainant provided was unreliable. When questioned as to how I made contact I informed Brian Kellenberger that I record every encounter I am able to and all he had to do was ask and I would show him how I always approach in a caring an appropriate manner in an attempt to get voluntary compliance. At that time my supervisor was Jeff McVay, not Brian Kellenberger. Jeff McVay, as the lead code enforcement officer found no validity in the complaint so I would not be receiving counseling on the situation. In the memo that is cited as the reasoning for this to be a written reprimand it states only there was a complaint. It doesn't not state there was reason to believe the complaint was valid as Jeff McVay stated there was not. Brian Kellenberger ordered Jeff McVay to issue a written reprimand for the Incident. Jeff McVay informed Brian that if he wanted me written up he needed to do it since Brian took the complaint. Brian once again ordered Jeff McVay to write it but Brian Kellenberger wanted to dictate the exact wording of the reprimand. Jeff McVay did as he was instructed to and provided the document to Brian but he also noted in the reprimand that it was "Per Brian Kellenberger." Jeff McVay would not sign it until Brian signed it but Brian would not sign it so it was never finalized. This information can be verified by contacting Jeff McVay. I have been in contact with him and he stated he would provide a statement to verify this information if needed.

Buddy Burgess

On February 17,2020, while I was in South Florida I was contacted by TDC Beach Code Enforcement Officer Buddy Burgess via email advising about an incident that occurred on the multi-use path near Ed Walline Beach Access. In the email, Officer Burgess stated the incident involved some people that Officer Burgess was attempting to have them remove theirs table, signs and umbrella from county property/ right-a-way. Officer Burgess stated he had called the Walton County Sheriff's Office and they initially refused to stand by while he issued a citation and then attempted to undermine him by telling the subject that he was wrong and the person with the sign was not in violation. I advised by email that I would contact him on February 19, 2020 when I return to work. On February 19,2020 I met with Officer Burgess to go over his report. In the report, Officer Burgess stated that he had observed a group of people that had set up a sign (Donald Trump PAC), table and an umbrella on the multi-use path near the entrance of the Ed Walline Beach Access (see attached photograph). Officer Burgess stated that he contacted the subjects and introduced himself and attempted to explained to the group that the signage was not allowed according to the Land Development Code. In the report, Officer Burgess stated that one of the subjects Arthur Murphy only wanted to argue that it was his freedom of speech that allowed him to set up where he was located. Officer Burgess stated in his report, that he informed the subject that if they did not remove the items, Officer Burgess would have to contact the Walton County Sheriff's Office to become involved. In the report, Mr. Murphy stated that he had contacted the Sheriff's Office and they had given him permission. Please see attached copies of the interaction between the following officers, Officer Buddy Burgess code enforcement, Deputy Don Fernandez and Sgt. John Glenister with Walton County Sheriff's Office.

On this date I saw a group set up on the sidewalk in front of Ed Walline RBA. They had a table and umbrella set up on the sidewalk with signage placed at the stop sign on 30A and south of the sidwalk on TDC property. I made contact with the individuals, introduced myself, and explained to them the signage was not allowed. Mr. Murphy only wanted to argue that it was his freedom of speech that allowed him to set up there. County Code Violations at Ed Walline Regional Beach Access

During my shift on February 17, 2020 I, Ofc Ratcliffe, received a phone call from Ofc Burgess regarding multiple county code violations at the Ed Walline RBA. Ofc Burgess described the violations as follows:

2 subjects (W/F and W/M) manning table with informational signs on multi-use path, blocking crosswalk, and in ROW.

I voluntarily went to site to ensure my fellow officer's safety. While on site, I observed Ofc Burgess in his patrol vehicle with Dep Pullens standing next to him discussing the violations. I could hear Dep Pullens state to Ofc Burgess that this was a "civil matter" and the WCSO would not be involved with the county code violations. At this time Dep Pullens and another deputy left the area. Then Ofc Burgess contacted SO and asked them to return to the site because he needed to issue a citation to the subjects because they had ignored his previous warning. Dep Glenister arrived and Ofc Burgess and he got into a heated discussion over whether there was an existence of any county code violations. Dep Glenister asked me to read the county code which he had displayed on his laptop and I explained to him that it was not a matter of whether the SO agreed there was a violation or not, but that Ofc Burgess was requesting FSS 162 be enforced if the subjects refused to sign his citation. At this time Ofc Burgess approached the subjects to issue him a citation for the violations. Dep Glenister approached with him. At the same time Ofc Burgess was explaining the citation to the subject and that the subject would be committing a misdemeanor if he refused to sign, Dep Glenister informed the subject that the WCSO would not take any enforcement action if he chose not to sign. I researched that particular ordinance and discovered that there was an exemption for the ordinance, Section 6.02 Exemptions: Temporary signs for political candidacy.

I then responded to the scene and informed Burgess of what I discovered. Burgess then became agitated and stated that Murphy had told him that the signs were not of political nature. I looked at the signs and saw Trump 2020 on it. I then informed Burgess that the signs were of political nature and that it would fall under the sign exemption. 

The female subject that was with Mr. Murphy urged him to pack up and address it later to which he said ok. During our interaction Deputy Fernandez attempted to verify who at the Walton County Sheriff's Office gave them permission to be there. It was found they had only contacted dispatch to notify them they would be set up at this location. I walked back to my vehicle where I waited for compliance. A short time later Deputy Fernandez walked up to me and advised his supervisor Ssgt Glennister needed to speak with me. Sgt. Glennister asked for the code number I was refering to as he was unable to easily locate it. I guided him to the section under land development code that prohibited the signage. He questions the fact they were political signs. I informed Sgt Glennister that during our intercation Mr. Murphy informed me they were not political signs and he was covered by the First Amendment. I also informed Sgt Glennister the blockage of the multi-use path was another violation. A short time later Sgt Pullings arrived on scene and made contact with Mr. Murphy. After speaking with him Sgt Pullings approached my vehicle and informed me they had no business there due to this being a civil matter. I reminded Sgt Pullings that Florida State Statute 162 states if Mr. Murphy refuses to sign it is a misdemeanor. Sgt Pullings did not agree with my statement but said they would be logging his info and if it is found they are wrong they will send a warrant up for his arrest. I told Sgt Pullings I needed him to stand by while I attempted to issue Mr. Murphy a



Per our conversation, here is a synopsis of what occurred on incident 2020-00024377:

On 2-21-20, Dispatch informed me that a gentlemen by the name of Arthur Murphy contacted me regarding the incident. Murphy said he was displaying political signs in an effort to support the re-election of President Trump. Murphy stated that Code Enforcement Officer Buddy Burgess was going to issue him a citation for violation of Section 6.01.02 (No signs allowed on public property). I researched that particular ordinance and discovered that there was an exemption for the ordinance, Section 6.02 Exemptions: Temporary signs for political candidacy.

I then responded to the scene and informed Burgess of what I discovered. Burgess then became agitated and stated that Murphy had told him that the signs were not of political nature. I looked at the signs and saw Trump 2020 on it. I then informed Burgess that the signs were of political nature and that it would fall under the sign exemption. I then informed Burgess the Sheriff's Office would not get involved in this incident due to there being an exemption. Burgess began to yell at me and demanded I stay and enforce F.S. 162.21 which talks about individuals refusing to sign code enforcement citations. Burgess further stated that Murphy was blocking the crossway and walkway, which I determined that he was not.

I then walked over and spoke with Murphy. I explained to him that there was an exemption for political signs and that he was allowed to display them on the public right of way. I told Murphy that I was there simply to keep the peace. Burgess then issued a written warning and asked Murphy to move down the road a bit which Murphy complied.

McCabe informed me he simply asked for clarification on the reason for the citation and Burgess immediately began lecturing him on his duties and became argumentative.

The video provided corroborates McCabe's account of the incident. Burgess' attitude and demeanor throughout the video was extremely unprofessional and did not display the type of working relationships and interactions Deputy Sheriffs usually have with Code Enforcement Officers. This incident and behavior from Burgess is not the first negative encounter between members of the Walton County Sheriff's Office and Burgess. Burgess' repeated unprofessional behavior is creating a strain on the working relationship with Walton County Code Enforcement.


