Key Takeaways

- US Nationals will be held in Anaheim in 2024, expecting around 1200-1250 athletes.
- Budget for US Nationals was reviewed, aiming for \$5k profit through sponsorships.
- Qualifications for US Nationals were discussed athletes must qualify through national/international leagues or state/regional championships.
- The event will be US Nationals, not a World Cup. International athletes can participate but not win medals.
- Discussed having a US National team for each age category that competes at World Championships.
- Elite age cutoff was discussed, initial thoughts are around 16 years old minimum. More research is needed on the appropriate minimum age.
- Committees are encouraged to meet more independently to drive initiatives forward.

US Nationals 2024 Planning



- US Nationals will be held in Anaheim in 2024, expecting around 1200-1250 athletes (up from 800 last year).
- Reviewed budget for the event, targeting around \$5k profit through securing sponsorships.
- Registration revenue is expected to increase with more athletes. Additional costs were budgeted for photography packages, awards, production, etc.
- Collaborating with Ninja Master for customized features, confirming US citizenship, registration software, and scoring.
- Currently have 1030 athlete slots in the schedule, but can adjust wave sizes if needed.

US Nationals Qualifications

- Athletes must qualify through national/international leagues or state/regional championships.
- Seeking support from leagues to support the growth of the community, use proper safety standards, have SafeSport-certified staff, and share athlete qualification data.
- Qualification tracking will be based on name, birthdate, NinjaWorks ID, and whether they met the criteria to qualify.

World Cup or National Event

- Decided not to designate the event as a World Cup to avoid added complexity.
- Will be a US Nationals event, but open to international athletes to participate (not win medals).

US National Teams

- Discussed having a US National team for each age category that would compete at the World Championships.
- Athletes could qualify through performance at US Nationals, but the selection committee can also pick athletes outside of that event if needed.

Elite Age Cutoff

- For US Nationals, the initial plan was 15+ minimum age for the elite category.
- Had a community poll about potential minimum age, most responded favorably to 13 years old based on skill level.



- For selecting an Olympic team, one needs to consider the emotional readiness of young athletes. Research shows very early specialization can be detrimental.
- Discussed resources like interviews with former Olympians to gather perspectives on appropriate minimum age.
- For the 2024 event, we are open to further discussion.

Committee Organization

- Encouraged committees to meet independently and drive initiatives forward.
- Board meetings can then be more efficient status updates rather than initial discussions.
- Committees should recruit broad representation and tackle topics through pre-work and consensus.

Next Steps:

- Publish initial schedule for 2024 US Nationals
- Continue qualification criteria planning
- Committees to set up regular meetings and advance goals
- Further develop elite age cutoff policy with research
- Website updates as needed (committees, etc)
- Next meeting will be determined after committees establish a regular meeting schedule.
