NOTICE IS HEREBY GIVEN, that declaration of candidacy for the office of School Board Trustees of the Bliss School District #234, Trustee Zone II

Description: **BEGINNING** at the intersection of U.S. Highway 30 and 2nd Avenue, thence Northerly along 2nd Avenue to Kentucky Street, thence Westerly along Kentucky Street to 1st Avenue, thence Northerly along 1st Avenue turning into Clover Creek Road, thence Northerly along Clover Creek Road to Iowa Street and the North Bliss City Limits Line, thence along said City Limits Line the following 5 courses: Westerly approximately 0.25 miles, thence Southerly approximately 750 feet, thence Westerly approximately 0.25 miles, thence Southerly approximately 0.5 miles, thence Easterly approximately 0.5 miles to River Road, thence leaving said City Limits Line Northerly along River Road to Clover Creek (1st Avenue), thence Northeasterly along Clover Creek (1st Avenue) to US Highway 30, thence Southeasterly along US Highway 30 to 2nd Avenue and the **POINT OF BEGINNING**.

And Bliss School District #234, Trustee Zone IV

Description: **BEGINNING** at the intersection of 2100 South and 1200 East which is near the Northeast Corner of Section 24, Township 6 South, Range 13 East, B.M., thence Westerly along 2100 South approximately 2 miles to Interstate 84, thence Northwesterly along Interstate 84 approximately 1 mile to Z Canal, thence Southwesterly along Z Canal approximately 120 feet to Frontage Road, thence Northwesterly along Frontage Road approximately 0.55 miles to 2000 South, thence Westerly on 2000 South to U.S. Highway 30, thence Southeasterly along U.S. Highway 30 approximately 3.5 miles to River Road, thence Northwesterly along River Road to Bliss Grade Road, thence Northwesterly along Bliss Grade Road approximately 0.55 miles to an unnamed drainage, thence Southwesterly along said unnamed drainage approximately 750 feet to the Snake River, thence Northwesterly along Snake River to Shoestring Road, thence Southwesterly along Shoestring Road approximately 0.4 miles to a point on the South School District Boundary said point being approximately 270 feet Northeast of the intersection of Shoestring Road, King Hill Canal Road and Serenity Lane, thence Southeasterly then Easterly then Northeasterly then Northerly along School District Boundary to 2100 South and 1200 East which is near the Northeast Corner of Section 24, Township 6 South, Range 13 East, B.M being the **POINT OF BEGINNING**

And Bliss School District #234, Trustee Zone V

Description: **BEGINNING** at the intersection of 2100 South and 1200 East which is near the Northeast Corner of Section 24, Township 6 South, Range 13 East, B.M., thence Westerly along 2100 South to Interstate 84, thence Northwesterly along Interstate 84 to U.S. Highway 30, thence Westerly along said Highway 30 to 2nd Avenue Northerly along 2nd Avenue to Kentucky Street, thence Westerly along Kentucky Street to Clover Creek Avenue (1st Avenue), thence Northerly along Clover Creek Avenue (1st Avenue) to the Union Pacific Railroad, thence Easterly along the Union Pacific Railroad approximately 0.55 miles to an angle point, said point is approximately 200 feet east of Interstate 84 (US Highway 26), thence Northwesterly approximately 580 feet to 750 East, thence Northerly along 750 East and its northerly extension approximately 0.9 miles to the Northeast corner of the Southeast ¼ of the Southwest ¼ of Section 32, Township 5 South, Range 13 East, B.M., thence Westerly meandering along the edge of a field and an unnamed road


approximately 0.6 miles to Clover Creek Road (Hill City Road), thence Northwesterly along Clover Creek Road (Hill City Road) approximately 13 miles to unnamed two track road located in the Northeast $\frac{1}{4}$ of the Northeast $\frac{1}{4}$ of Section 5, Township 4 South, Range 13 East, B.M., thence Easterly along unnamed two track road approximately 2.3 miles to Clover Creek and the East School District Boundary, thence Southerly along School District Boundary to 2100 South and 1200 East which is near the Northeast Corner of Section 24, Township 6 South, Range 13 East, B.M and the **POINT OF BEGINNING**.
