MEMORIAL DAY OR VETERANS DAY EXPENSES

Act of 1925, P. L. 75

Section 1. Be it entacted, etc., That the respective authorities of the several counties, cities, boroughs, and incorporated towns of this Commonwealth are hereby, authorized to appropriate annually to each camp of the United Spanish War Veterans, and to each post of the American Legion, and to each post of the Veterans of Foreign Wars, and to each Naval Association, and to each post of the Grand Army of the Republic, and to each post of the Disabled American Veterans of the World War, and to each organization of ex-service men, incorporated under the act of April twenty-ninth, one thousand eight hundred and seventy-four and the supplements thereto in the respective counties or towns, a sum not to exceed two hundred dollars, to aid in defraying the expenses of Memorial Day and Veterans Day. Such payments shall be made to defray actual expenses only. Before any payment is made the organization receiving the same shall submit verified accounts of their expenditures.
