## Documents:

### **Must be Original – Photo Copies ARE NOT ACCEPTED**

Current Michigan Driver's License, If you have a temporary paper license you must have a current GOVERNMENT ISSUED PHOTO ID

Current Temporary Instructional Permit- Eligibility Date is indicated on the permit

**Must Have:** Current Registration for truck (and trailer) and Current Proof of Insurance

**Equipment Failure-** Applicants should verify equipment meets the standard requirements such as GVWR. If the vehicle does NOT meet the standard requirements and cannot be used for testing purposes, you will NOT be refunded.

**Banked Test Portions:** If an applicant passes the vehicle inspection or basic skills test it will be considered banked for the duration of the Current Temporary Instruction Permit, banked tests expire with permit and if permit is replaced.

**Test Duration:** Each Class A FULL test is scheduled for 2 hours. If you do not complete the test within 2 hours, you will need to schedule a new test for the portions not completed and charged a fee for the additional test. This allows for additional testing to continue in a timely manner.

1. Cancellation Fee: Test must be canceled 2 business days prior to test the date.
2. Equipment Fee: Trucks and/or Trailers can NOT have a load
3. Late Fee: 15 min late or more, the test will be cancelled and charged
4. Using our vehicle is under all rental agreements for insurance purposes.
5. You are responsible for and liable for any damages while renting Bert's Testing & Training Vehicles. **\*No electronic devices permitted during test\***
