**\*2 - 16** Minute Halves - Running Clock - Clock stops for time-outs & Last two minutes of **EACH HALF.**

**TO's: 3-30 Second T.O.'s per game - 1 Additional T.O. for each Overtime (no carryovers)**

Technical Fouls: Automatic 2 points and ball out of bounds

Fouls: 7th team foul is bonus, 10th team foul double bonus. 5th player foul is disqualified.

OT Rules: 2 Minutes - Clock Stops. Double OT: Sudden Death - first point wins.


Boy's 7th-8th = Use 29.5 Ball | Boys 6th and below = Home Team or Higher Seed (seed on bracket day) will choose which ball to play with 29.5 or 28.5. If same seed, different pools. Home Team will choose the game ball.
