GAME RULES GENERAL FORMAT

*2 - 16 Minute Halves - Running Clock - Clock stops for time-outs & Last two minutes of EACH HALF.

TO's: 3-30 Second T.O.'s per game - 1 Additional T.O. for each Overtime (no carryovers)

Technical Fouls: Automatic 2 points and ball out of bounds

Fouls: 7th team foul is bonus, 10th team foul double bonus. 5th player foul is disqualified.

OT Rules: 2 Minutes - Clock Stops. Double OT: Sudden Death - first point wins.

Boy's 7th-8th - Use 29.5 Ball; Boys 6th and below Home Team or Higher Seed (seed on bracket day) will provide the game ball.
