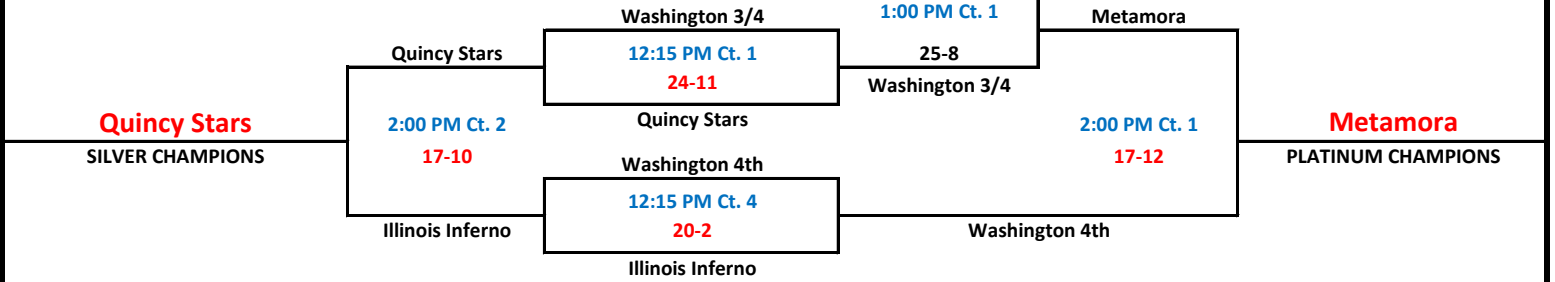

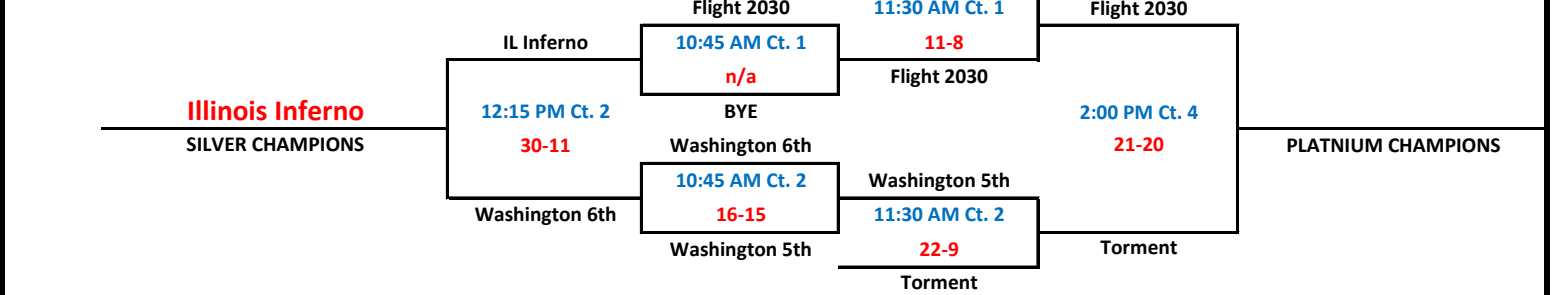

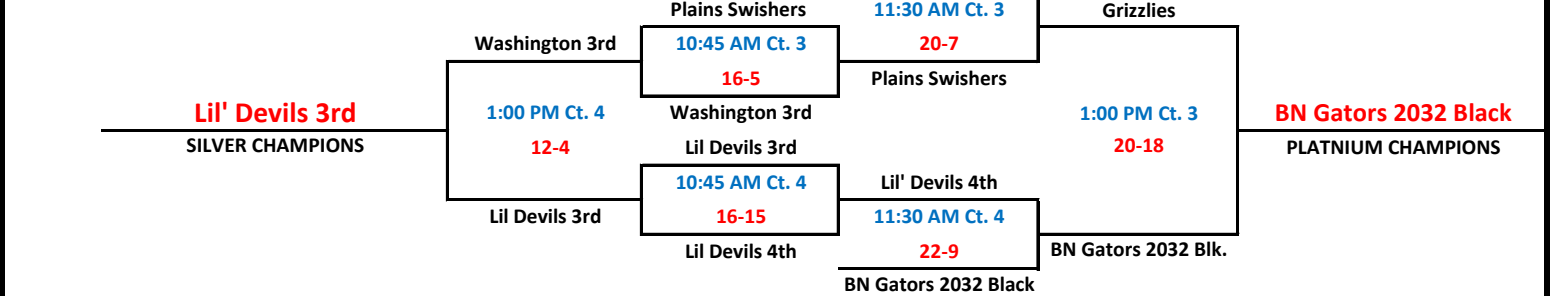

Top Bracket is the Home Team



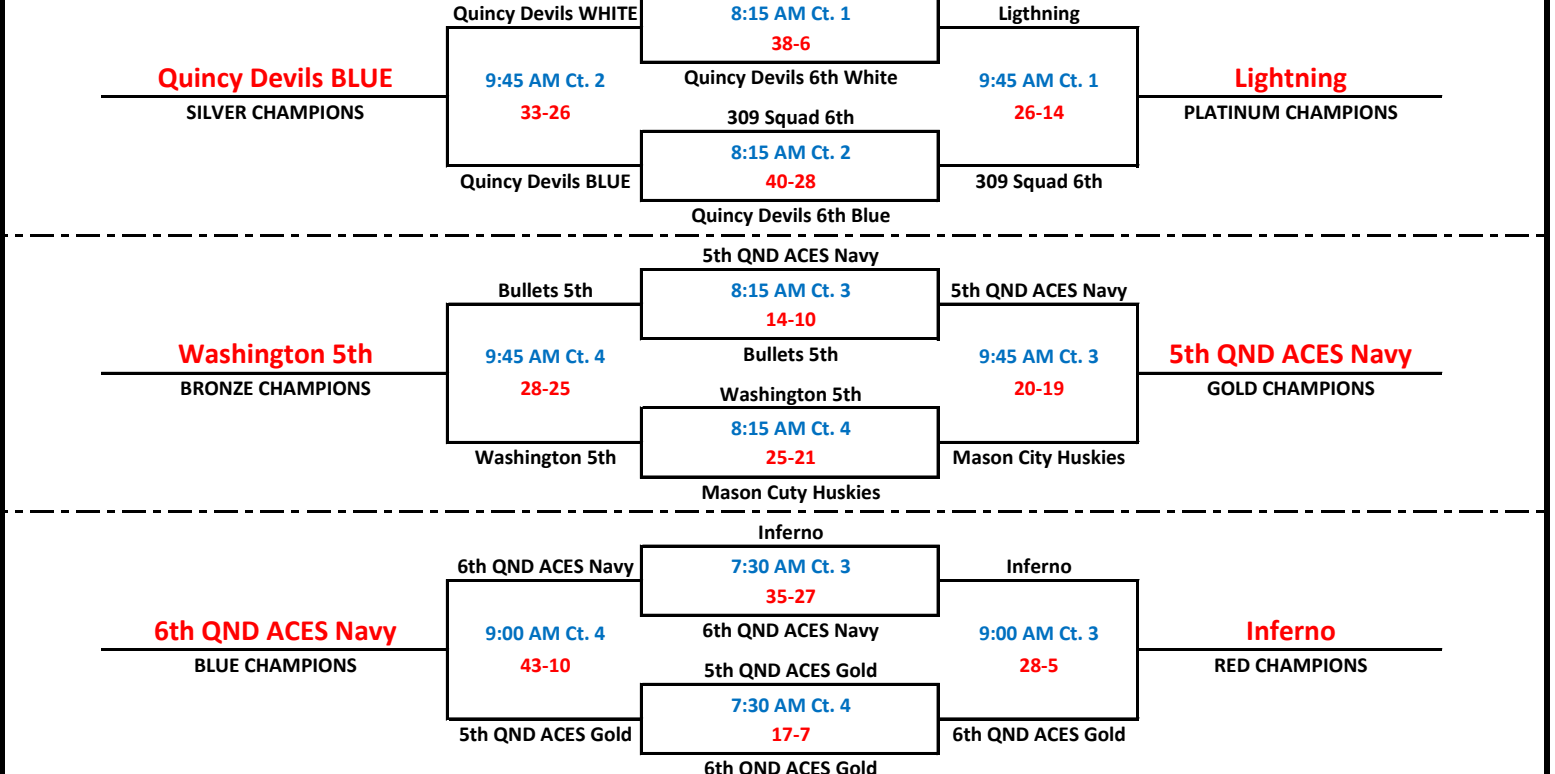

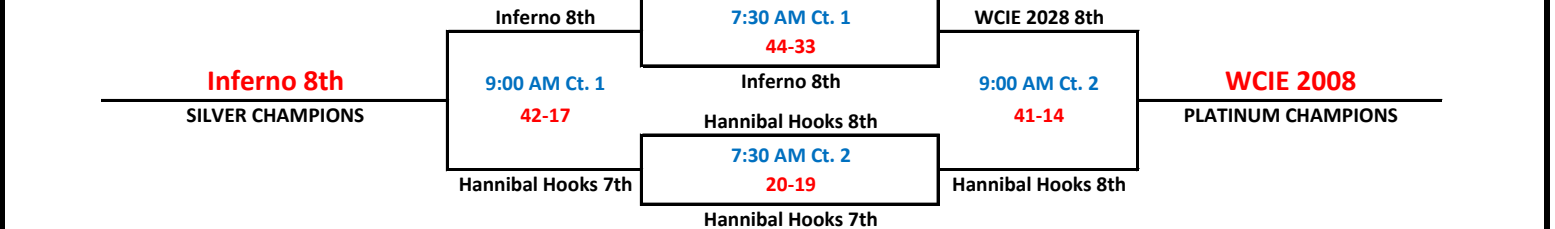
