ORDER

Upon review and consideration of the Application of Plaintiffs' Co-Lead Class Counsel for Award of Limited Attorney's Fees, and for Approval of Certain Out-of-Pocket Costs and Expenses and Incentive Awards For Class Representatives ("Plaintiffs' Application"), including all affidavits attached thereto; and the appearance by Counsel for all Parties before this Court on April 29, 2019,

IT IS HEREBY ORDERED, ADJUDGED and DECREED as follows:

1. An award of \$275,006.67 shall be made from the Settlement Fund to Dan B. McKay, Jr. Esq. for his attorney's fees in this matter;
2. An award of \$776,753.00 shall be made from the Settlement Fund to Co-Lead Class Counsel, to reimburse all Plaintiffs' counsel their costs from this matter as detailed in Plaintiffs' Application;
3. An amount of up to \$100,000.00 shall be made available from the Settlement Fund to cover additional administration expenses incurred after March 21, 2019 and prior to the submission of the motion for approval of the final plan of distribution, which amounts will be paid by Rust Consulting with the approval of Co-Lead Class Counsel and without further leave of Court; and
4. Awards to Class Representatives from the Settlement Fund shall be made as follows:
 - a. Robert Sparks: \$25,000
 - b. Jimmie Nell Lewis: \$25,000
 - c. Robert Wagner: \$25,000
 - d. Patricia DeWitt: \$10,000
 - e. Sylvia Lemoine: \$10,000

f. Narcelle LaCombe: \$10,000


