"Children" or "Child" means any user under the age of 13

ARE YOU UNDER 13 OR RESPONSIBLE FOR AN UNDER-13-YEAR-OLD?

SET LIMITS

WE DON'T WANT MORE PERSONAL INFORMATION

If you're under 13 years old, we will only ask you to create an email and password combination, which will be safely stored in our database. Parents and guardians should supervise their child during this process.

When users publish anything in our public and comment areas (for example: chat, forums, group walls, personal post) we will filter it and remove personal information, attempts at phishing, offensive words, or any adult content.

PLEASE ASK US IF YOU WANT TO MAKE PRIVACY RELATED CHANGES

You can request that City Swipe make changes to your child's account or allow you to review, delete, or prevent the further collection or use of personal information from you and your child. To make a request, please contact us.

WHEN WE COLLECT YOUR INFORMATION

Your first step to joining the City Swipe experience is to set up a City Swipe account.

We will ask you to create a unique username and password so that you can log in to your account and access features on City Swipe. You do not have to use your own personal email or any personal information while creating your user account, but you do have to pick an email and password combination that you will need to remember. Everytime you want to play City Swipe, you will have to login. We store your email and password in our database to help with account recovery and technical issues. We do not share your information, and we have established measures to keep your information secure. No usage data is collected when using this service.

RETENTION OF YOUR PERSONAL DATA

This company will not retain usage data for internal analysis purposes. The Funshark Company will not retain any personal data other than login information.
