EVV does not take the place of a time sheet for payroll, it is in addition to the time sheet and both must be used to be paid correctly. Soft launch for EVV starts 11/2/2020, which means that EVV is to be used as of 11/2/2020.

Please read the options below for EVV and discuss with your worker(s) which option works. If you have more than 1 worker and need more than one option, please indicate that on the back side of this form.

- Mobile phone application (mobile visit verification [MVV]): This option allows the worker to record visits using a smart phone or tablet, even when no cellular, satellite, or other data services are available at the service location.
- Landline phone (telephonic visit verification [TVV]): This option allows the worker to record visits via a landline phone at the service location/member's home using a toll-free phone number.
- EVV digital device (fixed visit verification [FVV]): This option allows the worker to record visits with a small electronic device. The device, which is secured to a surface in the member or participant's home, provides a code that links the time and date the services are provided to the client and service location. The visit information then needs to be submitted by the worker(s) via a phone to the Sandata program. FVV is the option of last resort and may only be requested if certain criteria are met.

A valid email address for each of your workers is required for EVV by DHS. We will need this information and on the other side of this document there is a place for you to indicate the email address of your worker and we also will be asking your worker for the same information.
