**AFFIDAVIT FOR WARRANT OF ARREST AND DETENTION**

The Undersigned Affiant, who after being duly sworn by me, on oath, makes the following statement:

I have good reason to believe and do believe that

**FIERAMUSCA, MAGEN ROSE WHITIE / FEMALE DOB: 01/13/1986**

on or about December 12, 2019 Austin, Travis County, Texas, did then and there commit the offense of:

**TAMPERING WITH A CORPSE - SECOND DEGREE FELONY**

1. Your Affiant, Detective B. Herries #5641, is an investigator assigned to the Austin Police Department Cold Case/Missing Person Unit. As a result of this assignment, your Affiant is responsible for investigating incidents involving missing persons and persons who have been taken or held against their will, which is commonly referred to by the offense title code: Kidnapping.
2. On Tuesday December 12, 2019, your Affiant was operating in an "on-call" status and received a message to contact Austin Police Department (APD) Officer Parker 8425 regarding case number 19-3461485. Upon making contact with Officer Parker, your affiant was told the following: Officer Parker had been dispatched to a call for service regarding a missing adult female, Heidi Broussard, a White Female, born 6/15/1986 and her two week old newborn, who is fully identified in Austin Police Department report 19-3461485, and will hereafter be referred to as her "Newborn Child". The complainant was Shane Carey, who is the boyfriend of Heidi, with whom they share two children, Newborn Child and a six year old child. Shane Carey, Heidi Broussard, and both children live together in an apartment at 744 West William Cannon Drive, in Austin, Travis County, Texas.
3. Shane Carey has cooperated with the Austin Police Department in investigating the disappearance of Heidi Broussard and her Newborn Child. Shane Carey provided an initial statement to Austin Police Detectives Brad Herries and Ryan Metcalf on Friday, December 13, 2019, at the Austin Police Department South Substation. That conversation was voluntary in nature and was recorded using a fixed digital audio and video recording system. Shane Carey spoke with Detective B. Herries of the Austin Police Department, Detective R. Metcalf of the Austin Police Department, Detective R. Faithful of the Austin Police Department, and Special Agent J. Baillie of the FBI during the continuing investigation. The conversations were collected on Body Worn Cameras or fixed digital audio and video recording systems in interview rooms.

4. Shane Carey stated that he last saw Heidi Broussard and the Newborn Child in person that day, December 12, 2019, at approximately 6:30AM. Shane Carey woke for work and saw Heidi and the children before he left for work at a moving company in North Austin. Shane Carey advised that Heidi Broussard would ready the children for the day, then take the six year old child to school at Cowan Elementary, 2817 Kentish Drive, Austin, Texas. I reviewed images captured by surveillance cameras at Cowan Elementary. Heidi Broussard can be seen entering and exiting the school on surveillance cameras provided by the Austin Independent School District with the Newborn Child. Based on video evidence, Heidi Broussard left the school at approximately 8:12AM with the Newborn Child.
5. Shane Carey and Heidi Broussard spoke on the phone at approximately 8:30AM regarding dropping the child off at school, a conversation that was confirmed by a consent search of Shane Carey's phone. Shane Carey stated that he did not speak with Heidi Broussard the rest of his workday. Shane Carey got off work at approximately 1:50PM and called Heidi Broussard. The phone call was not answered and went to voicemail.
6. Shane Carey arrived in the parking lot of their apartment complex at 744 West William Cannon at approximately 2:50 PM on December 12, 2019. Shane Carey noticed that Heidi Broussard's vehicle, a white 2012 Honda Fit bearing Texas License Plate [REDACTED], was parked in the parking lot of their apartment complex. Shane Carey found the front door to their apartment to be unlocked. Shane Carey stated that it was not unusual for the front door to be unlocked. Shane Carey stated that the apartment was not in disarray and that nothing inside the apartment appeared to be out of the ordinary. Neither Heidi Broussard nor the Newborn Child were in the apartment according to Shane Carey. Shane Carey believed that Heidi Broussard and the Newborn Child were possibly visiting another apartment in the complex or were at the park. Shane Carey realized as the day progressed that their elementary age child needed to be picked up from afterschool activities. Shane Carey went to pick the child up at approximately 5:50PM, thinking that Heidi Broussard would be there, as well. Shane Carey waited until after 6:00PM; Heidi Broussard did not arrive to pick up their child.
7. Shane Carey returned to the apartment with their elementary age child. Neither Heidi Broussard nor the Newborn Child were at the apartment. Shane Carey went to Heidi Broussard's 2012 Honda Fit bearing Texas License Plate [REDACTED] was in the parking lot of their apartment complex and found the vehicle to be unlocked. Shane Carey stated that it was unusual to him that the vehicle was unlocked. Shane Carey looked inside the vehicle and observed Heidi Broussard's red purse inside the unlocked vehicle. Shane Carey looked inside the purse and observed Heidi Broussard's wallet. All personal items, cash, credit cards, debit cards, and identification appeared to still be present inside the wallet.
8. Shane Carey stated that the Newborn Child had jaundice when discharged from the hospital. Shane Carey stated that he and Heidi Broussard had to supplement breast milk with formula due to the jaundice.
9. All necessities for caring for a newborn child remain in the apartment, including, but not limited to diapers, formula, clothing, wipes, bedding, car safety seating, and accessories. All apparent forms of financial means for Heidi Broussard appear to be inside Heidi Broussard's wallet, which was left in her vehicle. The only items of note missing from the apartment or vehicle are Heidi's iPhone 11 with telephone number (512) 214-5815 and her keys.

10. Shane Carey described Heidi Broussard's iPhone 11 as being black in color and was contained in a case with red, white, and blue colors in a tie dye pattern.
11. Shane Carey described Heidi Broussard's keys as 3-4 keys on a key ring with a Honda chip enabled car key and one key on the ring with blue tape.
12. The location of Heidi Broussard is unknown at this time. At the time of her disappearance, Heidi Broussard did not take the necessary items to reasonably care for a two week old newborn for an extended period of time when she departed the apartment. Heidi Broussard does not possess the necessary items to reasonably and legally travel inside a vehicle with a two week old newborn, such as an infant car seat and base. It is of note that both car seats possessed by Shane Carey and Heidi Broussard are in the apartment or Heidi Broussard's vehicle. Shane Carey stated that Heidi Broussard would not abandon her family, especially her elementary aged child. On December 17, 2019, I spoke with V.S., an adult female fully identified in Austin Police Report 19-3461485. V.S. has known Heidi Broussard for approximately 10 years. V.S. stated that Heidi Broussard would not abandon her elementary aged child.
13. Shane Carey began to call friends and family in the area to attempt to locate Heidi Broussard and the Newborn Child without success on December 12, 2019. Shane Carey called the Austin Police Department at approximately 7:31PM to report Heidi Broussard and the Newborn Child as missing. Responding Austin Police Officers conducted a deliberate search of the area of the apartment, contacted members of Heidi Broussard's family and friend group, conducted a "Reverse 911," calling over 4000 residences in the immediate area of the apartment, and released the names and images of Heidi Broussard and the Newborn Child to the media, all without locating Heidi Broussard nor her Newborn Child.
14. Your Affiant researched the Target Number, (512) 214-5815, belonging to Heidi Broussard through "Zetx.com" which is an online tool that will identify the carrier and registered name associated with the phone number. The Target Number was registered to Shane Carey. The service provider for the phone T-Mobile. Your Affiant contacted the Law Enforcement Liaison for T-Mobile and confirmed that T-Mobile does currently provide service for the target number and that the phone was currently showing to be on and active. Per T-Mobile policy your Affiant was directed to complete the "T-Mobile Exigent Form" and return the completed form to T-Mobile. Your Affiant completed and submitted the form to T-Mobile. A Surveillance Order with an Emergent Addendum was sworn to by the Affiant and was presented to Travis County District Court Judge J. Kocurek. Judge Kocurek reviewed the Order and approved the document with her signature.
15. An emergency ping of Heidi Broussard's phone number, (512) 214-5815, began at approximately 4:56 PM on Friday, December 13, 2019, and ran continuously for 48 hours until the afternoon of Sunday, December 15, 2019. The continuous ping of Heidi Broussard's phone was requested to indicate any location data associated with the use of the cellular device. The data was updated and sent at fifteen minute intervals for 48 hours. There was no location data reported for the 48 hours of the requested emergency ping, indicating that the target phone was not in use.
16. According to Shane Carey, Magen Fieramusca (also known as Maygen Humphrey) and Heidi Broussard have been friends since attending the Texas Bible Institute in Columbus,

Texas, approximately 10 years ago. Magen Fieramusca and Heidi Broussard speak on the phone regularly.

17. According to Shane Carey, Magen Fieramusca and Heidi Broussard became pregnant around the same time in 2019. Both expectant mothers were due in late 2019. Shane Carey stated that he saw Magen Fieramusca visibly pregnant in person. Magen Fieramusca held her hands to her apparently pregnant stomach, appearing to support the weight of her unborn child. Shane Carey reported that Heidi Broussard and Magen Fieramusca had spoken about the possibility of delivering on the same date.
18. On November 25, 2019, Heidi Broussard's water broke early in the morning. Shane Carey and Heidi Broussard went to St. David's South Austin Hospital for medical treatment in anticipation of childbirth. Magen Fieramusca was alerted to the impending delivery.
19. On November 26, 2019, Magen Fieramusca drove from her home in the Houston, Texas, area to South Austin while she herself was approximately 37 weeks pregnant. The afternoon of November 26, 2019, Heidi Broussard and Shane Carey gave Magen Fieramusca a key to Heidi Broussard and Shane Carey's apartment from Heidi's keyring.
20. Austin Police Officers Levine and Wind spoke with S.D., a nurse at St. David's South Austin Hospital, who is fully identified in Austin Police Report 19-3461485. Nurse S.D. overheard Heidi Broussard and Magen Fieramusca conversing about Magen Fieramusca being 37 weeks pregnant.
21. Shane Carey reported that Heidi Broussard delivered her Newborn Child on November 26, 2019. The following people were in the room when Heidi Broussard delivered her Newborn Child: Shane Carey, V. S. (an adult female fully identified in Austin Police Report 19-3461485), and Magen Fieramusca. Additional family members entered the room after the birth. The Newborn Child was first held by Heidi Broussard, then by Shane Carey, then by V.S., then by Shane Carey's father (an adult male fully identified in Austin Police Report 19-3461485). Immediately after Shane Carey's father was handed his grandchild, Magen Fieramusca interjected herself and asked to hold the Newborn Child, stating that she had to leave. Shane Carey's father was surprised by the actions of Magen Fieramusca and that his first introduction and time with his grandchild was interrupted by a friend of Heidi's.
22. Magen Fieramusca told Shane Carey that she would leave the key to their apartment on the counter inside the apartment. Shane Carey advised that neither he nor Heidi Broussard could ever locate the key Magen Fieramusca was given to have access to their apartment.
23. Magen Fieramusca left the hospital no more than one hour after Heidi Broussard delivered her baby and returned to Heidi Broussard and Shane Carey's apartment, where she stayed until November 27, 2019, when she returned to Houston, Texas. Magen Fieramusca drives a gray 2015 Nissan four door bearing Texas License Plate [REDACTED].
24. I reviewed a search of Learn Vigilant's License Plate Online Registry which shows that Magen Fieramusca's 2015 Nissan four door bearing Texas License Plate [REDACTED] was captured on stationary license plate reader operated by the Giddings, Texas Police Department traveling between Houston and Austin. The data confirms that the vehicle operated by Magen Fieramusca was traveling in the direction of Austin on November 26, 2019.

25. Shane Carey reported that on December 8 or 9, 2019, he learned from Heidi Broussard that Magen Fieramusca delivered a baby girl. Shane Carey did not see any photographs of the child.
26. A resident of 744 W. William Cannon Drive, the same complex in which Heidi Broussard and Shane Carey live, has installed video cameras on the exterior of his residence. The tenant of the apartment with the exterior cameras provided voluntary consent for Austin Police Detective D. Hruzek to view the recordings from the exterior cameras. One of the cameras captures the parking lot and has the capability of capturing vehicles as they pass in the parking lot. Video captured on the exterior cameras shows a light colored four door vehicle with the outline, window placement, and general appearance consistent with Magen Fieramusca's gray 2015 Nissan four door bearing Texas License Plate [REDACTED] driving northbound towards the rear of the complex at approximately 9:05 AM on December 12, 2019. Shane Carey and Heidi Broussard's apartment is on the rear of the complex.
27. On December 18, 2019, M.W., an adult female fully identified in Austin Police Report 19-3461485 provided a statement to Detectives Mireles and Briegel. The statement was captured on a fixed audio and video recording system. M.W. stated that on December 11 or 12, 2019, she was driving through the rear of the complex at 744 West William Cannon. M.W. stated that she saw a four door vehicle, believed to be light in color stopped in the parking lot perpendicular to the provided parking spaces. M.W. stated that she saw a white adult female walk from between buildings 7 and 8 towards the vehicle parked perpendicular to the provided parking spaces. The adult white female was carrying a small infant who was wearing a knit cap. The adult female carrying the small infant walked towards the vehicle parked perpendicular to the provided parking spaces. M.W. saw a female exit the front passenger seat and greet the adult female who was carrying the small infant. The front seat passenger opened the rear passenger side door of the vehicle, the adult female carrying the small infant entered the rear passenger seat, both doors closed, and the vehicle drove away. M.W. stated that there was not time for the adult female to secure the infant into any type of child restraint system before the vehicle drove away. M.W. turned from the main lane of the parking lot and last saw the four door vehicle driving towards the exit gate to South First.
28. On December 19, 2019, M.W. returned to the Austin Police South Substation and was presented a photo lineup. The photo lineup was prepared by Detective D. Mireles. The photo lineup featured six images of females, one of which was Magen Fieramusca. The females were all of a similar complexion and none of the females stood out of the lineup.
29. The photo lineup was presented to M.W. by Detective Mitchell 4523. When M.W. saw the photo of Magen Fieramusca, she stated that she was 60 to 70 percent sure that was the female she saw in the front seat of the vehicle in the parking lot of 744 West William Cannon.
30. Shane Carey told Detective Faithful that he believed Heidi Broussard was friends with Magen Fieramusca. Shane Carey provided a cell phone number for Magen Fieramusca from his cell phone: (346) 201-1801. This number was determined to be serviced by T-Mobile. On December 18, 2019, Intelligence Analyst Ferguson of the FBI conducted open source research related to any social media presence for Magen Fieramusca. A search of Heidi Broussard's contacts on Instagram revealed an Instagram account for user "maygenhumphrey."

31. On December 18, 2019, IA Ferguson obtained records for Instagram user "maygenhumphrey" via a Voluntary Emergency Disclosure. This record indicated the account was registered using email address maygenhumphrey@gmail.com. The account had been active for an extended period of time and contained no posts. Further social media research into Maygen Humphrey, possibly known as Magen Fieramusca, yielded at least one photo on the Facebook profile of Heidi Broussard depicting the Heidi Broussard and a white female who appeared to be tagged at one time as Maygen Humphrey. The white female identified in the photo as Maygen Humphrey was visually similar to the known Texas Driver's License photo of Magen Fieramusca.
32. On December 18, 2019, IA Ferguson requested records from Google, Inc. related to email address maygenhumphrey@gmail.com via Voluntary Emergency Disclosure. A review of the search history for maygenhumphrey@gmail.com identified a Google search for "reasons for Amber Alert" performed on December 12, 2019, at 10:31 PM CST. To date, an official Amber Alert for the Newborn Child has not been released via Austin Police Department or Texas Department of Public Safety.
33. A Google search was performed for "Amber alert issued Austin" by maygenhumphrey@gmail.com on December 12, 2019, at 10:42 PM CST. A result of this search, located at URL <https://rare.us/rare-news/police-issue-amber-alert-for-3-week-old-baby-last-seen-at-austin-hospital/amp/>, was visited on December 12, 2019 at 10:42 PM CST.
34. A full review of searches performed by maygenhumphrey@gmail.com between November 11, 2019 and December 18, 2019 revealed some form of "Heidi Broussard" was searched at least 162 times from a device utilizing the account maygenhumphrey@gmail.com.
35. On December 14, 2019, a search was conducted using the account maygenhumphrey@gmail.com for the words "bodies found in Austin Texas."
36. A follow-on request via Voluntary Emergency Disclosure for any Facebook or Instagram accounts related to email address maygenhumphrey@gmail.com resulted in the identification of Facebook UID 1422693164, vanity name MAYGEN.HUMPHREY. This account was active from 2008 until the account was terminated or deactivated on December 17, 2019 at 9:09 PM CST. IP address history from the account resolved to T-Mobile.
37. Members of the FBI Behavioral Unit have been included on numerous investigative briefs and summaries related to the disappearance of Heidi Broussard and her Newborn Child. The totality of the interactions and events related to Magen Fieramusca, including traveling to another city late into a pregnancy, the interaction with Shane Carey's father the first time he held his grandchild, the image of a vehicle consistent with the vehicle operated by Magen Fieramusca, and the deletion of Magen Fieramusca Facebook account were analyzed by FBI Behavioral Unit Members, who advised that the situations and scenarios described are indicative of a female perpetrator of child abduction.
38. Research conducted by the FBI indicated that Magen Fieramusca resided at 8118 Bo Jack Drive, Houston, Texas 77040.

39. Shane Carey told Detective Faithful that Magen Fieramusca's boyfriend was named Christopher Green, who also resides at 8118 Bo Jack Drive, Houston, Texas 77040.
40. A search warrant for the Call Detail Records associated with Magen Fieramusca's T-Mobile phone number (346) 201-1801 was prepared and was presented to Travis County District Court Judge B. Urrutia on December 19, 2019. Judge Urrutia signed the search warrant.
41. The signed search warrant for Call Detail Records associated with Magen Fieramusca's T-Mobile phone number (346) 201-1801 were submitted to T-Mobile. T-Mobile provided data which provided historical location data for the phone number associated with Magen Fieramusca's phone.
42. Historical location data for Magen Fieramusca's phone show the device traveling from Houston to the Austin area on November 26, 2019, which is consistent with statements that placed her at St. David's South Austin Hospital for the birth of Heidi Broussard's newborn child. Historical location data for the device associated with Magen Fieramusca's phone show the device in the Austin area on November 26 and 27, 2019.
43. Supervisory Special Agent Mullen of the FBI conducted a preliminary historical analysis of the data provided by T-Mobile. Historical location data for the device associated with Magen Fieramusca's phone show the device located in the Austin area near Heidi Broussard and Shane Carey's apartment on December 12, 2019, the same day Heidi Broussard and her Newborn Child disappeared.
44. On December 19, 2019, FBI Agents and Texas Department of Public Safety Investigators were conducting surveillance of Magen Fieramusca and Christopher Green's residence, 8118 Bo Jack Drive, Houston, Texas. Texas DPS deployed a helicopter for aerial observation. The operator of the DPS helicopter observed a vehicle parked in the back yard of the residence between the garage and the residence. The vehicle was parked in a manner consistent with an attempt to conceal the vehicle from public view. The vehicle was later confirmed as a gray 2015 Nissan Versa four door, bearing Texas License Plate [REDACTED].
45. FBI Agents reported that Christopher Green left the residence in a black Nissan Armada SUV on Thursday, December 19, 2019. Christopher Green drove to a Target store. DPS Investigators observed Christopher Green shopping for baby clothes and saw Christopher Green purchase baby formula inside the store. Texas DPS Investigators spoke with Christopher Green as he exited the store.
46. Texas Ranger Cristian provided a summary of the conversation with Christopher Green. Christopher Green informed DPS Investigators that he was in a relationship with Magen Fieramusca since 2016. Christopher Green and Magen Fieramusca live together at 8118 Bo Jack Drive, Houston, Texas. Christopher Green and Magen Fieramusca broke up in March 2019, however, both parties remained in the residence.
47. Christopher Green reported in the spring of 2019 that Magen Fieramusca was pregnant. Christopher Green stated that he noticed that Magen Fieramusca's stomach grew during the year. Christopher Green indicated that he felt her stomach, which he described as hard. Christopher Green stated that he never saw Magen Fieramusca's bare stomach during the pregnancy, stating that their relationship during the year did not lend itself to

seeing her in stages of undress. Christopher Green believed that Magen Fieramusca was pregnant with his child.

48. Texas Ranger Rainwater spoke with Christopher Green. Ranger Rainwater showed Christopher Green a flyer produced by the Nation Center for Missing and Exploited Children featuring images provided by your affiant of Heidi Broussard and her Newborn Child.
49. Christopher Green looked at the flyer, looked at the picture of Heidi Broussard's Newborn Child on the flyer, and stated, "That's the baby at my house."
50. FBI Agents were notified of the conversation with Christopher Green and the purchase of baby formula. FBI Agents and DPS Investigators observed Magen Fieramusca walk out the front door of 8118 Bo Jack Drive, Houston, Texas with her cell phone and a baby monitor.
51. Texas Ranger Gary Phillips spoke with Magen Fieramusca, who stated that on December 12, 2019, Magen Fieramusca left to go to the beach with a cousin while Christopher Green stayed in Houston working. When Christopher Green saw Magen Fieramusca next on Friday, December 13, 2019, Magen Fieramusca told Christopher Green, "Don't be mad, don't be mad." Christopher Green asked why he would be mad. Magen Fieramusca told Christopher Green that there was a baby on the bed. Magen Fieramusca said that she went into labor and delivered their baby without Christopher Green's knowledge.
52. Magen Fieramusca told Ranger Phillips that she went into labor on Thursday, December 12, 2019. Magen Fieramusca stated that she went to a birthing center in The Woodlands. Magen Fieramusca could not remember the name of the birthing center in which she reported giving birth. Magen Fieramusca stated that the only people present during the delivery were employees of the "birthing center." Magen Fieramusca told Ranger Phillips that she brought the baby home on Thursday, December 12, 2019. Ranger Phillips confronted Magen Fieramusca about the discrepancy about her location on the date she reportedly delivered; Magen Fieramusca stated that she was not in Austin.
53. Members of the FBI Behavioral Analysis Unit provided an assessment of Maternal Desire, specifically, that mothers have lost a pregnancy or have falsified pregnancy and have materialize the desire to have a child by taking possession of another child.
54. Shane Carey previously reported that the Newborn Child had jaundice when discharged from the hospital.
55. A physician consulted by the FBI advised that untreated severe jaundice can cause a condition called kernicterus, which is a type of brain damage.
56. Christopher Green was purchasing formula, which Shane Carey said was necessary to treat the Newborn Child's jaundice.
57. Due to the unknown status of the treatment of the Newborn Child's jaundice, which could lead to brain damage if untreated, members of the Texas Department of Public Safety approached 8118 Bo Jack Drive, Houston, Texas to check welfare on the Newborn Child.
58. DPS Troopers secured vehicles at the residence and secured the perimeter of the residence. DPS Troopers entered 8118 Bo Jack Drive in an attempt to ensure the safety of




the Newborn Child. DPS Troopers located a young, infant child whose physical appearance is consistent with that of Heidi Broussard's Newborn Child.


59. Texas Ranger Phillips has investigated numerous deceased persons and has been around numerous deceased human bodies. Ranger Phillips, through his training and experience, can readily identify the odor of decomposing flesh.
60. Texas Ranger Phillips approached the 2015 Nissan Versa four door, bearing Texas License Plate [REDACTED]. The 2015 Nissan Versa parked on the back porch of the single family residence at 8118 Bo Jack Drive is registered through the State of Texas to Magen Fieramusca. Ranger Phillips smelled the immediate and unmistakable odor of decomposing flesh emitting from the trunk area of the 2015 Nissan Versa four door, bearing Texas License Plate [REDACTED].
61. On December 19, 2019, I presented a search warrant for a search of the 2015 Nissan Versa four door, bearing Texas License Plate [REDACTED] registered to Magen Fieramusca to Judge Urrutia. Judge Urrutia reviewed and approved the search warrant, as evidenced by his signature.
62. Texas Ranger Gary Phillips was still on scene at 8118 Bo Jack Drive, Houston, Texas. Ranger Phillips was notified of the signed search warrant for the 2015 Nissan Versa four door, bearing Texas License Plate [REDACTED].
63. During the search of the 2015 Nissan Versa four door, bearing Texas License Plate [REDACTED], Texas Ranger Gary Phillips located a human corpse in the trunk of the vehicle. The human corpse appeared to be a female with long hair. The human corpse was shoved into a black duffel bag.
64. Your affiant has probable cause to believe that Magen Fieramusca did, on or about December 12, 2019, knowingly tamper with a human corpse. Magen Fieramusca, knowing that an investigation was pending or in progress, concealed a human corpse in the trunk of the vehicle registered to Magen Fieramusca with intent to impair its availability as evidence in the investigation.
