### AFFIDAVIT FOR ARREST WARRANT

STATE OF FLORIDA  
COUNTY OF OSCEOLA

The undersigned Judge of the Ninth Judicial Circuit, Alicia L. Latimore, received a sworn affidavit from Detective Cole Miller for the Osceola County Sheriff's Office, who being first duly sworn, says that on or about the 14<sup>th</sup> of January, 2020, in Osceola County, Florida, the Defendant, Anthony John Todt, did, in violation of Florida State Statute(s) 782.04-1A1 and 828.12-2 and did unlawfully commit the offense(s) of **Murder, Premeditated (4 COUNTS) and Animal Cruelty**, as evidenced by the following:

On January 13, 2020 at approximately 0909 hours, Osceola County Sheriff's Deputies responded to 202 Reserve Place located in Celebration, Florida, in reference to a wanted person call. Federal agents with the Department of Health were conducting surveillance and physically observed Anthony Todt walk into the above address. Anthony has an active federal arrest warrant.

Once additional deputies arrived on scene, they approached the front door of the residence and began making announcements while standing at the front door. Agents made several announcements with no response. Entry was made by the agents and deputies who later contacted Anthony. Anthony stated his wife Meghan was upstairs and believed she was sleeping. Agents and deputies began calling for Meghan with no response. Additional agents and deputies conducted a protective sweep of the residence.

While conducting a protective sweep of the residence, four obviously deceased human bodies were found in a bedroom located on the second floor of the residence. Also, in the same bedroom, a small dog was found deceased. Anthony could barely stand and appeared to be shaking. Anthony was transported to a hospital for further evaluation and later held for making threatening comments. Anthony told paramedics he took an unknown amount of Benadryl in an attempt to commit suicide.

The residence was cleared and the Violent Crimes Unit was notified. As the on call detective, I took lead on this investigation and responded to the scene. At this time search warrants were being completed for this residence and another belonging to the family.

Detective R. Quinn and I responded to Advent Health to speak with Anthony Todt. Anthony was awake and alert. Anthony was asked questions that confirmed he was of sound mind. Anthony was read his Miranda Warning and stated he wanted to speak with us. The following is a summary of the interview:



At approximately 1900 hours, the District Nine Medical Examiner's Office arrived to move and transport the deceased back to the medical examiner's office. As the bodies were being moved, both Tyler and Alek Todt had lacerations to their abdomens. Zoey did not appear to have any lacerations. Meghan had two small lacerations to her abdomen. All injuries were consistent with the statement Anthony provided.

Based upon this investigation, this Affiant has probable cause to believe that Anthony, acted with a premeditated design, and murdered his wife and three children and the family dog. Therefore, your affiant drafts this affidavit and respectfully prays for the issuance of an arrest warrant for Anthony Todt for four (4) counts of premeditated murder and animal cruelty.
