**CRIMINAL COMPLAINT**

The Madison County Prosecuting Attorney's Office having submitted, pursuant to Idaho Criminal Rule 3, the sworn affidavit of Detective Ron Ball of the Rexburg Police Department, who complains and alleges the Defendant, LORI NORENE VALLOW, AKA LORI NORENE DAYBELL, 4141 Queen Emma Drive, #3, Princeville, Hawaii 96722, committed the following crimes:

COUNT I.

DESERTION AND NONSUPPORT OF CHILDREN OR SPOUSE, a Felony  
Idaho Code § 18-401(1)

(Punishment: Up to 14 years imprisonment and/or up to a \$500.00 fine)

That the Defendant, LORI NORENE VALLOW, AKA LORI NORENE DAYBELL, on or between the 23rd day of September, 2019 and the 18th day of February, 2020, in the County of Madison, State of Idaho, did desert a child under the age of eighteen, to wit: J.V., DOB: 05/25/2012, who was dependent upon the defendant for care, education, or support with the intent to abandon J.V.

COUNT II.

DESERTION AND NONSUPPORT OF CHILDREN OR SPOUSE, a Felony  
Idaho Code § 18-401(1)

(Punishment: Up to 14 years imprisonment and/or up to a \$500.00 fine)

That the Defendant, LORI NORENE VALLOW, AKA LORI NORENE DAYBELL, on or between the 8<sup>th</sup> day of September, 2019 and the 18th day of February, 2020, in the County of Madison, State of Idaho, did desert a child under the age of eighteen, to wit: T.R., DOB: 09/24/2002, who was dependent upon the defendant for care, education, or support with the intent to abandon T.R.

COUNT III.

RESISTING AND/OR OBSTRUCTING AN OFFICER, a Misdemeanor  
Idaho Code § 18-705

(Punishment: Up to 1 year in jail and/or up to a \$1,000.00 fine)

That the Defendant, LORI NORENE VALLOW, AKA LORI NORENE DAYBELL, on or about the 26th day of November, 2019, in the County of Madison, State of Idaho, did willfully delay and/or obstruct a public officer, to-wit: Lt. Ron Ball of the Rexburg Police Department, in the discharge of his office, by giving false information regarding the whereabouts of a child, J.V., DOB: 05/25/2012, and thereby delaying the search for J.V.

COUNT IV.

SOLICITATION, a Misdemeanor  
Idaho Code § 18-2001

(Punishment: Up to 6 month in jail and/or up to a \$500.00 fine)

That the Defendant, LORI NORENE VALLOW, AKA LORI NORENE DAYBELL, on or about the 26th day of November 2019, in the county of Madison, State of Idaho, with the purpose of promoting or facilitating the commission of a crime, encouraged and/or requested Melanie Gibb, to engage in conduct which would constitute the crime of RESISTING AND/OR OBSTRUCTING AN OFFICER, by requesting and/or encouraging Melanie Gibb to give false information to law enforcement regarding the whereabouts of a child, J.V., DOB: 05/25/2012.

COUNT V.


CONTEMPT, a Misdemeanor  
Idaho Code § 18-1801(4)

(Punishment: Up to 6 month in jail and/or up to a \$1000.00 fine)

That the Defendant, LORI NORENE VALLOW, AKA LORI NORENE DAYBELL, on or about the 30th day of January, 2020, in the county of Madison, State of Idaho, did willfully disobey a lawful court order in Madison County Case No. CV33-20-0045, by failing to physically produce minor children, J.V. and T.R., to the Rexburg Police Department and/or Idaho Department of Health and Welfare within five (5) days of service of the order.



Said complainant therefore prays that a WARRANT be issued for the arrest of the said LORI NORENE VALLOW, AKA LORI NORENE DAYBELL, and that she may be dealt with according to the law.
