AFFIDAVIT OF [REDACTED]

This is the affidavit of [REDACTED] who makes this  
declaration under oath and penalty of perjury, and pursuant to 28 U.S.C. §1746, hereby  
states before a notary public the following:

1. My name is [REDACTED] and I am over the age of [REDACTED]  
years of age. I am giving this affidavit voluntarily, and I have personal knowledge of the facts  
stated herein and know them to be true.

2. I met [REDACTED] in April 2016, and on one occasion was with [REDACTED] at [REDACTED]  
apartment in [REDACTED] when [REDACTED] told me that [REDACTED] [REDACTED] killed  
Kendrick Johnson.

3. According to [REDACTED] [REDACTED] and Kendrick Johnson were in

the gym at Lowndes High School in Valdosta, Georgia where an argument between [REDACTED] and Kendrick took place. The argument was about or over [REDACTED]

4. According to [REDACTED], [REDACTED] was taking steroids at the time and out of a "roid rage" or the effects of the steroids, [REDACTED] struck Kendrick Johnson in the neck with a 45lb. weight or dumbbell. [REDACTED] stated that [REDACTED] said to [REDACTED] [REDACTED] that the aforementioned blow may have broken Kendrick Johnson's neck.

5. According to [REDACTED], [REDACTED] was a witness to the fight and [REDACTED] told [REDACTED] that if [REDACTED] didn't keep quiet and help [REDACTED] move Kendrick Johnson's body, [REDACTED] [REDACTED], now [REDACTED], would make sure [REDACTED] [REDACTED] would "pay for it," as in, suffer some form of retaliation.

6. [REDACTED] also told me that [REDACTED] got in touch with [REDACTED] after being notified of the fight and Kendrick Johnson's death.

7. [REDACTED] also told me that [REDACTED] got in touch with [REDACTED] [REDACTED]

8. [REDACTED] also told me that [REDACTED] got in touch with another [REDACTED] who in some way facilitated the editing of the high school's surveillance video by corrupting or deleting some one hour and twenty-five minutes of the original recording. Shortly thereafter, [REDACTED] [REDACTED] changed [REDACTED] story by saying that it was not [REDACTED] who in some way facilitated the editing of the high school's surveillance video, but that it was someone who was [REDACTED] [REDACTED] that was responsible for the editing of the video you see it already.

9. [REDACTED] also told me that after Kendrick Johnson's death, that his organs were removed and newspapers placed in the cavity so as to interfere with any effort to establish the correct time of death or to otherwise disclose any other injuries. [REDACTED] also told me that the autopsy was falsely documented.
