January 11, 2013

Detective Whitener arrived at the Lowndes High School in reference to a death. Detective Whitener was directed to the old gym of the school, where he met with School Resource Officers. They allowed Detective Whitener to approach the area where the body was discovered. Detective Whitener did not approach the body as it was within a blue mat. Detective Whitener contacted Captain Edwards and advised her to be en route. Detective Whitener was advised that several students were present when the body was discovered as well as Coach Phillip Pieplow of the school and was directed to an office so that an interview could be conducted.

Report Narrative Detectives Whitener and Pritchett, of the Lowndes County Sheriff's Office met with Phillip Pieplow within an athletic office. When asked to describe his involvement in the incident, he stated that during his Life Sports class, he was called by i and who are in the class. He stated that the girls had been on top of wrestling mats, which were stacked in the corner of the gym. He stated that he thinks that they had motioned for other students within the class to come over to the mats because they believed that they had found something.

Pieplow stated that students then began yelling to him to come over and that they thought that they had found someone in the mats. He stated that he climbed the mats and when he reached the top, he saw feet inside. He stated that he could not move the person, so he climbed down and began to pull away the mats from the outside; trying to get to the mat the person was in. He stated that students helped him clear the mats. He stated that he reached the mat and he reached for the top of the mat pulled it from the top, down to the floor, when he noticed that the person was deceased. Mr. Pieplow became upset and was having a hard time speaking. He stated that he does not remember who called 9-1-1 but that he had all the children leave the gym area. He stated that the main children who would have information on discovering the body were being held within a classroom and would allow the detectives to speak with them.

The detectives then met with She stated that while in the class, she and her sister were on the top of the mats. The detectives asked them why they were on top of the

mats and she said that she was going to lie down. She stated that after being there for a few minutes, she noticed feet with socks on them in the mat. She stated that someone was playing a joke, so she called for to come and look. She stated that she then called for help. She stated that she did not have any other information at this time.

The detectives then met with who gave the exact same account of the incident as did. She was unable to add anything of evidentiary value. The detectives then met with He stated that while in the class, he was called by to come up on the mats to look at something. He stated that he climbed the bleachers and when he got on top, she showed him a mat and when he looked down into the mat, he saw what looked like someone inside the mats because he saw feet with socks on. He stated that he called Pieplow over and Pieplow came up on top of the mats. He stated that when they could not free the person from the top, he and Pieplow began to move the mats from the floor by pulling them away. He stated that he did not physically touch the body but he could tell that the person was dead. When asked how he knew this, he stated that the smell and the person was not moving. He stated that he did not have any other information at this time.

The detectives then met with within the office. She gave the same account as and . She stated that when she looked and saw the feet, she quickly got off the mats and started to yell for Coach Pieplow to come and help. She thinks that she called 9-1-1 but was informed that someone else had already called. She stated that she did not have any other information at this time. The detectives lastly met with student within the office. He provided the same information as the other students and was unable to add any additional information.

**REPORT NARRATIVE**

On January 11, 2013 at 7:45 am, I received a missing person report from Sgt Craig Robey. The report stated at 0030, Jacquelyn Johnson reported her son, Kendrick Lamar Johnson missing. At approximately 8:00 am, I arrived at Lowndes High School and asked the school secretary, Jane Vickers to call teacher, Bobby Wilson, in his classroom and verify Johnson's absence. When Johnson was confirmed not at school, I printed color pictures of Johnson. At that time, the principal's secretary, Arabi Hall, notified me that there was a mother that wanted to meet with me in reference to her son missing. I proceeded to the principal's office where I met Jackie and her daughter, Kenyetta Johnson. They both verbally stated that he has no girlfriends and that he does not particularly hang around any sole person. Kenyetta verbally stated that his closest companion was . After discovering that had been suspended, I asked dispatch to send the zone 4 unit, Deputy McCarthy, to contact at his residence. After Jackie proceeded to the guidance counselor's office, McCarthy informed me that he made contact with . and that he stated he has not seen or heard from Johnson since school.

On January 11, 2013 at 10:32 am, I was dispatched to the old gym for a code blue. At 10:35 am, I and Deputy Kerry Quinn arrived. I observed students running out of the gym and overheard them saying "that was a dead body." As I approached the southwest corner of the gym, I detected a mild odor of a corpse. The complainant, Phillip Pieplow, was bent over north of the body and verbally said "I don't think anybody can help him." I and Quinn proceeded to the corner and I observed a blue cheerleader mat lying horizontal and rolled up to approximately a 3' diameter. In the center of the roll pointing north, I observed two feet with socks wearing denim jeans. We had to move three mats to get to the other end of that cheerleader mat. In the center of the roll facing south, I observed a black male torso and head wearing white, exposed down to his rib cage. Both arms partially obstructed the face and were moderately stiff. The facial area was severely disfigured and swollen. The only identifying feature to the victim that I observed was the long dread locks.

Soon after, three firefighters arrived on scene and began tending to the body. Not far behind, two paramedics arrived on scene and one verbally stated "rigor has already set in." At 10:43 am, I advised the dispatcher "109D" and asked for him to alert the detectives. I directed Quinn to establish a crime scene log while I monitored the two entrances. Soon after, the incident was turned over to Investigator Jack Winningham.

On January 12, 2013 at 9:00 pm, I sent the dispatcher a request to remove Kendrick Lamar Johnson from GCIC/NCIC as a missing person.

Detective Priddy and Detective John Marion went to 16006 Norman Drive, Lowndes High School, in reference to a missing Juvenile.

While in route to Lowndes High School, Detective Priddy heard over the police radio that there was an unresponsive subject in the old Gym at Lowndes High School.

Upon arrival Detective Priddy met with Sergeant Mike Adams who advised the detective that the subject that was unresponsive in the Gym was Kendrick Johnson and he was deceased.

Detective Priddy spoke with Staff Sergeant Bryce Whitener who advised the detective to go to Lowndes High School Administrator Bruce Crook and review the school surveillance video.

## Report Narrative

After several hours, Detective Priddy was able to locate the surveillance video from the old Gym that showed Kendrick enter the Gym but not leave. Detective Attempted to produce a copy of the surveillance, but due to some technical problems he was not able to produce a copy of the surveillance video.

Detective Priddy Spoke with Lieutenant Stryde Jones and advised him that the surveillance video showed Kendrick Johnson entered the old gym at approximately 1:09pm and that the time on the surveillance system is not accurate. Lieutenant Jones advised the detective that he needed to obtain an copy of the surveillance video for the entire wing of the school with the old gym for the last 48 hours.

Detective Priddy met with Scott Forthe who is the Information Technology person for the Lowndes County Board of Education. Detective Priddy explained to Scott that he wanted the last 48 hours of surveillance for the entire wing of the school with the old gym. Scott advised the detective it would take a few days because there is close to 40 cameras on that wing.

Lieutenant Jones noted that he requested two {2} specific items be removed from evidence and provided to him for investigative reasons. Those items included a LG cellular telephone, previously marked at item nine {9} by Criminalist James Thornton and a pair of Nike shoes, previously marked as item eight {8}. Both of these items were concealed in paper bags that had been sealed with evidence tape and dated and initialed.

The cellular telephone was examined and the model and serial number recorded in preparation for the submission of a Search Order affidavit. Lieutenant Jones retained possession of the telephone pending the submission of the aforementioned order.

The Nike shoe was examined and discovered to be a size nine {9}. This shoe was returned to the paper bag which was resealed with evidence tape and initialed and then returned to evidence for storage.

Other Property / Evidence forms submitted by Criminalist Thornton indicated that he also collected from the scene a pair of Adidas shoes that were a size nine and one half {9.5}.

Detective Burke was requested to assist Detective Staff Sergeant J. Winningham with a series of interviews at the Lowndes County High School in regards to this case investigation.

After receiving parental consent Detective Burke conducted an interview with three students,  
and , in the break room at the high school.

The interview with : revealed that he knew that "I" had observed a set of socks sticking out of one of the rolled up mats. stated that he "got up on the mats" and "saw someone in the mat". stated that he called for Coach Pieplow and then "went and got him". stated that he assisted with moving the mats to reach the one occupied by the victim. stated that when they reached the mats he noted a "bad smell" and was told to go to the new gym by a coach. stated that he did not know the victim and that he had no classes with him.

The interview with : revealed that he was "on top of the mats and saw legs and socks". : stated that he started yelling for a coach and that he called 911 on his cellular phone, : stated that while he was making the 911 call Coach Quinn, Coach Pieplow and "I" began pulling the mats away. stated that he disconnected from 911 and assisted them with moving the mats. stated that a short period of time later 911 called him back on his cellular phone. stated that at that time he was instructed to leave and go to the new gym.

The interview with : revealed that he was in Coach Pieplow's class playing basketball when the victim was discovered. stated that he went over to the area where the mats were when he heard that there was a student trapped in a mat. stated that he never seen the victim in the mat and that he did not know him.
