

## General Rules for Events

Clients are kindly requested to clear any items they bring into the space by the end of their booking, factoring in this requirement for their allocated time. If you need to stay past your scheduled check-out time, overtime is charged at 1.5x the hourly rate. So be sure to book set up and clean up time in your hours booked.

We emphasize maintaining a pristine environment and request compliance with specific guidelines:

No confetti, glitter, or foreign substances on the premises.

No spray on the balloons - this requires a de-greasing of our floors and will incur a \$175 cleaning fee.

Guests are expected to leave the space in the same impeccable condition as they receive it, ensuring that excessive mess is avoided to prevent additional cleaning fees.

All decorations must be freestanding or attached using removable adhesives only (e.g., Command strips, poster putty, mounting tack, or adhesive-backed hook-and-loop/Velcro) any materials used must be properly removed before departure. Nothing may be stuck directly to walls with nails, tape, or glue.

Please leave the space in the same condition you received it. Please clean any spills or messes immediately and Report any issues immediately so we can address them.

Certain restrictions are in place to ensure a pleasant experience for all:

No smoking indoors or within 20-25 feet of entryways or operating windows (California Law)

No underage drinking, rave events, pets/animals, or foreign substances on our dance floor.

While we take every precaution, we want to highlight that we are not liable for accidents, injuries, lost belongings during your stay, or any items left behind after the event. Any damages (walls, restroom, dance floor, mirrors, etc.) and any property missing will result in additional charges being billed to the credit card on file

## Food & Catering

All food must be fully cooked and prepared prior to arrival. There is no kitchen or cooking allowed inside.

If hiring a food vendor, they must have a valid permit, may set up in the parking lot, and are responsible for keeping the area clean and properly disposing of all waste. Food & drinks may be consumed inside the space, we just ask that any spills are addressed immediately. Leaving a spill that could damage our dance floors for our regular classes can result in extra fees.

## Events & Security

Events going past 6:00 PM or exceeding 45+ guests require security, which can be added for \$20 per hour.

Security must be on-site from 6:00 PM until the end of your rental.

 No smoking inside the studio or within 25 feet of an entrance, exit or operating window outside. There is absolutely NO SMOKING of any sort within the event space all cigarettes, cigars, marijuana, e-cigarettes, vaping devices, and similar products must be done outside. NO EXCEPTIONS!

 Alcohol last call must be served within an hour of end of booking. Follow all rules and laws regarding food and alcohol service, including licensing and insurance requirements.

If alcohol or food is served, all required permits, insurance, and legal compliance are the Guest's responsibility.

- Alcohol may only be consumed inside the facility.
- Guest submitting the Booking request must be of legal drinking age (21+ )
- All alcohol served at a Social Event must be for personal consumption only and not for resale.

## Equipment & Props

You may bring your own filming, podcast, or creative equipment, but it is your responsibility to secure it and take it with you after your rental.

Any props or equipment provided by us must be handled with care and returned to their original location after use.

 Zero tolerance Policy of fighting/violence onsite - event will be canceled immediately with no option of a refund.

If your event or rental is shut down by the police for any reason, we are not responsible and no refunds will be issued for unused time.
