# AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS & RESTRICTIONS OF STEVENS MILL SUBDIVISION

STATE OF NORTH CAROLINA

COUNTY OF UNION

THIS AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS & RESTRICTIONS OF STEVENS MILL SUBDIVISION (this "Amendment") is executed effective as of the and day of March, 2021 (the "Effective Date"), by STEVENS MILL HOMEOWNERS ASSOCIATION INC., a North Carolina non-profit corporation ("HOA") and Owners of Lots in the Stevens Mill Subdivision as indicated on Exhibit A attached hereto and incorporated herein by reference, (the "Owners").

#### **RECITALS:**

A. Fairview Developers, Inc., a North Carolina corporation, as "Declarant" filed that certain Declaration of Covenants, Conditions & Restrictions for Stevens Mill Subdivision (the "Original Declaration") dated January 11, 1994 and recorded in Book 683 beginning at Page 511 in the Office of the Union County, North Carolina Register of Deeds ("Registry"). The Original Declaration has been supplemented by the following Supplemental Declarations (collectively, the "Supplemental Declaration": (a) dated April 11, 1995 and recorded in the Registry in Book 776 beginning at Page 003, (b) dated July 19, 1995 and recorded in the Registry in Book

797 beginning at Page 608, (c) dated October 4, 1995 and recorded in the Registry in Book 817 beginning at Page 57, (d) dated November 30, 1995 and recorded in the Registry in Book 828 beginning at Page 712, and (e) dated November 30, 1995 and recorded in the Registry in Book 828 beginning at Page 714. The Original Declaration, as supplemented by the Supplements, is collectively referred to in this Amendment as the "Declaration." All capitalized terms used but not defined in this Amendment shall have the meanings given those terms in the Declaration.

Declarant's Class B membership has expired and any Lots owned by Declarant are Class A Lots.

The HOA and the Owners desire to amend the Declaration as set forth in this Amendment.

The Declaration does not specify the requirements for amendments to it. Therefore, pursuant to N.C.G.S. Sections 47F-1-102(c) and 47F-2-117(a), the Declaration may be amended by the affirmative vote or written agreement signed by Lot Owners to which at least sixty-seven percent (67%) of the votes in the Association are allocated.

This Declaration has been approved by more than sixty-seven percent (67%) of the Lot Owners as evidenced by their signatures on this Amendment.

NOW, THEREFORE, pursuant to the provisions of the aforesaid Declaration and the Act, the HOA with the consent of the Owners who are parties to this Amendment, hereby amend the Declaration as follows:

1. The following is added as a new Section 19 to Article VII:

Section 19. Leasing Restrictions. For purposes of this Section, a Lot shall be deemed "leased" or "rented" if any occupant pays or provides money or other consideration of any type in exchange for permission to occupy all or any part of a Lot, for any period of time. In addition, the term "Lot" as used herein shall be interpreted to include not only the land itself but also any dwelling or other structure situated thereon.

A. No Owner shall lease or rent less than an entire Lot and no more than one single family or housekeeping unit shall live on any one Lot. There shall be no sub-leasing of Lots, nor shall any Lot be leased or rented for transient or hotel purposes, which shall be defined as either a lease or rental agreement with a term of less than twelve (12) months or any rental if the lessee of the Lot is provided customary hotel services. Every lease or rental agreement shall be in writing and shall provide that it is in all respects subject to the provisions of this Declaration, the Bylaws, and the rules and regulations and any failure by the tenant or lessee to comply with such provisions shall be an immediate default under the lease or rental agreement, provided, however, that the failure of any lease or rental agreement to so provide shall not excuse

any person from complying with the provisions of this Declaration, the Bylaws, and the rules and regulations.

- B. Notwithstanding anything else to the contrary, no Owner shall be permitted to rent or lease his Lot until twelve (12) months have elapsed since the date on which the deed conveying said Lot to such Owner was recorded in the Union County Public Registry. In the event that a Lot is leased for any period of time in violation of this mandatory twelve (12) month "waiting period," the waiting period shall be immediately tolled and any time which elapses while the unpermitted lease remains in effect shall not count toward satisfaction of the twelve (12) month "waiting period" described herein. Furthermore, no more than five percent (5%) of the Lots within the Properties shall be leased at any one time.
- C. No Lot may be leased for a period shorter than twelve (12) months and it shall be a violation of this Article for any Owner to terminate any lease under circumstances which the Board determines to be, in the Board's sole and unfettered discretion, a deliberate attempt by the Owner to circumvent the express requirement that no Lot may be leased for a period shorter than twelve (12) months. In addition, it shall be a violation of this Section 19 for any Owner to list, advertise or offer his/her Lot for a period shorter than twelve (12) months and any listing, advertisement or offer of any Lot shall affirmatively state that the Lot is listed, advertised or offered only for a period not less than twelve (12) months. If any Owner lists, advertises or offers his/her Lot in violation of the restrictions contained herein, each separate listing, advertisement or offer shall constitute a separate violation of this Section 19 for each day that such violation continues.
- D. Not less than ten (10) days prior to commencement of any proposed lease, the proposed lessor/Lot Owner shall submit a written copy of his/her proposed lease to the Homeowners Association's Board of Directors who shall review the proposed lease for compliance with the requirements of this Section 19. Any such lease shall list the full names of all permitted occupants of the Lot under the proposed lease. Upon timely receipt of a complete and accurate copy of a proposed lease, the Board shall either approve or deny the proposed lease, in writing, based solely on the Owner's compliance, and that of the proposed lease document itself, with this Declaration and in particular this Section 19 Article VII. No lease may commenced without the prior written approval of the Board as described herein.
- 2. Except as modified herein, the Declaration and all provisions therein remain in full force and effect. Any terms used in this Declaration and not defined in this Amendment shall have the meanings given them in the Declaration.




