IMMANUEL LUTHERAN CHURCH ANNUAL CONGREGATIONAL MEETING MINUTES

FEBRUARY 9, 2020, LUTHER HALL

Prior to the meeting, the congregation participated in a potluck lunch. Voting members were asked to sign-in on the registration forms.

- 1. After determining a quorum was present, President Moore called the meeting to order at approximately 12:34 pm. Sixty (60) people signed in as voting members.
- 2. Roland Pera moved, and Kevin Fewell seconded a motion to approve the meeting agenda. The motion carried.
- 3. Pastor Sievenpiper led the opening prayer.
- 4. President Moore reported that the Congregational Council approved the 2019 annual Congregational Meeting Minutes during the first scheduled Council meeting following the 2019 annual meeting.

5. Reports

a. Pastor Sievenpiper's Report (page 7 of the Annual Report) – Pastor emphasized several 2019 accomplishments and 2020 goals in the areas of discernment, education and liturgy.

He thanked John Anderson for overhauling the sanctuary sound system.

He emphasized the posting of sermons to the ILC website, the paring of communion wine with the liturgical season, and the prayer team's addition of Vesper services on the third Tuesdays of the month.

In the area of Education we will be resurrecting the Education committee, studying James during 2020 Lenten Services, and continuing the ILC symposium discussions.

Pastor reported that the work of the Steering Committee continues, and that four areas of ministry have been identified; Worship, Relationships, Faith Formation, and Faithful Administration. Before any actions are taken a draft proposal will be prepared for congregational review and comment.

Pastor mentioned that the positions of Treasurer and Theology on Tap Coordinator are open and available to those wishing to serve.

b. Congregation President's Report (page 9 of the Annual Report) – President Mary Jo Moore highlighted the work of the Steering Committee, the use of our space by outside groups, the ILC Hollis work day, Summer Youth Works, the 120th ILC Anniversary celebration led by Deborah Crawford and her committee, and hosting the MLM Christmas Store (with a special thanks to Kathy Boehmer's task force). She emphasized the Council's work led by Kate Hauber on reducing the annual mortgage payment. President Moore presented a prepared chart outlining the loan modification. The key elements of the debt service reduction were: approximately a \$28,000 annual payment difference; an increase in the interest from 3.875% to 4.625%; and extending the loan maturity date by 4 years.

She gave special recognition to departing Council Member, Scott Thompson, for his service and especially his work on the Purple Dragon Day Care addition. She also recognized departing Treasurer, Mindy Rash, for the many years and hours of her service.

- c-d. Financial Reports (page 10 of the Annual Report) Treasurer Mindy Rash directed the congregation to the available reports. There were no questions from the floor, but she indicated her availability if any future questions came up.
 - e. Lynden Peters gave the Endowment trust Fund presentation (Page 23 of the Annual Report). He reported the ETF experienced a 17.2% return on investment in 2019, and that the ETF Committee will be evaluating alternative fund management options during 2020.
 - f. Committee Presentations President Mary Jo More indicated the committee reports were available in the Annual Report and asked if there were any questions. There being none we moved to the next agenda item.
 - g. Nominating Committee The proposed slate of candidates and efforts to resolve open positions was handled under the New Business section of the agenda.

Sally Baehni provided the Finance Committee's revised 2020 Budget (see attached) and walked the Congregation through the proposal. The proposal calls for a \$41,454 negative balance and relies on the ETF to cover that amount. Following the walk through and answering of questions Lenard Carr moved and Del Karmeier seconded a motion to approve the proposed budget. The motion carried.

a. Recognition of New Life – Baptisms and Death – Pastor presented the report available on Page 32 of the Annual Report. He advised there is a correction to the membership number to be reported to the ELCA. The 2019 end of year number should be 426.

- c. Resolutions (page 6 of the Annual Report) President Mary Jo Moore presented the proposed resolutions and gave the congregation a chance to review. There being no questions from the floor she called for a motion to adopt the proposed resolutions. Kevin Fewell so moved, CeCe Atherton seconded, and the motion carried.

COUNCIL PRESIDENT'S LETTER

Dear Sisters and Brothers in Christ:

For reasons everyone is all too familiar with, 2020 was a crazy year and, by crazy, I mean chaotic, unplanned. As the covid-19 virus began to spread throughout our metro area, Immanuel's leadership made the difficult choice of discontinuing on-site, in-person worship and ministries. In today's lingo, we pivoted from facility-based to on-line ministry and, suddenly, the way in which we did church became virtual. Worship moved to YouTube. Council, committee meetings, bible studies, book studies, coffee hours, and Theology on Tap were done by Zoom, a new online technology that allows many people to connect together in a virtual room. For members raised before the digital age, these changes presented quite a challenge. To maintain connections with all members, we established a Tele-Care ministry, which involves members calling other members, sending cards, and other forms of communication.

Immanuel took action to protect its staff by submitting a Paycheck Protection Program loan to the Small Business Administration through its banking partner, UMB. Once approved, we were able to keep our pastor and six other staff employed without a reduction in pay. (Our nursery attendant only received pay when we had in-person worship.) At some point, we will apply for loan forgiveness, which, when approved, means Immanuel does not have to repay the original PPP loan.

New this year was creating an ad-hoc committee to advise Pastor and the Council about covid-19 and its impact on facility-based ministry. Said another way, they advise about if and when to re-open our doors to pre-pandemic activity. They follow the CDC guidelines and those of the city of Kansas City, in addition to listening to what the synod office says from time to time. We are hopeful that our members will take advantage of the covid-19 vaccines coming in 2021 and that, once again, we can gather together in-person. What a joyous day that will be!

Lastly, we were hoping to unveil to the congregation a new mission and ministry plan prepared by the Steering Committee. During the year, this work was put on hold; however, by fall the work resumed and is nearing completion. There will be opportunities for feedback and change before the plan is finalized, so stay tuned! We pray that everyone will heed God's call and become actively engaged in the implementation of the new ministry vision and plan.

PASTOR'S REPORT

Partners in Ministry,

To say that this past year was different from what I was expecting would be accurate, although it fails to grasp the scope of what we've endured for 2020. In late March, the Immanuel Congregation Council made the difficult choice to suspend in-person ministry in response to the spread of COVID-19. As a community of faith, we are called to love God by loving our neighbors, and in the past year that meant giving up a lot of important things to keep each other safe from a deadly plague. While the doors of Immanuel's building were closed for much of the year, the church was opened in new ways. Every home became a parish, and we gathered in sacred virtual space for worship every week. Thanks to the many people who helped lead during our worship services, offering music, prayers, readings, and even a home video Christmas pageant. I'm grateful to everyone who joined us for worship on Youtube or logged into Zoom for one of our many meetings, from committee work to studies to casual conversation and more.

I did not expect this suspension to last as long as it did. When we stopped meeting in person during Lent, I was hoping that we would be able to return to in-person ministry by Pentecost at the very latest. Unfortunately, as you may have noticed, that didn't happen. Cases continued to climb, and to help guide our decision making, council appointed an Advisory Committee to help discern when and how we should return to in-person ministry. We meet monthly, and following our meetings we send updates to the congregation on the indicators we're tracking, decisions we've made, and our rationale behind these decisions.

The Steering Committee took a brief hiatus at the start of the pandemic, in part because it seemed impractical to plan for the future of Immanuel's ministry when there's so much we don't know about the future. In time, though, we realized that this important work of discernment should not be put on hold indefinitely, and while there is a lot of uncertainty about what the coming years will bring, our call to live out the good news of Jesus Christ remains the same. My hope is that we'll complete a first draft of a vision for our ministry some time in the Spring, followed by a time for comments, suggestions, and questions from the whole of the congregation. We welcome the wisdom of everyone, and when the time comes I hope you'll make your voice heard, so we can include the whole community of Immanuel as we listen to how God is calling us to be the church together. When we have a completed version, we will call a congregational meeting to discuss and hopefully adopt it.

I have had to learn a number of new skills this year, among them basic video editing and production. I lead worship from the sanctuary every Sunday morning by myself, but the days are surely coming where we'll be able to safely gather in person again. I'm looking forward to that day, and in preparation, we're making some additions to the sanctuary to allow us to continue live streaming worship. The hope is to make our worship offerings more accessible to anyone who wants to participate. With support from the Memorials Commission and funds designated for Evangelism, I'm in the process of building a computer dedicated to media production and streaming and mounting cameras in unobtrusive places, so that we can worship online without diminishing the experience of those worshiping in person. We'll also need people willing to help run the stream itself, so if you're interested in being part of a tech

team, please reach out to me. Even if you don't have experience with this type of thing, it's not hard to learn the basics.

Among the many difficulties of this year, we also experienced the death of beloved members of our community. Many of these losses were compounded by the need to keep physical distance, and while we still found ways to mourn, the inability to share a meal or offer a hug was deeply felt.

The pandemic was not the only challenge we faced this year, as people of faith and as citizens of the world we share. Along with the Adult Education Task Force, I led a pair of book studies, the first on Dear Church by Rev. Lenny Duncan and the second on How To Be An Antiracist by Dr. Ibram X. Kendi. I'm grateful for the valuable conversation as we grapple with difficult questions and discern how we are called to respond in faith to a world in need of good news. I hope these conversations and more continue in the future.

As I reflect on this past year, with its challenges and hardships, I am filled with gratitude for the manifold ways this community has continued to love God, each other, and the world. Thank you for being a part of this ministry, and for allowing me to continue to serve God and Immanuel as your pastor.

MUSIC DIRECTOR | SUZANNE ANDERSON

In January, we marked the official revival of Immanuel's Bach Cantata Vespers series with Cantata 23, *Du wahrest Gott und David's Sohn* (Thou, True God and David's Son). The Cantata Vespers Service was on the evening of Sunday, January 28th, and the choir offered one of the choral movements during worship the week before. Thank you to everyone in the Immanuel congregation, donors, choir and guest musicians who made this possible, and thank you to Pastor Ann and all those who helped to put together the beautiful reception afterwards.

The choir, bell choir and preparations for Easter and the April Bach Cantata Vespers Service were continuing normally until mid-March.

As we have been learning to worship via webcast, our musical offerings have continued to adapt to our changing needs. Our organist, Robert Barthel, continues to record preludes, postludes, hymn accompaniments and other organ music as requested, and we have enjoyed musical offerings by many members of the Immanuel congregation. As we moved into the fall, we added chanted psalms back into the liturgy and a weekly hymn led by a Virtual Hymn Choir. Our tenor Choral Scholar sings with the virtual choir and sends in occasional extra music. For Christmas Eve, we formed a Virtual Bell Choir made up of ringers from both the Bell Choir and the Chime Choir. For our Lessons and Carols Service on the first Sunday after Christmas, we received an abundance of wonderful musical offerings from members of the congregation.

Since mid-March, my tasks as Music Director have changed somewhat. I spend much more time at a computer and often need to investigate or make arrangements to be certain that we have the legal right to use a certain musical selection during a webcast. The process for creating every virtual hymn begins with creating a guide track (piano and metronome) that the singers and organist listen to while recording their parts. Once the individual recordings are received, I take each recording, copy it and split the sound from the video. Each audio file can now be lined up and edited together with the others. Once the audio is complete, I put the final audio file into the video editing program and layer each video in along with visuals of the words and/or printed music. For any solos or psalms that need piano accompaniment, I record an accompaniment while listening to the original file on headphones. The accompaniment is edited with the original file in the audio recording program before reuniting the sound with any visual elements.

As someone who has often felt intimidated by the recording process and the necessity of facing my own musical output in recorded form, I am continually amazed and inspired by everyone who has recorded music for use in services, either solos, psalms or individual hymn part recordings. At Immanuel, we have a congregation with a wealth and diversity of musical gifts. In the recordings I edit together, I am often struck by the care that went into making each recording. Sometimes, I notice the meaning of the words in a new way from the way someone sang them. Sometimes I am struck by the obvious presence of joy, something you can't see on the videos but can hear in the sound. Our individual selves and humanity are not obscured though we are physically apart. And just as with singing together in the same space, the more voices there are to put together, the easier things seem to come together.

Management Responsibility

The organization's management is responsible for the information contained in these reports and for the development, implementation, and adherence of all financial policies and procedures. We recommend management carefully review all transactions contained in these reports to insure accuracy and clarity.

Table of Contents

Statement of Financial Position

The statement of financial position gives a financial picture of the organization as of the end of the reporting period. It reflects the assets, liabilities, and net assets of the organization.

Definition of Fund Accounting Terms

Net Assets – Total Assets minus Total Liabilities. Net assets fall into one of two categories:

- 1. With Donor Restrictions funds that may be spent only as restricted by the donor.
- 2. **Without Donor Restrictions** funds available for general operations. These may be further separated as follows:
 - a. **Net Investment in Fixed Assets** total fixed assets minus accumulated depreciation minus any loans related to the fixed assets.
 - b. Board Designated although not donor restricted, these amounts have been segregated by the board (or finance committee, elders, etc.) for special purposes.
 - c. **Prior Years' Net Balance** cumulative net activity (revenues minus expenses) from all prior years.
 - d. **Current Year Net Balance** current year net activity (detailed on the Statement of Activities).

Statement of Activities

The statement of activities reflects the revenues and expenses of the organization for the current period of time—typically the current month and year-to-date. It can also be used to compare actual revenues and expenses to those budgeted.



ENDOWMENT TRUST FUND

The Endowment Trust Fund (ETF) was created in 1979 for the purpose of supporting the ministries of Immanuel Lutheran Church (ILC). In May of 2005, ILC entered into an agreement with UMB Trust Services to act as the professional investment manager of the ETF. Per ETF policies UMB is required to maintain a diversified portfolio. The ETF portfolio return on investment for 2020 was 10.8%. 1.20% of

In September the account management fee charged by UMB was reduced to 1.20%, for a guaranteed three-year period.

In 2015 the decision was made not to budget a contribution to the Operating Budget of ILC. The ETF contributed \$17,000 for Operating Expenses in 2020.

ALTAR GUILD

Altar Guild at Immanuel is made up of a group of dedicated members who strive to make the worship experience proceed as smoothly as possible.

On a weekly basis, a team of two or three members meets on Saturday morning to bake bread, prepare Communion trays, set up the hymn board, and prepare the Altar for worship on Sunday. This team also meets on Sunday morning between services to refresh communion trays, the chalice, and reset the Altar for the 10:30 service. They meet again after the 10:30 service to complete clean-up duties in order to be ready for the following week.

We use the church year calendar as a guide for observing the seasons of the church year and festival Sundays which may require changes in paraments or set-up. New this year is the introduction of wines that reflect the seasons of the church. After a wine tasting in October and member input and voting, wines were chosen for the upcoming year.

On a monthly basis, the entire Altar Guild meets to discuss upcoming events and handle tasks such as ordering palms for Palm Sunday, Easter lilies, and poinsettias for the Christmas services. We also schedule volunteers to sell lilies and poinsettias, buy wine and candles, and manage other duties necessary for a meaningful worship experience.

We are responsible for decorating the church for the Advent season, the Christmas season, and Easter.

Altar Guild also has volunteers who handle special preparations for weddings and funerals.

The monthly Altar Guild meeting is usually the last Saturday morning of the month at 8:30 in the Spong Common Room. There are times throughout the year when we meet more frequently or on a different Saturday depending on need.

Of course, this year was different. Our last regular, in-person meeting was held in February. Over the summer, Melodee Blobaum volunteered to chair the Altar Guild Committee. Hopefully, 2021 will allow the group to meet on a more regular basis.

GLOBAL MISSIONS: KENYAN CHILDREN'S FUND

During 2020, a year unlike others in our memory, faithful and generous donations from many Immanuel members made it possible for the Kenyan Children's Fund to provide needy children and their guardians in the Masii area of Kenya, with:

- Monthly food supplements to help stave off hunger.
- Crop seeds, which enable people to grow their own food.
- Education support, including assistance with tuition and uniforms, to help children stay in school.
- Goats that provide milk and much-needed income for the children's families.
- An expanded home-repair and construction program, through which you help pay for materials that local people use to fix crumbling abodes or, in many cases, build their first and only shelters.
- Sleeping pallets, which keep people from sleeping on dirt floors.
- A Kenyan social worker, who ensures that your contributions meet urgent needs and who reports to the KCF committee.
- Vaccinations and other medical and mental-health care, which are crucial in an area ravaged by HIV/AIDS.

Although the needs in Masii are many and varied, we are happy to report that Kenya is not a hot spot for coronavirus, so no additional funds have been needed to treat COVID-19. Malawi, the rural region where Masii is located, benefits from:

- Few crowds and outdoor living. People generally aren't packed together in close living conditions. Plus, it doesn't get cold in Kenya, and indoor settings big enough for a group are rare. So although Masii residents desperately need simple shelters to protect them from rain and sweltering heat, almost all activities occur outdoors. That greatly reduces super-spread events, which almost always result from indoor gatherings.
- Youth. The average age in Malawi is 17; only 3 percent of the total country's population is 65 or older. Young people generally can withstand the virus despite limited resources.
- Relative absence of underlying conditions. Complicating factors such as obesity and diabetes are rare.

During the coming year, the KCF will continue to provide food, clothing, medical care, home repair and construction materials, and social worker assistance. The KCF's 2021 goals also include:

- Purchasing water-well filters. The well, made possible in large part by your donations, serves about 7,000 people.
- Building a girls' bathroom at the regional school. There already is a boys' bathroom, but there's no facility for girls.
 Covering the roughly \$2,000 required for the project may require a special fund-raising appeal. Please let us know if you are interested.

A donation of only \$390 per year to the Kenyan Children's Fund, in care of Immanuel, will assist one child for the year. But a contribution of any amount is a blessing! For more information about sponsorship, contact John Helgesen, jhelgesen@mycci.net or 913-381-2997.

MUTUAL MINISTRY COMMITTEE

Immanuel's ministry is strongest and most effective for us and for the world when it is the mutual work of both the congregation and the pastor. Helping to ensure that all congregation members can be heard and involved is the work of the Mutual Ministry Committee.

The committee members represent varied viewpoints within the congregation and are accountable for maintaining strict confidentiality of any personal and/or personnel information shared during its work. They strive to be open-minded, willing to listen, sensitive to group dynamics, actively engaged in the congregation (but not necessarily leaders) and have knowledge of and appreciation for the church.

You can expect the Mutual Ministry Committee to:

- Generate and encourage thoughtful dialogue about perceptions, joys and concerns within the congregation. During 2020, for example, the committee helped identify ways to help Immanuel members become more aware of Pastor Ann Rundquist's work within and on behalf of the congregation, including with the Congregational Life Committee and our Confirmation ministry. They also promoted and assisted with communicating updates from the Immanuel Steering Committee, which is helping to chart a future vision and goals for our Christ-centered work in the world.
- Address conflicts or misunderstandings that may affect our ministry. During the pandemic, committee members emphasized that differences of opinion, while sometimes difficult, often can result in compromises, learning moments and new approaches for all involved. In that spirit, they had discussions with Pastor Micah, congregational council members and others about health/safety measures and other concerns. To help keep the congregation informed, they also promoted now-regular communication from the group that advises Pastor Micah and the congregational council about safety during the pandemic.
- Act as a focus group through which congregation leaders, especially the pastor, may share ideas for ministries and events, and also get suggestions for how to accomplish or improve what is being proposed. For example, in recognition that live-streaming worship and other events is valuable and will continue even after we can worship in person, Mutual Ministry members helped to begin drafting members of a new Tech Team people who can assist Pastor Micah or a supply pastor with technology aspects of YouTube and Zoom. Pastor Micah didn't take any time off during the final 10 months of 2020 because he was solely responsible for enabling worship via technology; a Tech Team would allow him to have some time away for renewal.
- Provide support for the pastor and other congregational leaders, especially during times of personal or professional stress. The work of being the church together while we are apart resulted in plenty of stress and challenges, each of which highlighted the need for careful listening, shared responsibility and willingness to be part of something new.
- Review the pastor's goals and have ongoing discussions with him about his priorities, scheduling, and any issues or concerns. As 2020 came to a close, Mutual Ministry members began conversations with members of the Personnel Committee about evaluations for current and future pastors, and how those evaluations could become even more beneficial.

Any Mutual Ministry committee can be effective only if congregation members are willing to openly share concerns and engage in conversations to help address those concerns. Continuing committee members, a new chairperson and new committee members who will begin serving in 2021 all pledge to hear your joys, suggestions or concerns with open minds and hearts.

PRAYER TEAM

The Prayer Team works to provide opportunities for members of Immanuel and others to enhance their relationship with God. In a typical year we offer not only occasional services for healing, but also monthly vespers and learning opportunities, however, the pandemic altered our plans in 2020.

Our planned healing service in March and retreat in April were canceled as were vespers services. We met and decided to offer services via Zoom to provide members the opportunity to be with and support one another online. We began offering services again in October on the third Tuesday of the month at 6:30. October's service was Prayers for Confidence in Uncertain Times, the November service was Prayers for Assurance in a Time of Turmoil. The Longest Night service was offered on Tuesday, December 8 on Zoom; this service was recorded and available for viewing on the church website. The services on the third Tuesdays of the month are brief and offer an opportunity to quiet your mind from the busy-ness of the day and see others in our community. The Church Council meeting begins at 7 if you wish to attend the meeting afterwards.

We pray for all members of the church on the prayer list daily and for Immanuel. Every Tuesday at 6:30 pm you are invited to pause and join with us in prayer for members on the prayer list, for Immanuel, and those friends and family members of our congregation who are also listed in the bulletin.

PROPERTY COMMITTEE REPORT

2020 presented several challenges. Committee meetings were really just an exchange of emails or phone calls. Workdays as a group were replaced by individuals showing up and to tackle specific tasks. Several major projects have been delayed for a variety of reasons.

This is a list of projects that was listed in last years report along with their current status:

- Work on the library floor. Has not been started.
- Painting the Genessee Residence. Estimates gathered but the roof repair needs to be completed before painting.
- Genessee Residence flat roof repair. The contract has been signed and some of the work has been started but material shortages are slowing progress. This project will also replace the roofing material for the Bell Street overhang.
- Patch work on water damage walls. Has not started.

We've had miscellaneous projects that had to be taken care of. A couple of the refrigerators had to be repaired. The large trees on the east side of the property were trimmed. The small water heater failed and is in the process of being replaced. We discovered that our sprinkler system will probably need to be replaced. Our HVAC company was onsite this week for maintenance and reminded me that the current boiler is 20 years old. Some parts are getting difficult to find.

I would like to thank all the volunteers for their time and effort over the past year(s). I expect that scheduled workdays will not happen until things start returning to normal. STEERING COMMITTEE

"In your steadfast love you led the people whom you redeemed..."

Exodus 15:13

The Book of Exodus tells us these are the words the Israelites sang on the banks of the Red Sea after escaping Pharaoh's forces during their journey out of Egypt. Having survived a harrowing experience, God's people gave thanks and looked forward with joy to the new life God was leading them into.

Like the Israelites of the Exodus story, we rely on God' steadfast love to lead us where He wants us to go. Through challenges and times of uncertainty, we know God has a plan and a purpose for us as the people of Immanuel. In that spirit, Pastor Micah assembled a Steering Committee in Spring 2019 to consider the future of Immanuel and to envision where God is calling our congregation.

Following an unplanned hiatus over the past spring and summer, the Steering Committee recently resumed monthly meetings to continue the process of collective discernment. To mark this resumption of our work, we wanted to provide a general overview of the Steering Committee itself and give an update on our progress thus far.

What is the mission of the Steering Committee? What does it exist to accomplish?

Broadly, the Steering Committee seeks to answer the following questions by listening to God, to the congregation, and to one another:

- What is our mission, as the people of Immanuel Lutheran Church?
- What does successful ministry look like here?
- What are we called to do, as the people of God living in this particular time and place?

In answering these questions, we hope to articulate "what makes Immanuel Immanuel" and to create a set of priorities and guiding principles to guide our congregation going forward.

Who is on the Steering Committee? How and why were you chosen?

The Steering Committee is led by Pastor Micah, and the members of the committee are: Don Arney, Connie Benolkin, Kayla Carey, Linda Fox, Lori Kueker, Mary Jo Moore, Bryan Park, Dave Petersen, Elie Roddy, and Bonnie Thomas.

A call for volunteers to join the Steering Committee was issued at the time of the 2019 Annual Meeting. In selecting members from among those who indicated their interest, Pastor sought to bring together a diverse array of voices, including both new and longstanding members and individuals representing different generations.

How often do you meet?

We began meeting in April 2019 and met approximately once a month for the first year of our work. The demands of responding to the Covid-19 pandemic caused us to pause our regular meetings from mid-March 2020 through mid-August. We began meeting monthly again (via Zoom) in August of this year.

What are you currently working on or talking about? What have you accomplished so far?

The committee's first step was to read and discuss Peter L. Steinke's book A Door Set Open to help us reflect on the process of change and renewal within a congregation -- what does it look like? Why might it be a necessary project for churches in today's world? Using Steinke's book as a starting point, we considered what change and renewal might look like for our own congregation and how we might work together to envision Immanuel's present and future.

- •In the summer of 2019, Steering Committee members hosted listening sessions with members of the congregation to hear input on our essential questions: What does successful ministry look like here at Immanuel? and What are we called to do as the people of God?
- Using insights gathered from the listening sessions, as well as from the Congregation Assessment Questionnaire collected at the 2019 Annual Meeting, the Steering Committee then crafted a draft mission statement for Immanuel. We also drafted a list of core values that will guide our congregational life and work and identified ministry areas that represent both strengths and areas of potential growth for Immanuel.
- For each of the ministry areas we identified, we are currently working to create objectives to pursue as a congregation. These objectives are meant to be broad and flexible enough for committees and individuals to work freely within while still providing enough detail to make the objective's purpose clear -- as you can imagine, this process has required lots of wordsmithing!
- Since resuming our monthly meetings in August 2020, we have also been in discussion about how the events of 2020 (locally, nationally, and globally) might impact the way we had previously answered some of our core questions.

When can we expect to hear more from the Steering Committee? Who can we contact with questions or comments? Pastor is planning a presentation on the work of this committee for the Annual Meeting on Feb. 21st, with the hope that we'll have a first draft of our work ready for comment later in the Spring. When those initial documents are shared, there will be abundant opportunities for feedback from the congregation. In the meantime, your thoughts and insights are most welcome. Feel free to contact Pastor Micah or any member of the Steering Committee with questions or comments. Sustained by God's steadfast love, we are excited to see where God will lead us together!

STEWARDSHIP COMMITTEE

The mission of the Stewardship Committee is to promote the expression of faith in our daily living, while helping church members see the relationship between whole-life stewardship and a life of discipleship.

- Immanuel's constitution

Virtually everything, if not everything, in the pages of this annual report are expressions and examples of stewardship – managing what God has entrusted to us.

This committee started the year with discussions of overall plans for the year. Then the physical distancing need arose due to COVID-19. We complied taking a hiatus, since most of our activities with the congregation are in person. We finally adapted to having *Zoom* meetings and planned the fall commitment drive a bit later in the year than usual. Since potlucks are such a tradition, we invited the congregation to a virtual potluck where members could submit to our Facebook page recipes of dishes they might bring to an actual potluck with the option of including photos of the dishes for us to imagine and reminisce.

December 20th was Commitment Sunday, when members could submit their intentions to participate in ministry in 2021 through prayer, service, and finances. By 23 January 2021, we had received 23 prayer and/or service commitments identifying more than 1404 hours (some didn't specify a number). SOCIAL MINISTRY

Social Ministry Committee members work to be good stewards of Immanuel's offerings. Please see the budget categories titled **Ministry to Those at a Distance** and **Ministry to the Community** for the list of the organizations that Immanuel supports. We have been partners with these nonprofit organizations for many years.

Our committee has created a calendar that tracks the monthly events that keep Immanuel busy and involved in the community. For example:

- We supported the Gathering Table (formerly Children's Memorial Lutheran Church) during February by collecting socks in all sizes for low income and homeless populations in Northeast Kansas City.
- Before the coronavirus kept us from gathering in person, our Sunday School children created artwork for all-occasion Caring Cards that were sold throughout the year. Proceeds from the sales were earmarked for Lutheran Disaster Response.
- Many of our spring and summer events were overshadowed by the pandemic, but we were able to host "Christmas in July" the ingathering of gifts to help fill the MLM Christmas Store. Though ILC was not able to host the actual Christmas Store this year, we did again set up a drive-thru gift drop-off in the Bell Street parking lot to receive more gifts to support the store.
- Immanuel members supported the annual CROP Hunger Walk. Rick Sundell and Karen Bame (Karen's 31st consecutive walk) walked, and others donated dollars to Immanuel's team in the effort to ease hunger locally and worldwide. This year we raised \$2,281.

Heartfelt thanks to the members of Immanuel and other outside partners for their continued support of Social Ministry events and opportunities to serve. We can all relate to the hope that we will be able to do more service-related events in 2021.

SUNDAY SCHOOL

The 2020 Pandemic has forced us to think outside the box in many ways this year! Immanuel's Sunday has been quite different after we put away the Alleluias last February 23rd! Remember standing, sitting, & singing as the congregation sang *Allelu*, *Allelu*, *Alleluia*, *Praise ye the Lord* with the Sunday School children? That seems like YEARS ago!

In the somewhat normal months of January & February 2020, the children helped create some artwork for the Caring Cards, which have been sold to generate funds for Lutheran Disaster relief.

As services were suspended on March 2nd, Sunday School lessons were emailed to families until May 10th. In September, all Immanuel Sunday School age children were given a bible to use at home as we continued to worship remotely. On September 20th, we began mailing a weekly Spark Curriculum called "Faith Together at Home" to each Sunday School and Confirmation family. Each activity page included a ritual, reading and talking about a Bible story or verse, an activity, a service idea, and a prayer. Our goal was for these "off screen" materials to help nurture our Immanuel families through this challenging time.

We are very thankful for many years of creative and devoted leadership of the "Alleluia" program from Ellen Wilcox. On October 4th, Megan Sawyer began an "Alleluia & the Arts" singing time via Zoom, after the online service. She also planned and organized some of Immanuel's families to participate in this year's Christmas Eve service.

During Advent, we mailed out "Advent Adventures", which encouraged families to spend intentional time together during the Advent season by learning, creating, serving, and exploring together.

Pastor Ann Rundquist mailed the quarterly Spark magazines to families. She also sent families an Advent package which included 4 crafts, an Advent calendar, and the family Spark magazine.

Those serving our Immanuel Sunday school are Jeri Blaske-Yungeberg & Elizabeth Hastings (2s-Pre-K), Ellen Parson & Tori Friedrich (K-3rd), Michael Hamlin (4th-6th), Megan Sawyer (Alleluia & the Arts) and Suzanne Steffen (SS chair). There are currently 19 children, and 8 Confirmation age children.

Even though we have not been together in person much, and have not enjoyed many of our annual traditions this year, we look forward to 2021, when we can slowly return to a new normal of gathering and learning together again!

We really have a wonderful group of children and parents at Immanuel! Special thanks to all the dedicated teachers for volunteering their time and service. Thanks, also, to the parents, for their support of Immanuel's Sunday school program.

WORSHIP AND ARTS

The year 2020 saw challenges we could barely imagine at its beginning. Worship at Immanuel was severely impacted by the pandemic, and yet, like other ministries of the church, our community found ways to adapt, adjust, and even thrive in our new reality.

The year began with Bach Cantata Vespers featuring the Immanuel Choir and guests presenting BVW 23, *Du wahrer Gott und David's Sohn* (Thou True God and David's Son), as a part of an evening vespers service led by Music Director Suzanne Anderson. Though April's planned Bach Cantata was canceled due to COVID, we look with hope to the future in anticipation of reviving this Immanuel tradition in the future.

Beginning in mid-March, with the suspension of in-person ministries, Immanuel's worship has taken place online, streamed live each Sunday from our YouTube channel. Our tradition of lay leadership in worship has continued, with members serving as virtual readers, psalmists, assisting ministers, and providing various musical offerings for virtual worship. From Holy Week and Easter to Christmas Eve, and all the surrounding Sundays, Pastor Micah has stitched together meaningful worship from these recorded offerings. Since summer Suzanne Anderson has prepared, led, and engineered a weekly virtual choir. Organist Robert Barthel has continued providing organ music during this time as well. Beginning in October, Pastor Micah and the Altar Guild have provided outdoor communion opportunities with COVID precautions in place.

Megan Sawyer has begun offering twice monthly (and weekly during Advent) Alleluia gatherings for Immanuel's Sunday School students via Zoom. Sunday School families also participated in a virtual Christmas Pageant, each taking a scene from the Christmas story, which Megan then produced into a video premiering during the online Christmas Eve service.

While we long for in-person community and to be able to worship and give thanks in the ways to which we are accustomed, we rejoice in the creative ways we have found to worship under these difficult circumstances. We look to the future with hope.

2021 PROPOSED BUDGET NOTES

- Summary As more and more people get vaccinated and the COVID-19 numbers decrease, we anticipate re-opening, with safety protocols firmly in place. For planning purposes, this budget has been prepared with the assumption of a July 1 re-opening. We also looked at the year-end financials prepared by Miller & Company, comparing the budget to actual revenues and expenses. Council will be monitoring the budget closely and make adjustments, as needed. With the help of the finance committee, we will be focusing on sustainability and exploring all possible ways to continue the ministry of Immanuel well into the future, including the ETF, revenue-producing applications such as Amazon Smile, Round-Up and others, securing another PPP loan (if eligible), selling properties, and re-organizing staff, etc. We anticipate a continuing on-line ministry and we will expand our digital presence.
 - Overall, revenues are down from 2020. We received 49 commitment cards totaling \$212,580 compared to 64 commitment cards totaling \$316,000 in 2020. In the past year, Immanuel lost five (5) households, including four deaths and one withdrawal. The combined commitments totaled \$55,000. To arrive at a revenue figure from envelopes and growth in giving in 2021, we took the 2020 actual total of \$334,281 \$55,000 = \$279,281. Assuming more households will contribute throughout 2021 not all households send in commitment cards we rounded that figure and added a modest increase to \$281,000.
 - Immanuel in past years has set aside 10% of revenues for outreach, both local and global missions. The social ministry committee chooses the recipients and the dollar amounts to be donated. Included in this category are payments to the ELCA (seminaries, synod, churchwide, world).
 - Immanuel pays for the Living Lutheran magazine that is mailed to each household's home. The cost is \$8.95 for 111 households (total = \$993.45/yr.) Some have suggested stopping this practice, putting responsibility for subscribing on each individual household. A family subscription is \$36.00 for 3 years (\$12/yr.).
 - The biggest change in personnel-related expenses came in increases in pastor's compensation (housing allowance, FICA, portico benefits) and replacing the building manager position with a building superintendent who would provide both custodial services and managing use of space. Until Immanuel re-opens, Town & Country wil continue to provide custodial services and Kevin Fewell, our former part-time building manager, has volunteered to work at the church on Wednesdays. The budget reflects a start date for the new position on July 1, although it may occur later in the year.
 - Immanuel's computers are old and some no longer support newer software. Pastor will prepare a plan for new computers and software that will meet present needs and offer more security. He will ask the Memorials Commission to pay for these purchases.
 - The property committee submitted requests for items that cannot be deferred without jeopardizing the health and safety of members and Oxford House renters, resulting in an increase of \$10,713.33 over 2020 actuals. This category also shows anticipated expenses for when the building superintendent starts to clean the church, including equipment and supplies now provided by Town & Country. Note that there is \$11,250 in deferred maintenance and repairs that are not included. These projects will continue to be done in phases, as possible, with funding from other sources.
 - Line items 6310/6311 relate to Immanuel mortgage payments. The monthly payment is \$7,284. This includes principal and interest. As we continue to pay down the mortgage, the principal goes up, the interest due goes down. The balance due on our mortgage as of 12/31/20 is \$761,774.61 (4.625% interest rate). The amount Immanuel paid for debt retirement (principal only) is \$4,874.75.
 - The 2021 budget reflects a 8% decrease in expenses budgeted for 2020. Every effort will be made in 2021 to limit spending and to increase revenues.
