2.1 Liability Waiver - Release of Liability

This Liability Waiver and Release of Liability Agreement ('Agreement') is entered into between Get Up & Go Travel ('Company') and the undersigned participant ('Participant').

1. Acknowledgment of Risk. Participant understands that participation in a motor coach tour and associated activities (collectively, 'Activities') involves inherent risks, including but not limited to: vehicle accidents, slips and falls, injuries during boarding or disembarking, injuries during activities at destinations, weather-related risks, and risks associated with interaction with other participants, staff, and third parties. Participants voluntarily assume all such risks.

2. Release and Waiver. In consideration of being permitted to participate in the Activities, Participant, on behalf of themselves, their heirs, assigns, and personal representatives, hereby releases, waives, discharges, and covenants not to sue Company, its owners, officers, employees, contractors, agents, and affiliates from any and all liability, claims, demands, actions, or causes of action arising out of or related to any loss, damage, or injury that may be sustained by Participant while participating in the Activities.

3. Medical Treatment. Participant authorizes Company to provide or secure emergency medical treatment as Company deems reasonably necessary. Participant is responsible for all costs of medical treatment.

4. Personal Property. Company is not responsible for lost, stolen, or damaged personal property during the Activities. Participants are solely responsible for their belongings.

5. Conduct. Participants agree to conduct themselves in a manner that does not endanger or disrupt other participants or staff. Company reserves the right to remove any participant whose conduct is deemed disruptive, dangerous, or inappropriate, without refund.

6. Indemnification. Participant agrees to indemnify and hold harmless Company for any loss, damage, or liability arising from Participant's actions during the Activities.

7. Governing Law. This Agreement shall be governed by the laws of the State of West Virginia.

8. Severability. If any provision of this Agreement is found unenforceable, the remaining provisions shall remain in full force.

2.2 Terms and Conditions

By purchasing a seat on any trip operated by Get Up & Go Travel, the Guest agrees to the following terms.

1. Booking and Payment. A non-refundable deposit of \$ 100 is required to secure a seat. Final payment is due by October 4, 2026. Failure to complete final payment by the deadline forfeits all prior payments and the seat will be released.

2. Cancellation by Guest. Cancellations are subject to the following refund schedule:

- More than 60 days before departure: Full refund minus non-refundable deposit
- 30-60 days before departure: 50% refund
- Less than 30 days before departure: No refund

All cancellations must be submitted in writing to mferrari@getupandgotravel.us.

3. Cancellation by Company. Company reserves the right to cancel any trip due to insufficient bookings, force majeure, or safety concerns. If Company cancels, Guest receives a full refund.

4. Travel Insurance. Travel insurance is strongly recommended. Company does not provide travel insurance. Guests are responsible for purchasing their own coverage.

5. Check-In. Guest must arrive at the designated pickup location at the designated time. If Guest misses the departure, Company is not obligated to provide a refund or alternative transportation.

6. Conduct. Guest agrees to behave in a respectful manner. Company reserves the right to remove any Guest whose behavior is disruptive, dangerous, or illegal, without refund.

7. Photography and Media. By participating, Guest grants Company permission to use photos and videos taken during the trip for marketing purposes, unless Guest submits a written opt-out prior to the trip.

8. Changes to Itinerary. Company reserves the right to modify the itinerary due to weather, venue availability, or other unforeseen circumstances. Substituted activities will be of comparable value.

9. Liability. Guest agrees to sign and comply with the Liability Waiver and Release of Liability Agreement. Company's liability is limited to the total amount paid by Guest for the trip.

10. Governing Law. These Terms are governed by the laws of the State of West Virginia.

2.3 Photo and Video Release
