



Resolution No. 2026-18

A Resolution Repealing Resolution No. 2024-23 and Adopting a New Solid Waste Rate Schedule for Various Classes of Service Applicable to SWATCO Customers in the City of Banks

The Banks City Council adopts the following findings:

WHEREAS, effective January 1, 2018, the City enacted Ordinance 2017-10-01, and entered into an exclusive franchise with SWATCO Sanitary Service for the provision of curb-side and related solid waste and recycling services throughout the City of Banks, codified as Title X (Franchises), Chapter 104, (SWATCO – Solid Waste Management Ordinance) of the Banks Municipal Code; and

WHEREAS, since approval of this franchise, the cost of SWATCO's providing solid waste and recycling services has increased to the point where the rate schedule, set forth in Schedule A to the Solid Waste Management Ordinance, required revision virtually every year to keep pace with SWATCO's actual costs and to provide SWATCO with a reasonable rate of return for the service it provides to the citizens of Banks; and

WHEREAS, because the rate schedule was incorporated into the original franchise (Ordinance 2017-10-01), all such successive rate schedule adjustments required an ordinance and amendment of the original franchise; and

WHEREAS, the Banks City Council amended the original franchise (Ordinance 2017-10-01) with the adoption of Ordinance 2021-08-01, which removed the rate schedule from the franchise and allowed periodic amendment of SWATCO's rate schedule to keep pace with inflation by resolution without the need to amend the ordinance; and

WHEREAS, the City Council considered SWATCO's last previous solid waste rate increase request at its October 8, 2024, Council meeting and adopted those new rates at the Council's regular October 8, 2024, meeting as Resolution No. 2024-23; and

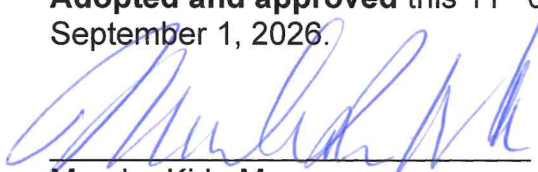
WHEREAS, on July 23, 2026, SWATCO submitted its most recent rate schedule increase, attached hereto as Exhibit A, which the Banks City Council heard as a presentation at its regular August 11, 2026 council meeting, at which time the Council allowed all manner of written and oral comment on the proposed solid waste rate increases; and

NOW THEREFORE, the Banks City Council hereby resolves as follows:

1. Repeal. Resolution No. 2024-23 is hereby repealed, as are all prior solid waste rate schedules.

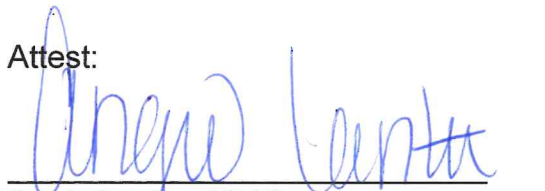
2. Adoption. The solid waste rate schedule set forth in Exhibit A, attached hereto and incorporated herein by this reference, is hereby adopted and shall be the maximum solid waste rates that SWATCO may charge its customers within the City of Banks.

Adopted and approved this 11th day of August 2026. This Resolution shall take effect September 1, 2026.
