The Bear Necessities

- Please provide your email and/or phone number if you haven't already. Going forward, all communication will be made via email. You can provide this information at the Spring meeting or by emailing nancya4lbl@gmail.com. This is very important to ensure quick communication with landowners. This will also reduce paper waste and mailing costs.
- ➤ The dumpsters are returning! We will have them available for member use starting Memorial Day weekend with two pick-ups per week. As a reminder, these dumpsters are for household trash placed in bags only.
- Keys for the boat launch and dumpsters will be made available at the spring meeting for members in good standing for \$5.00.
 Old keys must be returned when picking up your new key. If you cannot make the Spring meeting, scheduled "Office Hours" will be posted on the LBLA website and on Facebook for key pickup.
- ➤ **LBLA will be imposing a Noise Ordinance**. This will be registered with local authorities. The goal is to ensure we respect our neighbor's rights to quiet after 11:00 PM. We owe our older members and those with young children this courtesy.
- ➤ **Boating Rules**: When using the lake for boating, PWC and fishing, be familiar with and follow all local & state laws, including:
 - o Open Boating hours: 11:00 am to 7:30 pm
 - o No Wake hours: 7:30 pm to 11:00 am the next day
 - No Wake in ALL COVES at any time
- > Spring cleanup has been completed in all common areas. Trees that fell along the roads over the winter have also been taken care of.

2025 Dues Increase

We are all feeling the effects of the Consumer Price Index increase and economic pressures. Prices on household groceries has increased 45-55%, the cost of electricity, gas, insurance, a visit to your favorite restaurant, are almost double what they were 2-3 years ago. LBLA is not immune to these economic pressures. With significant increases in road grading, brine, trash services, insurance, taxes, etc., LBLA member dues have not been able to keep up with changing economic times. The continued pressure on our bottom line is not sustainable. The association must restore budget for Legal and the Fish Fund which haven't been funded for years now. Most importantly, we must cover the rising cost of expenses and safety concerns with our primary lake access locations. Access locations continue to deteriorate or have been damaged. LBLA has a responsibility to keep our amenities safe and sound, especially for older members. On April 18, 2024 the board voted 5/2 in favor of raising Member Dues to \$200.00, Effective September 1, 2024. As outlined in the LBLA Bylaws, the board is responsible for assessing increases or special assessments when financial conditions require. We believe we are acting in the best

interest of Little Bear Lake Association to sustain safety and ongoing operations.
