- 1. Vendors may set up Thursday, 5/1/25, 9 am to 4 pm CST or Friday, 5/2/25, from 7 am 9 am CST (start of event).
- 2. Space is up to 10'. An 8' table, chairs and electricity are provided.
- 3. Vendors must stay the entire time.
- 4. If this is your first event with us, please send a minimum of three (3) close-up photographs of your work or items to sell and one (1) close of your display. Send via email or mail. If you wish the photographs to be returned, include a self-addressed stamped envelope with this application. - 5. All arts and crafts vendors are restricted to original works, designed and hand-crafted by the applying artist. If the applying artist will not be present for the event, please include the name of the person who will be responsible for the booth.
- 6. Pornographic and/or obscene material in any form is strictly prohibited. Committee holds the right to define pornographic and/or obscene.
- 7. Acceptance is a commitment to show for the Event. Vendors failing to show or notify staff at the Panhandle Pioneer Settlement will not be accepted to future shows.
- 8. No refunds in case of cancellation.
- 9. Register early. Placement is not guaranteed and is at the discretion of the Events Committee.

  Placement requests will be considered if possible; spaces are NOT reserved or guaranteed.
- 10. Vendors are responsible for collecting and reporting appropriate sales tax...
- 11. Service Animals only are allowed on grounds.
- 12. When any rule is violated, the Committee reserves the right to ask the offending vendor to leave the show or remove said offense or violation.
- 13. The Settlement is not responsible for loss or damage, or for exhibits/items.
