

Maple Lake Township

Monthly Minutes

April 17, 2018

The regular meeting of the Maple Lake Township Board was called to order by Chairman Tom Neumann at 7:00 P. M. Supervisors, Ron Wolff, Tom Otto, Treasurer, Judy Neumann, Clerk, Dick Hogan were present.

The minutes of the March 20, 2018 meeting was read by Chairman, Tom Neumann. As no additions or corrections were noted, a motion was offered by Wolff, second by Otto to accept as read. Carried 3-0

The first order of business was opening of bids placed for the hauling and spreading of gravel: One bid was received for this service. Bid was presented by Bjorklund Companies, 27072 Polk Street NE; Isanti, Mn 55040. Bid was quoted in the amount of \$3.80 per yard for hauling, and \$.75 for loading. Motion was offered by Otto, second by Wolff to accept. Carried 3-0 Central Minnesota Dust Control, 22418 Elbow Drive, Richmond, Mn 56368, presented the lone bid for application of magnesium chloride at a cost of \$.86 per gallon for product and application. Motion by Neumann, second by Wolff to accept. Carried 3-0.

Terry Mooney, on behalf of the Maple Lake Library requested a donation to help support the everyday expense of operation. Library is operated by volunteers who rely on donations for their everyday expenses. Mrs. Mooney stated the City of Maple Lake and other townships contribute to its cause. A motion was offered by Wolff, second by Otto for a contribution of \$250. Carried 3-0.

Duane Rolstad, real estate developer, discussed options for splitting and sale of property previously owned by Mel Stuhr, and now owned by a bank. Property is located on the eastern side of Maple Lake, and not in the land use plan. Board will research with Wright County Planning and Zoning for insight as to what can be done. Mr. Rolstad will attend May Town Meeting. No action taken.

Mike Reid, 1906 Donnelly Drive, requested expansion of a existing 528 sq foot garage to a 928 sq foot structure, this would be 128 feet over limit allowed. After discussion of usage, a motion was offered by Wolff, second by Otto to approve request to Wright County Planning & Zoning for their consideration. Carried 3-0.

Mike Niewind, General Manager of Advanced Disposal, asked if the board would be interested in a tour of the disposal operation. Motion by Wolff, second by Otto to accept invitation with an open date. Carried 3-0

Chairman Neumann presented a 5% across board wage increase for all employees, second by Wolff to approve. Carried 3-0

All warrants were approved and paid as presented (see attachment)

As no additional business was brought before the board, Supervisor Tom Neumann adjourned meeting at 7:40 P. M.
