

Minutes of the Regular Board Meeting May 20th, 2025 7:00 PM Held at Maple Lake Township Hall

The regular meeting of the Maple Lake Township Board was called to order by Chairman Tom Hackenmueller at 7:00 PM.

Supervisor Philip Rasset, Supervisor Vern Haag, Clerk Esther Wenzel, and Treasurer Renae Neumann were present.

The minutes from the April 15th, 2025 regular board meeting and the April 17th, 2025 Special Meeting minutes were presented. A motion was made by Haag, seconded by Rasset to approve the minutes as presented. Motion carried 3-0.

Checks 5312-5340 and EFT 192-195 were presented to the Board for approval and payment. A motion was offered by Haag, seconded by Rasset to approve, and pay the checks as presented. Motion carried 3-0.

Update from Maintenance Department – Gravel Hauling is completed and they are grading the roads as they can and when they are rough. They are trying to get the dust control company out here as soon as possible. Cleaned out the culvert on Elder that is getting plugged from a beaver.

Benjamin Arnold (PID 210-129-007030) - Came to discuss a new deck, breezeway and attached garage that he wants to build, they do not meet the set-back requirements. There was a motion made by Hagg, seconded by Rasset to approve of the variance request as presented. Motion carried 3-0.

Jake Swanson (PID 210-016-000010) - Came to see how the board would vote in giving township right of way to him. The board stated they would need to get our attorney's advice on what we should do.

Devitt Ave - water issues and no turn around were discussed. There is inadequate water drainage on this road, the board discussed as to what could be done. One of the board members said they would go out and look at Devitt and then discuss what could be done. Making a cul-de-sac on Devitt was also mentioned, we will have to get our attorney involved and see how we can proceed.

Mike Mooney (PID 210-000-073100) - Came to get approval for his driveway. There was a motion made by Hackenmueller, seconded by Rasset to approve the location of the driveway as presented. Motion carried 3-0.

Getting a speed limit sign put up on Fillmore Ave was discussed as there are several residents who would like the speed lowered to help slow drivers down. There was a motion made by Haag, seconded by Rasset to have a yellow 25 mph speed limit sign to be installed on Fillmore Ave. Motion carried 3-0.

There was a motion made by Hackenmueller, seconded by Rasset to purchase plastic culverts for 50th and Dempsey Ave. Motion carried 3-0. There was a motion made by Hackenmueller, seconded by Haag to purchase a 30x40 culvert for Elder Ave and have Mares Excavating install it. Motion carried 3-0.

There was a motion made by Hackenmueller, seconded by Rasset to have Morris Excavating tile 85th Street for \$18,000. Motion carried 3-0.
