

Minutes of the Regular Board Meeting September 16th, 2025 7:00 PM Held at Maple Lake Township Hall

The regular meeting of the Maple Lake Township Board was called to order by Chairman Tom Hackenmueller at 7:00 PM.

Supervisor Phillip Rasset, Supervisor Vern Haag, Clerk Esther Wenzel, and Treasurer Renae Neumann were present.

The minutes from the August 19th, 2025 regular board meeting minutes were presented. A motion was made by Rasset, seconded by Haag to approve the minutes as presented. Motion carried 3-0.

Checks 5434-5466 and EFT 208-211 were presented to the Board for approval and payment. A motion was offered by Rasset, seconded by Hackenmueller to approve, and pay the checks as presented. Motion carried 3-0.

Update from Maintenance Department – Asphalt repair was completed on 85th Street and 32nd Street. They have fixed washouts, and hauled quite a bit of gravel to fix the washouts this year.

Doug and Shelly Waters (3821 Donnelly Dr NW) – Came to request to construct a storage building 48 ft. from the centerline of 51st St. NW (65 ft. setback required from a local road). There was a motion made by Haag, seconded by Rasset to approve the setback of 48 feet to the building, and have that be the minimum setback. Motion carried 3-0.

Michael Loch (PID 210-100-254204 & 210-100-252400) — Came to request a lot line adjustment, requesting to make the one lot that is roughly 8.59 acres, making that a 10-acre parcel. There was a motion made by Hackenmueller, seconded by Rasset to approve of the lot line adjustment to make the one parcel 10 acres total. Motion carried 3-0.

There was additional discussion regarding the culvert replacement on Appleton & 60th Street. Noel Zander wants to repair their drain tile that goes under the road. There was discussion on if the farmer could do the work. However, the board will check with the attorney if Zanders can complete the work or if they need a licensed contractor to do the work. There was a motion made by Hackenmueller, seconded by Rasset to check with the attorney regarding who can complete the work on the road, and to give permission to Noel Zander to do the work, depending on what the attorney says. Motion carried 3-0.

There was a motion made by Hackenmueller, seconded by Rasset to approve the RESOLUTION TO ERECT REGULATORY SPEED SIGNS IN RURAL RESIDENTIAL DISTRICTS – For Donnelly Dr, to reduce the speed limit to 35 mph. Motion carried 3-0.

There was a motion made by Rasset, seconded by Haag to approve the election judge list as presented for the November 4th, 2025 Election. Motion carried 3-0.

There was a motion made by Haag, seconded by Rasset to adjourn the meeting at 9:16 pm. Motion carried 3-0.
