## JANUARY 2024 FEE SCHEDULE

**Subject to revision, without notice, as material prices fluctuate**

### ONE TIME CHARGES:

#### Membership Charges

<b>Single Family Residence (SFR):</b>	\$7,000.00
<b>Multiple Family Residences (MFR) and Commercial, First 2 Units:</b>	\$7,000.00
<b>Each Additional Unit (see Note 1):</b>	\$3,500.00

**Note 1:** “Additional Unit Fee” applies to MFR and commercial buildings with separate keyed units and/or separate addresses. MFR includes duplexes and apartments. Commercial includes business, government, school, church, and community facilities. For example: a 12-unit apartment building will have a membership charge of \$42,000 [7,000 (first 2 units) + (10 x 3,500)] = \$42,000

**Fire Protection (for each square foot over 3,600):** \$1.40/sq. ft.

### Service Meter and Premises Isolation Installation (see Notes 2 and 3):

Cost of City of Edgewood Permits, if required, shall be added to the above prices.

**Note 2:** Additional charges apply for hydro-excavation equipment, spoils disposal, paving, curb/gutter replacement, sidewalk replacement, excessive excavation, shoring, de-watering, flaggers, directional boring, and relocation and/or restoration of facilities and/or landscaping.

**Note 3:** A long service is defined as a service which crosses any portion of a roadway to reach the property being served.

**Note 5:** The first unit of Multiple Family Residences on one service will be charged the appropriate Water Base and Water Usage Charges. Additional units will be charged an additional Water Base charge of \$36.42 each.

Commercial Property (Businesses, Government, Schools, Churches, and Granges): \$15.00 Fire Flow Fee plus \$0.01 for each square foot of building space in excess of 2,000 square feet.
