BY-LAWS

BASKETWEAVERS GUILD OF OKLAHOMA

Section 2: Elections shall be held in September of odd years for President and Treasurer and even years for Vice-

President and Secretary.

Section 3: The term of office shall begin upon the adjournment of the November meeting.

ARTARTICLE I - NAME

The name of the organization shall be BASKETWEAVERS GUILD OF OKLAHOMA, a non-profit organization.

ARTICLE II - PURPOSE

The object of BASKETWEAVERS GUILD OF OKLAHOMA is the preservation, promotion and education of the art of basketry.

ARTICLE III – MEMBERSHIP

Membership in BASKETWEAVERS GUILD OF OKLAHOMA shall be open to anyone interested in furthering the purpose of this organization, accompanied by the payment of annual dues

ARTICLE IV - DUES

Section 1: The annual dues will be \$15.00 due January 1, 2003 and each year thereafter unless amended. Dues are non-

refundable.

Section 2: Members whose dues have not been received by February 1 shall result in forfeiting membership and shall be

dropped from the membership list.

Section 3: Membership may be reinstated upon payment of full amount of dues.

ARTICLE V - NOMINATIONS AND ELECTIONS

Section 1: The elected officers of BASKETWEAVERS GUILD OF OKLAHOMA shall be President, Vice-President, Secretary,

and Treasurer. The elected officers will serve a term of two years.

ICLE VI - DUTIES OF OFFICERS

Section 1: Duties of the President

Preside at all meetings.

Direct and coordinate the program and the activities of the guild meeting according to the by-laws.

Prepare a written agenda for all meetings.

Create and dissolve committees as necessary.

Continued from previous page.

By-laws continued:

Section 2: Duties of the Vice-President

- a. A. Work in close cooperation with the President.
- b. Perform such duties as may be assigned by the President.
- c. Preside in the absence of the President.
- d. Coordinate programs for meetings. (*Proposed change: Add this line.*)

Section 3: Duties of the Secretary

- a. Record all minutes of the guild.
- b. Be responsible for coordinating and distributing a membership roster. (*Proposed change: remove this duty.*)
- c. Be custodian of all records and papers pertaining to the office and pass on all records and papers to the incoming Secretary.

Section 4: Duties of the Treasurer

- a. Receive and deposit all revenues of the guild and pay all authorized bills, keeping an itemized account of all disbursements and receipts in depositories designated by the officers.
- b. Obtain the required signature cards and forms from the designated financial institutions for the officers qualified to sign.
- c. Present a written financial report at each regular meeting.
- D. Be custodian of all records and papers pertaining to the office and pass on all records and papers to the incoming Treasurer.

Section 5: Membership Coordinator – volunteer position, non-<u>elected</u>. (*Proposed Change: add this section*)

- a. Keep accurate records of members
- b. Notify membership of dues paid or not paid
- c. Be responsible for coordinating and distributing a membership roster.

ARTICLE VII – NEWSLETTER

- Section 1: A newsletter will be the primary means of communication among the members.
- Section 2: Newsletter editor is a volunteer position.
- Section 3: Newsletter editor will be responsible for compilation and distribution.
- Section 4: Secretary will provide a current mailing list to newsletter editor. (*Proposed change: change duty from secretary to membership coordinator.*) Membership Coordinator will provide a current mailing list to the newsletter editor.

ARTICLE VIII – MEETINGS

Section 1: The meetings of BASKETWEAVERS GUILD OF OKLAHOMA will be held the second Saturday of the following months: January, March, May, July, September, and November. The meeting will be held at the National Cowboy and Western Heritage Museum in Oklahoma City or a site approved by guild officers.

By-Laws Continued:

The BASKETWEAVERS GUILD OF OKLAHOMA will meet six times per year.

Meetings to be held every other month on a date and place agreed upon by a quorum.

Section 2: Special meetings of the membership may be called by the President at a site designated by the President.

Written notice, by newsletter or special mailing, must be given to all members in such an event.

Section 3: A quorum shall be the members of the guild present and entitled to vote.

ARTICLE IX - DISSOLUTION

Section 1: In the event of dissolution, the elected officers at the time of dissolution shall, after paying or making provision

for the payment of debts, dispose of all remaining assets to a legally constituted, non-profit organization.

Section 2: None of the property or any other asset of the guild nor any portion thereof shall be distributed to or for the

use of any member of BASKETWEAVERS GUILD OF OKLAHOMA.

ARTICLE X - AMENDMENTS

Section 1: The by-laws may be amended at any general membership meeting by a two-thirds vote of those present and

voting providing the proposed amendment(s) has been submitted in writing and presented to the members

one month prior to the vote.

Section 2: By-laws will be reviewed yearly or as needed for the operation of the guild.

A Day in the Life of a Moose

I'm always amazed what I will find when I type in something on Google to do a search. I wanted to let you know about the willow now that winter is at our doorsteps. I wondered if I could find out anything about taking care of willow to get it ready for winter. I typed in how to bed down willow for the winter. I found an article about moose in Alaska and how they figure out what animals do with their time. The following actually refers to moose eating willow:

""It's basically a day in the life of a moose," she said.

After an hour of foraging, the moose and her calf bed down and Stacy logs them in as "resting." It's a cycle for the moose during winter, feed and rest, feed and rest. The resting is largely digesting, as bacteria and protozoa in their digestive tract break down the dry willow twigs and horsetail stems, providing a fraction of energy these moose need to get through the winter. The remainder is supplied by fat and protein reserves the moose put on last summer and fall."

So my friends, if you get hungeyr and want to eat willow this winter, just know that it does not give much energy even if you can swallow it.

10 Reasons to Grow Basket Willow

- 1. **Willows are carbon sequesters.** They take in carbon and use it in their leaves and store it in their roots. When burned, it gives off less carbon than it stores so it is good as a break between a garden and the road.
- 2. **Willows help to filter toxic waste and purify the soil.** Willow is grown in areas where the soil is polluted with toxic waste such as gasoline. This willow can not be used for medicinal purposes.
- **3. Basket willows are fast growing.** These willows have been grown for centuries. When they are green the stems are flexible and can be bent at a 90 degree angle without breaking. They grow 4 to 8 feet without branching.
- **4. Willows are a versatile resource.** Making baskets will get more plastic our of your life. Left to grow for 2 or 3 years it will reach 10 to 12 feet tall. After cutting new poles will grow in the same plot. Once established, they don't need much fertilizer or water. (This may not be true in Oklahoma.) In Europe farmers are growing willow for a few years then after harvesting use the poles for fence posts or fuel logs. The logs provide renewable fuel for electrical generation reducing the reliance on nonrenewable resources.
- **5. Willow bark can be harvested for herbal medicine.** Willow bark is anti-inflammatory, takes away fever, reduces pain and reduces flu and cold symptoms. The bark is pealed and the inner bark is scraped with a knife.
- **6. Willow branches can be used as a natural rooting hormone.** When rooting plants in a jar of water, put one inch pieces of the willow branch in the jar and roots will develop faster.
- 7. Willows are super easy to grow. You can grow a living trellis by planting willow branches and weaving them. Willow will grow just by placing a stick in the ground. If you cut all the sprouts from one of these sticks, it will grow a tree.
- **8. Willow makes an attractive organic screen.** Grow willow to make a barrier between your yard patio and the neighbors or alley way. It will also make a wind break and provide shelter for birds and beneficial insects.
- **9. Willows provide early pollen for bees.** When willows are allowed to grow and the pussy flower is allow to open it will provide pollen earlier in spring before flowers have had time to grow and bloom. Planted next to an orchard, willow will encourage more bees to come to the orchard.
- **10.** There are enough varieties of basket willow to offer color and interest in your garden in all seasons. Many varieties offer bright red, orange, yellow and purple stems in winter. In summer, the leaves offer different shapes and sizes for contract to other garden plants.


A word of caution:


Do not plant willow close to building foundations and septic drainage fields. Willow will seek out water.
