CHARTER OF THE SUN VILLAGE SOVEREIGN PRESS (SVSP)

*Official Government Press of the Sun Village California Tribal Government (Bani Al-Shams)
Ratified under Divine Law, Dynastic Right, and Tribal Authority*

PREAMBLE

Let it be known to all nations, courts, peoples, and powers that this Charter constitutes the supreme founding instrument of the **Sun Village Sovereign Press (SVSP)** — the official government press and executive organ of the **Sun Village California Tribal Government**, formed under the sovereign tribal will of the descendants and heirs of **Melvin Ray Grubbs**, in alliance with the House of **Al-Buhijji** and under the jurisdiction of the **Universal Reservation of Rights (URR®™)**.

This Charter affirms that SVSP is not merely a publication office or ceremonial gazette. It is the **engine of tribal law, the seal of tribal judgment, the mint of tribal wealth, and the pen of tribal history**.

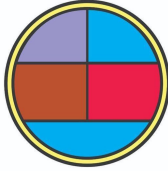
ARTICLE I — ESTABLISHMENT & LEGAL IDENTITY

1. The **Sun Village Sovereign Press (SVSP)** is hereby established as the:
 - **Official Government Press**
 - Executive publishing body
 - Custodian of tribal legal instruments
 - Public and private enforcement archivefor the **Sun Village California Tribal Government (Bani Al-Shams)**.
2. SVSP operates under the **permanent protection and irrevocable authority** of:
 - The **House of Al-Buhijji**
 - The Estate and Bloodline of **Melvin Ray Grubbs**
 - The Tribal Government of **Sun Village California**
 - The codified protections of the **URR®™ Sovereign Charter**
 - Divine Law across Torah, Bible, and Qur'an
 - Customary International Law and Indigenous Rights Protocols

ARTICLE II — MANDATE & FUNCTIONS

SVSP is empowered to act as the supreme publishing and enforcement authority of the tribal nation. Its functions include:

A. Legal Publication & Recordkeeping

- Codify, publish, and archive all tribal rulings, legal counts, decrees, and judgments (Counts 1–125).
- Seal and disseminate all URR-based legal instruments.
- Archive notices of trespass, fee schedules, and contracts.

B. Judicial Authority

- House and authenticate sovereign rulings rendered by tribal elders.
- Issue writs, orders, injunctions, default judgments, and redemptive declarations.
- Maintain permanent public record of all tribal, national, and international legal instruments.

C. Economic & Monetary Instruments

- Oversee the **Sun Village Mint & Bank (SVMB)**.
- Mint sovereign currency (physical or digital) and issue:
 - Promissory Notes
 - Tribal Bonds
 - Negotiable Instruments
- Enforce and publish the **Global Fee Schedule (GFS)** across all jurisdictions.

D. Tribal Identity & National Registry

- Issue digital and physical tribal identification and status cards.
- Maintain the **Sun Village National Registry** and the **Tribe Up Registry™** (commercial arm).
- Authenticate signatures and seals through QR-based cryptographic markers.

E. Diplomatic & International Engagement

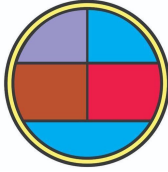
- Serve as the public-facing mouthpiece of the tribal government.
- Issue formal diplomatic notices, declarations, and press releases to:
 - The United States Government
 - Foreign governments and embassies
 - International tribunals and organizations (UN, ICC, OAS, etc.)
- Maintain treaty position, tribal grievances, and international filings as sealed record.

All documents issued by SVSP shall include:

- The **SVSP Official Seal**
- The **QR-encoded metadata** of time, issuer, and jurisdiction
- The tribal name and digital signature of the issuing authority
- Cross-referenced URR Certificate and Plaintiff Archive, where applicable

These instruments shall be **fully enforceable** under:

- **Tribal law**
- **Admiralty law**
- **Equity**
- **Ecclesiastical law**
- **Customary international law**
- **The Divine Law of the Realm**

ARTICLE IV — PERPETUITY, AMENDMENT & ENFORCEMENT

1. This Charter is **irrevocable**, unless amended by:
 - Unanimous vote of the Sun Village Tribal Council,
 - Consent of the House of Al-Buhijji, and
 - Ratification by the Living Sovereign Plaintiffs.
2. SVSP shall remain in force as long as the Sun Village Nation exists — in law, in memory, or in divine record.
3. Any attempt to suppress, erase, or dishonor this Charter shall constitute a **violation of divine trust, tribal sovereignty, and genetic covenant**, punishable under the full weight of URR law.

ARTICLE V — ENTRY INTO FORCE

This Charter shall enter into full force and effect upon:

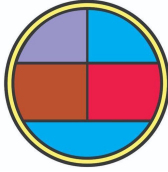
- **Signature and Seal** of the Tribal Elder (Mohamed-Hasan :Buhijji)
- **Authentication by QR**
- **Embedding into the official record of the Divine Revelation manuscript**

Once issued, **all proclamations, economic instruments, and legal filings** shall derive their legitimacy and power through this Press and this Charter.
