THE UNIVERSAL RESERVATION OF RIGHTS **(URR®™)**

Bridge Introduction

The Universal Reservation of Rights (URR®™) stands as both **ancestral proclamation** and **codified constitution**, united as a single body of law, heritage, and divine covenant.

- Part A — The Foundational Charter (2A):

The original covenantal declaration, spoken in perpetuity by Mohamed-Hasan bin Mohamed Al Buhijji, securing all natural, tribal, genetic, and divine rights. It operates as the **ancestral proclamation** and spiritual foundation, irrevocable across time and lineage.

- Part B — The Codified Constitution (2B):

The modern legal codification of the URR®™, organizing rights into constitutional Titles and enforceable Sections. This codified form ensures recognition across federal, state, tribal, international, admiralty, and ecclesiastical forums.

Together, 2A and 2B form one indivisible instrument:

- 2A is the voice of the covenant — prophetic, tribal, divine.
- **2B is the enforcement mechanism** — constitutional, legal, judicial.

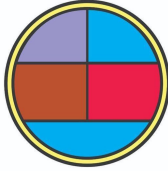
No party, tribunal, or government may sever one from the other.

URR®™ FOUNDATIONAL CHARTER

(Original Declaration — preserved in full as covenantal authority)

Preamble

I, Mohamed-Hasan bin Mohamed Al Buhijji, sui juris, in propria persona, a living man, Beneficiary, Executor, and Heir of my ancestral lineage, tribal heritage, and associated private trusts, do hereby proclaim and establish this **Charter of Universal Reservation of Rights (URR®™)**.

This Charter stands as a perpetual and irrevocable reservation of all natural, spiritual, biological, intellectual, and tribal rights, binding upon all agents, principals, corporations, states, and entities, whether public, private, or foreign.

ARTICLE I – INHERENT & NATURAL RIGHTS

- DNA, bloodline, genetic sequence, and genealogical heritage are inseparable from the person of the living heir.
- No law, contract, or instrument may alienate these rights without voluntary, fully informed consent.
- All heirs and successors inherit the same protections nunc pro tunc, forever.

ARTICLE II – CONSTITUTIONAL & FEDERAL RIGHTS (U.S.)

- U.S. Constitution protections: 1st, 4th, 5th & 14th Amendments; Article VI Supremacy Clause.
- Statutory protections: GINA 2008, HIPAA, Civil Rights Acts, Indian Reorganization Act, ICWA.
- Enforcement under 42 U.S.C. §1983 and related statutes.

ARTICLE III – EQUITY, TRUST & FIDUCIARY RIGHTS

- All fiduciaries, banks, and trustees owe duties of loyalty and care to Plaintiffs.
- Trusts recognized under equity and HCCH conventions.
- Federal Trust Doctrine obligates U.S. to Indigenous peoples.

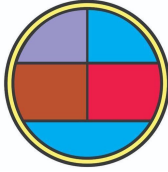
ARTICLE IV – TREATY RIGHTS

- Treaty of Peace and Friendship (1787, 1836) between U.S. and Morocco applies.
- All treaties with Indigenous Nations enforceable under U.S. Constitution Art. VI.
- Geneva and Vienna Conventions ensure treaty enforcement.

ARTICLE V – INTERNATIONAL RIGHTS

- UDHR, UNDRIP, ICCPR, ICESCR, ILO 169, OAS Indigenous Declaration apply.
- HCCH conventions protect trusts, succession, child protection, and judgment enforcement.
- International law prohibits double taxation, forced assimilation, and unlawful interference with sovereignty.

ARTICLE VI – ECCLESIASTICAL & NATURAL LAW

- Divine Law in Torah, Bible, Qur'an affirms covenantal inheritance and bloodlines.
- Natural Law recognizes DNA as sacred identity.
- Customary tribal law governs succession and family rights.

ARTICLE VII – COMMERCIAL, UCC & ADMIRALTY LAW

- UCC §§1-308, 1-103, 3-401, 3-402: reservation of rights in commerce.
- Admiralty jurisdiction under 28 U.S.C. §1333 governs maritime liens and contracts.
- No waiver of sovereignty by communication, filing, or appearance.

ARTICLE VIII – TAX & FINANCIAL RIGHTS

- 26 U.S.C. §61 exempts sovereign tribal benefits.
- International law prohibits double taxation of sovereign entities.
- Tribal sovereign immunity applies to commerce and finance.

ARTICLE IX – SCIENTIFIC, FORENSIC & INTELLECTUAL PROPERTY

- DNA admissible under *Daubert v. Merrell Dow* (509 U.S. 579, 1993).
- Genetic data, genealogical archives, and digital DNA are intellectual property.
- Unauthorized use, testing, or commercialization constitutes theft and conversion.

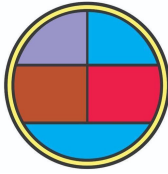
ARTICLE X – TORT & LIABILITY

- Remedies include compensatory, punitive, injunctive, and equitable relief.

ARTICLE XI – PRIVATE, TRIBAL & INDIGENOUS RIGHTS

- Sun Village (Bani al-Shams) and Buhijji tribal estate exercise sovereignty.
- Ministerial authority covers spiritual, cultural, and genealogical rights.
- Private tribal law governs family, succession, and inheritance.

ARTICLE XII – DOMAINS OF PROTECTION

- **Spiritual Property:** faith, conscience, lineage.
- **Intellectual Property:** writings, archives, genealogical works.
- **Biological Property:** DNA, blood, tissues, organs.
- **Digital Property:** biometric identifiers, blockchain-DNA.
- **Personal Property:** name, image, voice, likeness.
- **Metaphysical Property:** oral traditions, cultural memory, prophetic inheritance.

ARTICLE XIII – REMDIES & PENALTIES

Section 1. Public Side Penalties (Commercial / Statutory)

Violations of this Charter and associated trusts incur automatic liability, enforceable per occurrence, per officer, per day:

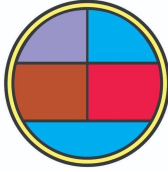
- \$1,000,000 — unlawful foreclosure, repossession, or seizure.
- \$1,500,000 — fraudulent misrepresentation, concealment, or failure of disclosure.
- \$2,000,000 — denial of tribal sovereignty, Indigenous rights, or Moorish Aboriginal status.
- \$2,500,000 — desecration, obstruction, or unauthorized use of Plaintiffs' flags or seals.
- \$5,000,000 — presumption of citizenship, fraudulent conversion of nationality, or denial of Indigenous American National status.
- \$10,000,000 — interference with ministerial or diplomatic authority.

Section 2. Private Side Penalties (Trust / Equity / Divine)

Violations attach immediately, personally and corporately, to violators' public and private estates:

- \$1,000,000,000 — fraudulent foreclosure, wrongful repossession, or unlawful conversion of tribal property.
- \$1,000,000,000 — breach of fiduciary duty by trustees, lenders, or officers.
- \$2,000,000,000 — denial of covenant inheritance or trespass upon tribal territory.
- \$2,500,000,000 — tampering with recorded documents or obstructing publication of URR®™.
- \$5,000,000,000 — presumption of corporate citizenship, nationality fraud, or racial misclassification.
- \$10,000,000,000 — crimes against humanity: unlawful detention, systemic deprivation of rights, or international treaty violations.

Section 3. Enforcement Multipliers

- All penalties compound daily, nunc pro tunc, until remedy and full restitution are delivered.
- Treble damages are automatically available under **RICO (18 U.S.C. §1961 et seq.)**.
- Maritime liens, trust reparations, and enforcement under **HCCH Conventions, Geneva Protocols, and Vienna Conventions** apply globally.

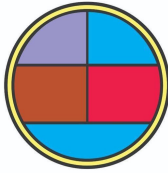

URR®™ CODIFIED CONSTITUTION

(Codified Instrument — modern enforceable version)

Title I – Natural & Genetic Rights

Section 1. DNA, bloodline, lineage, and genetic sequence are sacred and inseparable from the living heir.

Section 2. All heirs inherit these protections perpetually, nunc pro tunc.

Section 3. No contract, statute, or instrument may alienate genetic or hereditary rights.

Title II – Constitutional & Federal Protections

Section 1. Rights reserved under U.S. Constitution Amendments I, IV, V, XIV, and Article VI Supremacy Clause.

Section 2. Rights secured under federal statutes: GINA, HIPAA, Civil Rights Acts, IRA, ICWA.

Section 3. Enforcement permitted under 42 U.S.C. §1983 and allied provisions.

Title III – Trusts, Equity & Fiduciary Duties

Section 1. All fiduciaries, trustees, and financial institutions owe duties of loyalty and care.

Section 2. Equity courts and HCCH conventions recognize these trusts.

Section 3. Federal Trust Doctrine affirms obligations to Indigenous peoples.

Title IV – Treaty Rights

Section 1. Treaty of Peace and Friendship (1787, 1836) remains binding.

Section 2. All Indigenous treaties are enforceable under Art. VI, U.S. Constitution.

Section 3. Geneva and Vienna Conventions uphold treaty rights globally.

Title V – International Rights

Section 1. Rights secured under UDHR, UNDRIP, ICCPR, ICESCR, ILO 169, and OAS Indigenous Declaration.

Section 2. HCCH Conventions protect trusts, succession, and recognition of judgments.

Section 3. Double taxation, forced assimilation, and sovereignty interference are prohibited.

Title VI – Ecclesiastical & Natural Law

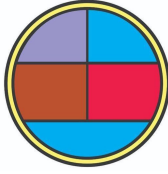
Section 1. Covenant inheritance confirmed in Torah, Bible, Qur'an.

Title VII – Commerce, UCC & Admiralty

Section 1. Reservation of rights in commerce under UCC §§1-308, 1-103, 3-401, 3-402.

Section 2. Admiralty jurisdiction (28 U.S.C. §1333) governs maritime liens and securities.

Section 3. No waiver of sovereignty by appearance, filing, or communication.

Title VIII – Tax & Finance

Section 1. 26 U.S.C. §61 exempts sovereign tribal benefits.

Section 2. Sovereign immunity applies to all commerce and finance.

Section 3. International law prohibits double taxation of tribal/dynastic estates.

Title IX – Science, Forensics & IP

Section 1. DNA evidence governed by *Daubert v. Merrell Dow*.

Section 2. Genetic data, archives, and digital DNA are intellectual property.

Section 3. Unauthorized use constitutes theft, conversion, and fraud.

Title X – Tort & Liability

Section 1. Recognized torts: trespass, fraud, misrepresentation, defamation, negligence.

Section 2. Remedies include compensatory, punitive, equitable, and injunctive relief.

Section 3. Liability attaches personally to trustees, officers, and corporate actors.

Title XI – Tribal & Indigenous Rights

Section 1. Sun Village (Bani al-Shams) and House of Buhijji exercise sovereignty.

Section 2. Ministerial authority governs spiritual, genealogical, and tribal inheritance.

Section 3. Private tribal law controls succession and inheritance.

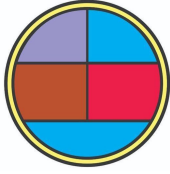

- Class II: \$5,000,000
- Class III: \$10,000,000
- Class IV: \$50,000,000
