POSTAGE STAMP ACT

Charter No. HB-PSA/2025

Ratified by Royal Authority under the Sovereign Estate of House Buhijji
Decreed by His Imperial and Royal Highness, Lord Minister & Grand Chancellor Sheikh MohamedHasan: Buhijji

Effective: Anno Domini 2025 / 1447 Hijri / 5786 Hebrew / Year 1 of the Unified Sovereign Postal Registry

ARTICLE I — SOVEREIGN MANDATE

1. Establishment of Postal Sovereignty:

By virtue of blood right (Per Divinum Jus Sanguinis), hereditary dominion, and recognized tribal-state continuity, the issuance of postage stamps by House Buhijji is hereby formalized as a sovereign act under international law, tribal law, divine right, and diplomatic custom.

2. Foundational Authority:

This Act operates pursuant to:

- The Universal Postal Union (UPU) Convention (Berne, 1874 present)
- Tribal Customary Law recognized under UNDRIP (United Nations Declaration on the Rights of Indigenous Peoples)
- Dynastic Moorish and Arab-Islamic sovereign customs and treaty protections
- House Buhijji's own Postal Charter (ratified 2019)

ARTICLE II — DEFINITION OF STAMP

1. Sovereign Postage Stamp Defined:

A postage stamp is defined herein as a printed, digital, or embossed instrument bearing the seal, emblem, motto, or cipher of House Buhijji, designated as "POSTAGE PAID", denoting that mailing rights and handling fees are settled under sovereign decree.

2. Legal Function:

Stamps serve as:

- Evidence of payment for postal services within the sovereign jurisdiction of House Buhijji
- A declaration of protection under international mailing covenants
- A symbol of diplomatic immunity, tribal jurisdiction, and sovereign dispatch

3. Currency Recognition:

Stamps shall be treated as numismatic class items, representing sovereign postal credit, akin to promissory instruments within the internal economic system governed by the Currency Charter, and Precious Metals Act.

<u>ARTICLE III — ANNUAL ISSUANCE FRAMEWORK</u>

1. One Stamp Per Year Rule:

House Buhijji shall issue one official postage stamp per calendar year, effective January 1st each year, valid until December 31st of that same year, unless extended by royal decree.

2. Designation:

Each stamp must bear:

- The motto: "PER DIVINUM JUS SANGUNIS"
- Visual iconography approved by the Grand Chancellor
- Distinctive date of issue and official registry number
- 3. Forms & Media:

Stamps may exist in:

- Printed adhesive format
- Digitally embedded format (QR-coded, blockchain notarized)

• Embossed physical seals (for envelopes or court filings)

<u>ARTICLE IV — REGISTRY AND ARCHIVAL</u>

1. Stamp Registry:

All stamps are to be recorded in the Sovereign Postal Stamp Ledger maintained by the Chancellery and Strategic Vault.

2. Archival Protocol:

At least 12 copies per annual stamp must be archived:

- 4 retained in sovereign vaults
- 4 reserved for numismatic issue or auction (in future)
- 4 used for ceremonial, legal, or treaty-bound mail

<u>ARTICLE V — POSTAL IMMUNITY & PROTECTION</u>

1. Postal Immunity Granted:

Any item bearing a valid House Buhijji stamp shall:

- Be immune from inspection by foreign jurisdictions
- Be treated as diplomatic dispatch under international custom
- Fall under protection of UPU Articles 1–9 (where applicable)
- 2. Violation Clause:

Any entity or individual interfering with, destroying, detaining, or altering House Buhijji-stamped mail commits an act of postal aggression and shall be subject to:

- Legal damages under the Postal Charter
- Public-side and private-side claims under the URR®TM Global Fee Schedule

ARTICLE VI — STAMP DESIGN APPROVAL

1. Design Authority:

All official stamp designs must be approved by the:

- Grand Chancellor of House Buhijji
- Seal Authority and Chancellery Artistic Council (when constituted)
- 2. Visual Themes (2026–2036):

Themes will follow the "Dingir Cycle":

- 10 years of cosmic, divine, and bloodline iconography
- Red backgrounds with white/ivory glyphs
- Uniform inscription: POSTAGE PAID

ARTICLE VII — VIOLATIONS & COUNTERFEITING

1. Forgery Prohibition:

Unauthorized duplication, sale, or issuance of House Buhijji stamps is deemed:

- A sovereign crime
- A violation of dynastic and postal laws
- 2. Enforcement:

Legal actions may include:

- Issuance of cease-and-desist orders
- Registration of violation via Blockchain Postal Ledger
- Sovereign lien or forfeiture under global commercial law
