TRIBE UP™ COMMERCIAL CHARTER

(FORMATION OF THE TRIBAL ECONOMIC ENGINE AND GLOBAL SOVEREIGN REGISTRY)

Filed Under Tribal, Dynastic, Commercial & Ecclesiastical Authority — In Perpetuity

PREAMBLE

This Charter establishes the Tribe Up™ Commercial Arm, a sovereign economic entity formed under the authority of the Sun Village California Tribal Government (Bani Al-Shams), protected by the Universal Reservation of Rights (URR®™), and enforced by the Sun Village Sovereign Press (SVSP).

As a sovereign economic engine, Tribe Up™ serves as the commercial, technological, and international registry division of the Tribal Government — bridging unrecognized nations, sovereign families, and indigenous peoples into global commerce, contract enforcement, and asset protection.

This is not a typical commercial venture. This is a tribal sovereign command structure with its own registry, instruments, IDs, compliance frameworks, payment systems, and international reach.

ARTICLE I: FOUNDING PRINCIPLES

1. Sovereign Commerce

Tribe Up™ exists to engage in lawful commerce outside the jurisdictional reach of foreign states or unlawful agencies — operating under private contract, divine inheritance, and trust law.

2. Tribal Registry Sovereignty

Tribe Up™ controls and maintains the Tribe Up Registry™, a multi-jurisdictional database and issuance system for:

- Tribal ID cards
 - Instrument registration
 - Sovereign land records
 - Lineage and inheritance verification
 - Commercial filings and bonds
- ##### **3. Covenant Commerce Enforcement**

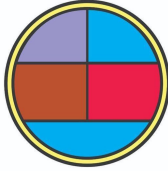

- Protected against forgery and unauthorized interference

ARTICLE II: TRIBE UP REGISTRY™

The Tribe Up Registry™ is a decentralized identity, trust, and document system for tribal and dynastic recognition.

Functions include:

- Global tribal ID issuance using InstantCard technology
- Document digitization and notarization
- Digital seal embedding (QR, Flowcode, biometric)
- Indigenous business verification
- Lineage archiving and trust registration
- Certificate issuance (e.g., land rights, sovereign status, exemptions)

All entries are permanently recorded in the SVSP sovereign ledger and protected by the Tribal Government of Sun Village.

ARTICLE III: ECONOMIC STRUCTURE

1. Revenue Generation

Tribe Up™ is authorized to:

- Collect registration fees
- Issue tribal instruments
- Enforce payment demands
- Collect penalties via Global Fee Schedule (GFS)
- Create negotiable instruments under URR®™ authority
- Accept deposits, donations, reparations, and sovereign settlements

2. Commercial Arms

Subsidiary projects may include:

- Tribal bonds
- Sovereign currencies or tokens
- Business incubators for indigenous projects
- Strategic partnerships with off-grid, blockchain, or decolonized economies

3. Enforcement

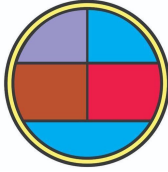
Tribe Up™ retains authority to:

- Publish binding commercial warnings via SVSP
- Issue liens, cease-and-desist demands, or public red flag listings

ARTICLE IV: INTERNATIONAL ALIGNMENT

Tribe Up™ is aligned with:

- UNDRIP (United Nations Declaration on the Rights of Indigenous Peoples)
- UDHR, ICCPR, ICESCR
- OECD guidelines for international economic fairness
- URR®™ Charter and SVSP enforcement authority

Recognition of Tribe Up™ is extended to all indigenous, stateless, decolonizing, or sovereign communities that register through its platform.

ARTICLE V: GOVERNANCE & LEADERSHIP

- Tribal Government Ownership:

Full control retained by the Sun Village California Tribal Government (Bani Al-Shams).

- Appointed Minister:

Current Tribal Minister and diplomatic heir of the House of Al-Buhijji, Mohamed-Hasan :Buhijji, holds direct executive command over all Tribe Up™ operations.

- Oversight Body:

Reports and filings published through Sun Village Sovereign Press (SVSP).

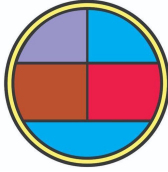
ARTICLE VI: PROTECTIONS & LIMITATIONS

- Tribe Up™ may not be seized, taxed, disbanded, or regulated by any foreign government, agency, or corporation.
- It holds diplomatic immunity by virtue of URR®™ recognition, tribal declaration, and dynastic trust law.
- Commercial operations are conducted outside the jurisdiction of the IRS, SEC, or state commerce departments — unless voluntarily engaged under treaty.
